On the heels of floods, county deals with **Hurricane Beryl**

While still recovering from the effects of the late April storms, Trinity County residents suffered high winds and rain after Hurricane Beryl made rainfall.

On July 8, the day the county was hit, Trinity Fire Department responded to 23 calls for service.

Fire Chief Keith Johnson said the majority of calls were for trees blocking roadways and on electrical lines, keeping firefighters busy keeping roads open.

Additionally, firefighters were called to a home in Timber Bay after a tree fell on a house, trapping the resident.

Johnson said that firefighters, along with a retired firefighter, were able to remove the victim with no injuries.

Firefighters also responded to a two-vehicle accident on Pinecrest Road; however no injuries were reported. Groveton, Pennington, Apple Springs and Friday volunteer de-

partments also were kept busy.

The Groveton Fire Department opened its doors to provide cooling and charging for city residents, since an anonymous donor provided a generator.

Without a doubt, though, the loss of power cost many dearly.

Next steps taken for water service

TRINITY — The city of Trinity will now seek contractors to begin work on improvements to the city's water system.

City Manager Tim King said that at the Thursday City Council meeting, the council approved seeking bids for work to replace a water storage tank at the city well site, as well as building a new water

tower and installing backup generators.

The grant, administered by Goodwin Lasiter Strong, is for almost \$4 million, King said.

In other business, the council:

•approved bids for the purchase of two Ford ¾-ton pickup trucks for the Water and Sewer Department;

• accepted the annual audit performed by Davis, Heinemann and Co., which was given an unmodified opinion but suggested raising

• approved an amendment to an ordinance that established the position of Police Chief. King said the original ordinance, passed in the 1980s, abolished the city marshal position and created a police chief; however, it stated the chief of police will answer to city manager, which was changed to answering to the mayor; and

• amended the ordinance on mobile homes and HUD-code manufactured homes areas to require the parks to have two entrances on each end or a turnaround large enough to accommodate a fire truck.

Insurance tips after **Hurricane Beryl**

If you experienced damage from Hurricane Beryl, contact your insurance company to start a claim. If you still have questions, the Texas Department of Insurance has specialists ready to help. Call the TDI Help Line at 800-252-3439.

"You need to get your claim started as soon as possible," said Insurance Commissioner Cassie Brown. "We can help you if you run into an issue contacting your insurance company or just don't understand what you're hearing from them."

Filing an insurance claim

Contact your insurance company or agent as soon as possible. Keep a list of everyone you talk to. Be ready to describe the dam-

Make a list of damaged property. Take pictures or video. Don't throw away damaged items until you talk to your insurance company or adjuster.

property from further damage. Cover broken windows and holes to keep out rain and prevent vandalism or theft. Ask about additional living expenses if you can't live in your home due to the damage or power outages. Your insurance may pay some

Save proof you paid the deductible on your claim. State law makes it illegal for contractors or roofers to offer to waive a deductible or to

promise a rebate for the amount.

In addition to filing your insurance claim, be sure to tell the Texas Division of Emergency Management about the damage. This will help Texas to receive as many recovery funds as possible. Report damage at iSTAT Damage Surveys.

Flood damage

Most home and renters' policies don't cover flood damage. Check your policy or call your agent if you aren't sure about your coverage.

If you have flood insurance, call your agent or company as soon as possible. Federal flood policies require you to file a claim and document your losses within 60 days.

Your personal auto policy may cover flood damage if you have comprehensive coverage. If your car was flooded or damaged, call your insurance company or agent as soon as possible.

SNAP, WIC replacement benefits approved

AUSTIN — Acting Governor Dan Patrick last week announced that the Texas Health and Human Services Commission received federal approval allowing recipients of the Supplemental Nutrition Assistance Program to apply for replacement benefits for food lost or destroyed from Hurricane Beryl.

The Special Supplemental Nutrition Program for Women, Infants and Children is also replacing food and formula benefits lost during the hurricane.

"The recent storms have impacted many families across the state." By providing these replacement food benefits, we will offer relief to those who need our help the most," Patrick said. "As we continue our recovery process, it is vital that SNAP and WIC recipients have access to these benefits to continue to feed their families.

"Three million homes and businesses lost power with Hurricane Beryl's impact, which caused people's food to go bad, and many were forced to discard spoiled food because they had to evacuate. This loss was especially painful for families who rely on SNAP benefits," said HHSC Deputy Executive Commissioner of Access and Eligibility Services Molly Regan. "Replacement food benefits will relieve some of the challenges many Texans are currently facing."

To replace food lost or destroyed by the storms that began July 8, SNAP recipients must apply for replacement benefits that will be placed on their Lone Star Cards within two business days once benefits are approved.

SNAP recipients in 121 counties listed in Acting Governor Patrick's disaster declarations must apply for replacement benefits by Aug. 8. Affected counties are listed below. Beginning July 11, recipients can apply by dialing 2-1-1 and selecting Option 8.

Recipients can also download Form H1855 (Affidavit for Nonreceipt or Destroyed SNAP Benefits). Completed forms should be mailed to Texas Health and Human Services Commission, P.O. Box 149027, Austin, TX, 78714-9027, or faxed to 877-447-2839.

Recipients who live in counties other than those listed below can apply for replacement benefits in person within 10 days of discovering their food was lost or destroyed due to the recent storms. Individuals in those counties must go to a local benefits office to request replacement food benefits.

HHSC is also providing crisis counseling for Texans affected by this disaster through local mental health authorities. To locate a local mental health authority, visit the Where Can I Find Services

Additionally, the WIC program, administered by HHSC, is replacing food and formula benefits lost during Hurricane Beryl through July 31, 2024. Families can visit TexasWIC.org or call 800-942-3678 from 8 a.m. to 5 p.m., Monday through Friday, and select Option 3 to speak with an operator who will help find an open WIC location. WIC participants will need to go to the WIC office in order to replace food benefits. WIC also offers 24/7 breastfeeding assistance through its lactation support hotline: 855-550-6667.

"Many WIC recipients have been impacted by Hurricane Beryl," said Rob Ries, HHSC Deputy Executive Commissioner for Family Health Services. "Texas WIC and local WIC offices are here to help meet their food, formula and breastfeeding needs as quickly

Any Texan in need can apply for benefits, including SNAP and Medicaid, at Your Texas Benefits.com or can use the Your Texas Benefits mobile app to manage their benefits. To find local resources, such as food or shelter, dial 2-1-1 and select Option 1.

Unemployment assistance deadline extended

AUSTIN — The Texas Workforce Commission has received federal approval to extend the deadline for Disaster Unemployment Assistance applications relating to the severe weather events that impacted Texas counties between April and June.

Individuals who may be eligible for DUA now have until Aug. 15 to apply for assistance under Federal Emergency Management Agency Disaster Number 4781-DR. This disaster declaration does not include the recent impacts of Hurricane Beryl.

Individuals whose employment or self-employment was impacted by the severe storms, straight-line winds, tornadoes, and flooding that began on April 26 and ended June 5 must now submit their applications by Aug. 15. The amended declaration includes Anderson, Austin, Bell, Calhoun, Collin, Cooke, Coryell, Ellis, Dallas, Denton, Eastland, Falls, Guadalupe, Hardin, Harris, Henderson, Hockley, Jasper, Jones, Kaufman, Lamar, Leon, Liberty, Montague, Montgomery, Nacogdoches, Navarro, Newton, Panola, Polk, Rusk, Sabine, San Jacinto, Smith, Terrell, Trinity, Tyler, Van Zandt, Walker, and Waller

Workers and self-employed individuals in the designated counties who have been unable to work due to damage sustained from the severe weather may be eligible for DUA benefits. Individuals can apply for benefits online through Unemployment Benefit Services

Flood insurance a valuable resource for Texans

AUSTIN — Your house has never flooded. You have a homeowner's insurance policy. You're thinking: "I'm covered."

Maybe not.

Many Texas residents may believe they don't need to buy flood insurance. They don't live in a high-risk flood zone. But flooding can happen anywhere, often to the surprise of residents who thought they were covered for disaster. When flooding happens, the damage is not covered by most One inch of floodwater can cause more than \$25,000 of damage in a home.

Before a community is eligible for federal disaster assistance, it must be designated a federal disaster area. This happens in less than 50 percent of flooding incidents. The main form of federal assistance after a federally declared disaster is a loan that must be repaid with interest.

Property owners can protect themselves from financial losses by having a flood insurance policy through the National Flood Insurance Program. Flood insurance

coverage is available regardless of federal disaster declarations. Insurance for contents is also available to homeowners and renters. There is a 30-day waiting period before new policies go into effect, an important consideration during hurricane season.

Statewide, 653,309 policyholders in Texas hold \$197 billion in coverage but many people have no flood coverage. Residents can purchase a flood insurance policy if their community participates in the NFIP, no matter their flood risk. Even in areas that are not flood-prone, insurance is a good

idea. People outside of high-risk areas file more than 25 percent of NFIP claims.

Coverage is available for residential and commercial buildings and contents:

•Up to \$250,000 in building coverage and up to \$100,000 in contents coverage for single-tofour family residential structures.

•Up to \$500,000 in building coverage and up to \$100,000 in contents coverage for five-ormore family residential structures.

•Up to \$500,000 in building coverage and up to \$500,000 in contents coverage for businesses.

How to buy:

Contact your insurance company or agent. If you need help finding a provider, go to FloodSmart. gov/flood-insurance-provider or call the NFIP at 877-336-2627. In addition to the NFIP, flood insurance is also available from some private insurance providers. For an agent referral, call 800-427-4661 or visit FloodSmart.gov.

More than 2 million Texans lost power when Hurricane Beryl hit the Texas coast, and Gov. Greg Abbott wants to know why. The Austin American-Statesman reported Abbott has ordered the Public Utility Commission to conduct an immediate study into why the Houston area has again been hit by widespread power outages.

"I want to find out, was there a structural flaw with regard to the electrical delivery system?" Abbott said. "Was that the cause of it? If so, what needs to be done to shore up, or was this a personnel issue of not having enough power personnel in all the right locations to get power back up?"

CenterPoint Energy is the primary electricity transmission company serving the Houston area. Its CEO, Jason Ryan, appeared before the PUC last week and was questioned about the outages.

"To our customers that not only have power out but have significant property damage from the trees we talked about coming up from the roots, our hearts go out to you and our hearts go out to our community," Ryan said.

As of Sunday morning, Center-Point's website indicated 461,247 customers were still without power, nearly a week after Beryl made land-

To date, 67 counties have been approved for federal disaster assistance, while other counties may be included as damage assessments are concluded. Those counties in the initial list are: Anderson, Angelina, Aransas, Austin, Bowie, Brazoria,

Forest service assesses tree damage after Beryl

More than 400,000 acres of rural forestland was potentially affected by Hurricane Beryl, according to the Texas A&M Forest Service, which has closed W.G. Jones State Forest in Conroe until a damage assessment can be undertaken. In addition, hurricane force winds potentially affected as much as half of Houston's urbanized area tree coverage, the service reported.

"We used a combination of onthe-ground observation, remote sensing and Forest Inventory and Analysis data to conduct a tree damage assessment for rural forests in

East Texas and the Houston metro area," said Aaron Stottlemyer, Texas A&M Forest Service Forest Analytics Department Head.

Old pipes lead to billions in lost gallons of water

The state's most populous cities lost approximately 88 billion gallons of water last year because of aging pipes and extreme heat, The Texas Tribune reported. Unsurprisingly, the city that lost the most water, according to self-reported audits, was Houston, the state's largest, at 31.8 billion gallons. Coming in second was San Antonio, which reported losing 19.5 billion gallons.

The main factors for the losses are leaks and water main breaks, problems more often associated with smaller towns with fewer resources to maintain infrastructure, The Tribune reported.

"What we have right now is not sustainable [or] tenable," said Jennifer Walker, National Wildlife Federation's Texas Coast and Water Pro-

'Real ID' will be required by next May

Is your state-issued identification card, such as a driver's license, a Real ID? Texans have until May 2025 to find out and comply with a federal law passed in 2005 in response to 9/11, the Statesman reported. The state in response began issuing Real ID compliant cards in 2016. These cards have a gold circle with an inset star located in the upper right-hand

Right now, a Real ID card is not required to fly domestically, but that will change on May 7, 2025. After that, a Real ID or a passport will be required to board domestic flights. Anyone renewing their driver's license now will receive an idea that is Real ID-compliant.

Passports are still required to travel beyond U.S. borders.

Saltwater fish release nears 1 bil-

Hurricane Beryl slowed the official release of the 1 billionth saltwater fish into Texas bays, but it should happen soon, according to the Lubbock Avalanche-Journal. The Texas Parks and Wildlife program has been releasing fish into Texas bays for the past four decades in order to replenish native fish populations.

The fingerlings are raised in local and state hatcheries. The billionth fish is slated to be a red drum fingerling — a highly popular game fish in

Paxton: House committee preparing to impeach him again

Texas Attorney General Ken Paxton said last week that a House investigating panel once again is attempting to impeach him, though its chairman said the panel is meeting for an unrelated matter.

The committee passed articles of impeachment in May 2023 that were passed overwhelmingly by the House. The Senate then voted by a large margin to acquit Paxton.

"Their bitter obsession with taking me down knows no bounds, and they will stop at nothing to remove me from office," Paxton wrote last

Committee chair Rep. Andrew Murr, R-Junction, said Paxton was

mistaken. 'There is absolutely no truth to Mr. Paxton's far-fetched fantasy that the House General Investigating Committee is meeting to talk about him," Murr said in a statement.

Whataburger app serves as outage tracker

While CenterPoint Energy's outage tracker was down, some Houston residents figured out that an app used by Whataburger, the iconic Texas burger chain, could be used to figure out what areas had power and what didn't.

The Houston Chronicle reported the app allowed folks to look at the Houston area and determine what areas had power. If the Whataburger "W" normally orange logo was gray on the app's map, that area likely had

SBA loans available to Hurricane Beryl victims

SACRAMENTO — Low-interest federal disaster loans are now available to Texas businesses and residents as a result of President Biden's major disaster declaration, U.S. Small Business Administration's Administrator Isabella Casillas Guzman announced.

The declaration covers the Brazoria, Chambers, Galveston, Harris, Jackson, Jasper, Jefferson, Liberty, Matagorda, Montgomery, Orange, Polk, San Jacinto, Walker and Wharton counties as a result of Hurricane Beryl that occurred July 5-9.

"SBA's mission-driven team stands ready to help Texas's small businesses and residents impacted by Hurricane Beryl," said Administrator Guzman. "We're committed to providing federal disaster loans swiftly and efficiently, with a customer-centric approach to help business es and communities recover and rebuild."

Francisco Sánchez Jr. associate administrator for the Office of Disaster Recovery and Resilience at the Small Business Administration, also stated, "As a native Houstonian, I am deeply concerned for communities now facing two historic

disasters within a matter of weeks. Hurricane Beryl was catastrophic and deadly. The U.S. Small Business Administration is still on the ground responding to the derecho and will send reinforcements in response to Beryl. I was on the ground just days after the storm and I can assure Texans that the Biden-Harris Administration will be with them every step of the way. SBA will work across local, state, federal, business, and non-profit partners to make every possible resource avail-

Businesses of all sizes and private nonprofit organizations may borrow up to \$2 million to repair or replace damaged or destroyed real estate, machinery and equipment, inventory and other business assets. SBA can also lend additional funds to help with the cost of improvements to protect, prevent or minimize disaster damage from occurring in the future

For small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations of any size, SBA offers Economic Injury Disaster Loans to help meet working capital needs caused by the disaster. Economic injury assistance is

available to businesses regardless of any property damage.

Disaster loans up to \$500,000 are available to homeowners to repair or replace damaged or destroyed real estate. Homeowners and renters are eligible for up to \$100,000 to repair or replace damaged or destroyed personal property, including personal vehicles.

Interest rates can be as low as 4 percent for businesses, 3.25 percent for private nonprofit organizations and 2.688 percent for homeowners and renters with terms up to 30 years. Loan amounts and terms are set by SBA and are based on each applicant's financial condition.

Interest does not begin to accrue until 12 months from the date of the first disaster loan disbursement. SBA disaster loan repayment begins 12 months from the date of the first disbursement.

As soon as Federal-State Disa covery Centers open throughout the affected area, SBA will provide one-on-one assistance to disaster loan applicants. • Became the breadwinner or major support of a household because of the death of the head of household; or

•Were unable to reach their job or selfemp loyment location because they must travel through the affected area and are prevented from doing so by the disaster.

To receive DUA benefits, all required documentation must be submitted within 21 days from the day the DUA application is filed. Required documentation includes Social Security number, and documentation to support that you were working or self-employed when the disaster occurred or were about to start work or self-employment and could not

do so due to the disaster. TWC must have documents that prove you were working, or scheduled to start working, at the time of the disaster. If you do not send us proof of employment by the 21-day deadline, TWC will halt DUA payments and you will be responsible for repaying any benefits you received. In some cases, TWC can use information in our system, such as wage records, to prove you were employed at the time of the disaster.

Report contaminated fuel to TDLR

Special to the News-Standard

AUSTIN — Consumers who suspect that they may have purchased contaminated fuel after flooding caused by Hurricane Beryl hit southeast and east Texas should file a complaint with the Texas Department of Licensing and Regulation as soon as possible.

Intense flooding can sometimes cause water to enter underground fuel storage tanks and contaminate the gasoline supply.

If you suspect you purchased contaminated fuel, take these steps as soon as possible:

•File an online complaint with TDLR immediately. Choose Fuel Metering & Quality from the drop-down menu. It's important to file a complaint as soon as possible - if the station gets deliveries between the incident and the investigation, it can be difficult to prove the fuel did not meet specifications because the contaminated fuel may be diluted or completely dispensed.

•When filing your complaint, be sure to include fuel receipts, fuel type, octane rating, pump number and as much information as

possible about the station and any damage to your vehicle caused by the contaminated fuel.

•Alert the station management or chain headquarters to the issue. Most stations/ headquarters will take action to stop selling the suspect gas and have it checked or remediated. Stations often will voluntarily reimburse the consumer for repairs. However, some stations will deny there's a problem, which is why it's so important to file the complaint quickly so TDLR can investigate the quality of the

•Once TDLR receives a complaint, the department reviews the information to determine if it is appropriate to dispatch an investigator to the location to take a sample of the fuel for lab If the sample is found to be contaminated, TDLR will take necessary action, depending on how the station responds to the reports of contaminated fuel.

Motor fuel dealers and operators are reminded to visually inspect motor fuel metering devices, filtering equipment and storage tanks to ensure there is no contamination and that all items are in proper working order.



Deer season not that far away



We're in the midst of our annual midsummer burnout. A cool day this time of year is when the mercury only reaches 95; but fall and cooler weather is not that far away.

Whitetail season is less than a scant three months away. The summer hunting shows will soon be under way in several of the major cities across the state. This is a time when we deer hunters make plans for fall hunts and devise strategies to outsmart that wily old buck that eluded us this past season. Is he still out there on our hunting grounds, did he move on or succumb to a pack of coyotes after the rut before he had a chance to regain his strength and vitality?

Why not fast forward a few months and think about cooler weather and deer hunting? I think it will do us all good.

I've been a deer hunter since my early years when I would jump off the school bus at the age of 10 during deer season, grab my .410 shotgun loaded with a single rifled slug, snatch a cold sweet potato off the stove and headed to the woods behind our little farm to set on a bucket and hunt deer. This was way back in the late 50s when deer were precious few in northern Red River County where I grew up.

I once saw a big buck cross our hay meadow but never after all those amateurish attempts to kill a buck did I see hide nor hair of

one. I knew next to nothing about whitetail deer other than that they fascinated me, and I had a burning desire to hunt them. It was several years before I killed my first deer — a goat-horned spike — but that little buck was the trophy of a lifetime for me back in the early 60s.

As a young man with a growing family, dollars were tight, but I still managed to get out and hunt the woods of northeast Texas each season. I even managed to take a few deer back in those years, but I was well into my 20s before I had the opportunity to travel down to the Texas Hill Country near Llano with a couple of buddies for a glorious three day hunt with an outfitter that offered day hunts.

I remember to this day that our cost was \$180 apiece and that included transportation to and from stand and camping rights near the old camp house. We all enjoyed a big barbeque dinner that first evening before opening day. I remember the outfitter kidding me about my little brush gun, an iron-sighted lever action .30-.30. Most of the hunters back then had gravitated to scoped rifles, mostly in .30-.06 or .243 caliber.

My stand for that opening morning was a few boards nailed to the lower limbs of an old live oak. Some corn had been sprinkled around the area and just after shooting light, I began to see deer. Several does approached the area and nibbled on corn and then on the edge of a distant tree line, I saw a deer with its head down to the ground, trotting along like a hound on a hot trail.

By this time, had learned the habits of deer and knew this was a buck on the trail of one of the does that was approaching my stand. Within 15 minutes of shooting light, I had my first Hill Country buck on the ground. I think I stretched the distance of the shot a bit when Herb Stehling the outfitter kidded me about making a lucky shot with that old "thuttythutty," but it was an honest 70 paced yards.

My friends and I could not have had a better time had we booked a guided moose hunt in Canada. We hunted, cooked and sat around the campfire a bit too late on that opening night as my memory serves me.

When I began writing outdoor articles back in the eighties, my deer hunting opportunities increased and I found myself hunting deer over much of Texas but also in North Dakota and several of the mountain states for mule

Some of my most fond memories are those early October days I spend hunting with a family that farmed and outfitter deer hunts in the little hamlet of Streeter North Dakota. I hunted with these fine folks for several years. They owned a big house in downtown Streeter (population around 400) which served as a gathering place and dining room for the hunters. Lodging was provided in several homes around the town.

With more than six decades of opening mornings to reflect upon, I feel truly blesses that I have never lost my passion for getting up well before daylight on those cool fall mornings and heading to the deer woods somewhere. I am very thankful that I can still climb a tree into a tree stand and enjoy all elements of deer hunting, everything from practice with my bows and rifles to skinning and quartering the game. I have always enjoyed cooking venison for my family and at camp and put great value on having a good supply of

venison in the freezer.

Granted, I've obviously learned a good bit about deer and how to hunt them through the years, but I still learn something new each year, deer are fascinating animals and there is no formula that always results in venison on the meat pole.

This past February my good friend Larry Weishuhn, aka "Mr. Whitetail," invited me out to far west Texas for a late season doe hunt. I still needed a couple more deer to round out my supply of venison and his managed lease had several unused permits. I had just obtained a new CVA muzzleloader, and I was anxious to put it to use. I honestly thought I would get up in a stand, wait until the feeder went off and be covered up with deer. I was surprised to learn that bucks were dominating the feeders and doe were staying back I the brush, feeding on a plant

called filaree and cedar berries. I had a good supply of a food attractant called Vineyard Max www.vineyardmax.net that I'd heard good things about. It is made from dried, hammer-milled grape skins, rice brand and corn chops. I've known for years that deer love wild grapes but to my knowledge there were no wild grapes or vineyards anywhere near my friend's lease. The attractant has a very strong grape smell, but we were all curious whether these West Texas deer would be attracted to this new smell.

We baited several clearings in the brush with Vineyard Max during mid-day and returned to hunt them on the late afternoon hunts. We were able to fill our doe permits thanks to the smell of grapes. There's always something new to learn about whitetail deer. I can't wait until the season once again opens and I enjoy my 64th season hunting them. I bet you feel the same way too.

Some hybrids are scattered while some are schooling in 19-26 feet biting live bait, jigging with a spoon, or trolling with a deep diver with a pet spoon as a trailer. Crappie are in or around structure 12-21 feet using minnows or jigs. Hair jigs are outproducing plastics. Always wear your life jacket and stay hydrated in this heat. Topwaters are hitor-miss early on points. Carolina rigs, big shaky heads and Texas rigs are good in 10-25 feet of water on points, humps, drop offs. Big worms doing the best in these areas. Crankbaits are good over deep underwater ridges and humps with timber in 18-28 feet. Shad patterns and blue and chart Strike King 6XD or 8XD. Report by Marc Mitchell, Lake Fork Guide Service. Black bass are chasing topwater patterns early in the day and later in the day when it is dark. Check out the brush piles as big bass are using them to feed on crappie. Bream are excellent in the shallows on wooly buggers and small poppers. Report by Guide Alex Guthrie, Fly Fish Fork Guide Service. Lake Fork crappie fishing continues to be excellent going into the dog days of summer. Fish are in all the places they should be for this time of year. Look for crappie holding on brush piles, summer time trees, lay downs, bridges and docks. You can find fish in 14-30 feet right now but it seems like those fish will be above 14-16 feet as that is where the thermocline is showing up.

One of the biggest keys to loading the boat with crappie has been finding the fish that haven't been pressured as much. We are still having a lot of success with very small hand tied jigs in 1/16 ounce. Cut the tails down shorter to get those finicky bites to hook up. Minnows are producing bites but it seems the hook up ratio is much lower and we end up losing a lot of minnows to those finicky fish. Soft plastics will work on the more aggressive crappie too. Staying off huge groups of fish, pitching and swimming jigs will also help to keep those fish put a little longer. If you get the boat right over fish with the really bright sunny skies they will move off most times and relocate. Report by Jacky Wiggins, Jacky Wiggins Guide Service.

Minnows and pin tail Bobby Garland jigs work well. The fish bunch up on bright sunny days. Fish should go on ice as soon as possible, or keep ice in a live well due to extremely high water tem-peratures. Report by Hambone Guide Service.

Nacogdoches

EXCELLENT. Water stained; 92 degrees; 0.44 feet below pool. Largemouth bass are excellent off the bottom in 15-20 feet of water on big crankbaits, Carolina rigs and dropshots. Crappie are excellent on brush piles with live minnows or 1/8 ounce crappie jigs. Catfish are good on cut bait and live minnows. Report by Cal Cameron, Cal's ETX Guide Service.

Naconiche

FAIR. Water stained; 88 degrees; 0.50 feet above full pool. The heat is on so the fish should be in full summer mode. Keep an eye on the thermocline and this tells you the exact depth to present your offering. Bass are holding tight to submerged timber with a Texas rigged Mag-worm. The days of Mag-worm fishing are probably here for the next several months. This is a common approach, so do not be afraid to do something different like Tokyo-rig instead. If you catch them schooling, chunk an underspin at them. Crappie population is good. Catfish are slow. Report by Eric Wolfe, NacoTack Fishing Services Report by Eric Wolfe, NacoTack Fishing Services. Largemouth bass are excellent on Carolina rigs and large swimbaits. Crappie are good on brush piles with chartreuse crappie jigs. Catfish are slow on cut bait and live minnows. SLOW. Water slightly stained; 88 degrees. Huntsville State Park was hit directly by Hurricane Beryl, and will be closed due to storm damage. We apologize to our anglers who were hoping to get on the water this week. Call for up to date information.

GOOD. Water stained; 90 degrees; 5.11 feet above pool. Lots of floating debris after the recent rains from Hurricane Beryl. Water level is slowly dropping, but fishing conditions and patterns are holding steady. Summer bite is just around the corner when we will see the bass draw to deeper water points and white bass schooling. Bass are good on topwaters, or flipping soft plastics into submerged brush and points, or deeper humps and points with Carolina rigs. Crappie are in 12-16 feet of water, 20-30 feet on timber and brush. Catfish are in 22 feet of water in the creek channels. White bass are in 26 feet of water off of points on jigging spoons. Outages left many Texans exposed to the heat. The hurricane has greatly impeded Trinity County's recovery efforts following the storms earlier this year.


