# Patriot Day celebration this weekend at VFW

**WOODVILLE** – Patriot Day is a federally recognized holiday, introduced in 2001 as a day of mourning for those who were lost in the tragic events of Sept. 11 of that year.

Since then Patriot Day celebrations have occurred each year, taking place all over the country, and fostering a sense of togetherness, as well as service, in the various ways they are celebrated. This weekend, for Saturday and Sunday, Sept. 7-8, Veterans of Foreign Wars post number 2033 is hosting its second annual Patriots Day weekend extravaganza.

The event will take place on the VFW post land, located beside of the actual post building at 301 Veterans Way in Woodville. The VFW is asking the community "How much fun can we have?"

According to the VFW, there will be "loads" of enter-

tainment, including the 1-Ton Bullet Band; a live DJ, Daryl Morris, a.k.a. Harry Cheaks and two solo acts, Dave Christen and Troy Seale.

Christen is a Dallas-based singer/songwriter with several records and singles to his credit. He is a regular performer around the DFW area, and at venues in the area, as well, such as Conroe's Corner Pub.

# Infrastructure advisory committee approved

**WOODVILLE** – In a short meeting of the Tyler County Commissioners Court on Tuesday morning, county officials voted to appoint a three-member committee to advise on infrastructure projects potentially effecting the county.

The item had been tabled last month, by the court. County Judge Milton Powers said then that the idea of appointing the committee was to keep the commissioners abreast of potential impacts for the many infrastructure projects coming up in the near future.

Steve Pittman, who was instrumental in coming up with an alternative route to submit to the Texas Department of Transportation (TxDOT) for the relief route project, was appointed to the committee. Pct. 3 Commissioner Mike Marshall, who motioned to remove the agenda item from being tabled, added the names of Cathy Bennett and Scott Yosko, whom Powers had wanted to appoint.

**WOODVILLE** – Woodville Health and Rehabilitation hosted a ribbon cutting event and open house at its facility last Thursday evening.

Representatives from the Tyler County Chamber of Commerce were on hand to do the ribbon cutting on WH&R's new Journeys memory care unit, and the staff, along with representatives from Cantex (WH&R's parent company) provided tours of the facility to attendees.

Journeys is a 40-bed secure unit within the facility. In addition to skilled nursing care for individuals suffering from memory loss, it also holds a support group each month for family members of those affected by Alzheimer's and dementia.

According to a spokesperson for the facility, Journeys is licensed for 40 beds, and there are RNs on duty, around-the-clock. At night, the unit has one-on-one care with more RNs on duty.

Journeys also has all of its rooms semi-private, and although the unit is locked, family members can visit any time. Journeys also has its own dining area.

The benefits of the secure unit include additional safety for your family member, being to move freely in a safe environment to reduce anxiety, freedom of movement which gives residents a feeling of self- confidence and pride, peace of mind for family and friends, and activities geared toward diagnosis.



936.563.2WIN NASKILA.COM In my 40 years of dancing around the halls of journalism, I have one story that when people ask me what my favorite interview was, I relate the story of the Szaloys in Quay County, N.M.

The old man was the son of one of the original homesteaders of that area, around the turn of the last century, and his recounting of the events he lived through were riveting and peppered with humorous phrases.

One of the events in the early 1900s was a snowstorm that lasted for days, which for people at that time was very dangerous. The family had prepared by cutting firewood, but the storm was so bad and so long that they burned through their stockpile.

He then said, "After we burned all the firewood, we looked at the fenceposts we had cut. At first, we burned only the crooked ones. Pretty soon they were all crooked."

The upshot was that at that time, what they had wasn't enough, at that has been the problem with the federal government for decades. Their spending habits have been out of control for so long that there seemingly is never enough cash around for them to fund everything they claim needs funding.

Or, as Margaret Thatcher said, "The problem with socialism is you eventually run out of other people's money."

So in the latest bid to elect an overspender (Kamala Harris), a tax plan has come to light with is supposed to fix the money flow — the unrealized



gains tax. In a very tiny nutshell, it's a tax on income that you could have made.

The income tax started in 1861 during the Civil War, a 3 percent flat tax on incomes over \$800, which was repealed 11 years later. In 1913, the 16th amendment gave the government power to levy taxes on income, since the money coming in from tariffs and excise taxes were not enough to cover the growing needs of the country.

From there, the fenceposts started to become crooked; initially, sales from stocks didn't qualify as income, but the money pit that Washington, D.C., has become needs to be fueled, so things were changed. Soon, anything that could remotely be considered as income — interest on bank accounts, rental income (if you own property), even the swag bags given to presenters at the Oscar celebrations.

In short, if you received it via any means, it was income — you know, crooked wood for the fire. Of course, government's appetite for money has only grown exponentially (while our income hasn't), so now the definition is changing again.

Harris is touting the 25 percent unrealized capital gains tax, which would be placed on personal and business assets, nominally for people with \$100 million or more in wealth. We all know, though, that once the foot is in that particular door, it's only a matter of time before that changes, because the money must flow.

How it works is you own a piece of property that costs \$500,000 (a value, of course, set by the government as well). If the value of that property goes up \$50,000, then you owe the feds \$12,500, whether you sold the property or not.

Guess what happens if it goes up again the following year?

If you can't pay, then of course, you can take out a loan, and if you can't, you lose the property. Simple, huh?

At no time, that I can see, has a plan been put into place to address debt, budget deficits or any government overspending; just more promises of giveaways in order to buy votes, which in turn creates an even greater need for money, and the beat goes on.

The Founding Fathers wanted to protect private property rights. Our current leaders want to protect your private property from, well, you.

# Survivor of a Baby Boomer childhood

Editor's Note: This column is an except from Tom Purcell's book, "Misadventures of a 1970s Childhood."

The MSNBC.com article said that kids raised in the '50s, '60s and '70s are survivors.

We survived chain-smoking adults, meat-andpotato diets and rough-and-tumble fearlessness of every kind — such as the bike jump that nearly killed me in 1972.

It was the Evel Knievel era, after all. Knievel became famous doing wheelies and jumping his motorcycle over cars and buses. Every kid with a bicycle tried to emulate him. We jumped our bikes from ramps built from warped plywood that we set on rickety blocks.

It was a grand feeling to soar through the air — though our landings often weren't pretty.

This was the early '70s, after all. We didn't wear helmets or pads. When our rear wheels hit the pavement, we wiped out plenty.

When a landing went really wrong, a mom was alerted, a moaning kid would be loaded into a wood-paneled station wagon and off he'd go to St. Clair Hospital for stitches or a cast.

Which brings us to the day I almost died.

I was riding a five-speed Murray Spyder bike that year. Its fifth gear allowed me superior speed



and, thus, superior distance off the ramp.

I held the neighborhood record for the longest jump — until some outsider allegedly broke it.

I wasted no time reclaiming my record. I rode to the tippy-top of Marilynn Drive and began pedaling like mad.

I was moving faster than I ever had when I cut a hard left onto Janet Drive and hit the ramp.

The jolt was spectacular. It caused my sweaty fingers to lose hold of the handlebars. Everything went into slow motion.

I remember floating through the air like a directionless missile — my body flailing as it sought to regain its balance.

I remember the tremendous impact that shot through my spine as the rear wheel hit the pavement — how my bike began wobbling wildly.

I was heading for a big, splintery telephone

pole. I leaned left, then right, and, miraculously, avoided the large pole.

The worst was yet ahead. I was roaring toward a thicket of pine trees. Their trunks and branches would surely turn me into kid stew.

Then providence intervened.

One of our neighborhood dads was a welder. He had built a giant steel-framed street-hockey net, and it was stored in the pine brush directly where I was headed.

The net caught me like a glove. I didn't hit a single trunk. I didn't suffer a scratch.

One doctor told MSNBC.com that most kids of my era survived their childhood just fine, but some did get badly hurt, and a helmet and some padding could have saved them.

But it's also true that whereas kids were once free to roam and explore, too many of today's kids aren't free to do much of anything.

In any event, I regained my bike-jump record that day and I'm confident it will stand forever.

Even if a 2024 kid was daring enough to jump his bike off of a ramp, he'd be covered in more protective padding than a hockey goalie.

There's no way a kid carrying that much weight could ever fly as far as I did the day a bike jump nearly killed me.

## Provisions approved for coming fly-in event

The commissioners approved a pair of agenda items for provisions for the coming Fly-In and Food Truck Festival at the Tyler County Airport on Saturday, Sept. 21.

Pct. 1 Commissioner Joe Blacksher said the rental of an avgas (aviation fuel) fuel truck and portable restrooms and a wash station for the event will be paid from the economic development fund.

The event, which is being hosted by the Tyler County Chamber of Commerce, will feature an aviation meet-up with pilots showing off planes, and a group from Conroe offering rides for attendees, as well as a spate of food trucks and craft vendors.



e recently went through a monumental parental rite of passage – moving Daughter, our one and only child, into her college dorm and leaving her there, approximately 200 miles away. It was a long, quiet drive home, to an even quieter house.

I'm sure I'll write all about it at some point ... but not today. It's bittersweet and still too fresh and personal to share with my readers. So instead, I'll pivot tion at 303 Red River. As of this writing, I truly believe that Moonshine may be my favorite restaurant in Austin. I first discovered it numerous years ago when I was attending a court coordinator conference there. That first time, I enjoyed the seared rainbow trout with cornbread stuffing, chile sage butter and green beans with bacon and it was all wonderful. I couldn't wait to take Hubby there. If there's anything we've learned over the years, it is that I should trust him when it comes to TV shows and to cheese with a bacon gratin.

Moonshine is located in a building that is a Texas Historic Landmark, having formerly served as the Hofheintz-Reissig Store. According to the Texas Historical Commission marker erected out front, the structure served as a grocery and dry goods store for nearly 100 years, having been built between 1850 and 1875 for German Emigrant Henry Hofheintz. A one-story addition was later added and was used as a saloon and a residence. Hofheintz' eldest child, Catherine Louise, and her husband, Adolph Reissig, inherited the store, and the property remained in the family until 1966. The building is a beautiful example of the German-influenced architecture found in many 19th-century Texas buildings. Before heading home on Sunday, we met for brunch at Kerbey Lane Cafe, the University location at 2606 Guadalupe. With multiple locations, we'd previously eaten at the original (on Kerbey Lane) on a long-ago spring break trip to Austin, so we knew we would be treated to some excellent food. I ordered the Cuban Benedict which was Cuban-style pulled pork, poached eggs, hollandaise, bacon, cilantro and onion atop a toasted hoagie roll and served with breakfast potatoes. Hubby chose migas, a Tex-Mex classic of scrambled eggs with pico de gallo and tortilla chips, topped with a choice of homemade sauce and melted cheddar jack cheese. It was served with black beans and Mexican rice and a choice of tortillas. Daughter selected biscuits, eggs, sausage and gravy which was two homemade biscuits topped with peppered gravy, two eggs over-easy and two sausage patties. As you can see, we certainly didn't go hungry. With Daughter now ensconced on "The Forty Acres," I think I can safely predict that our trips to Austin will increase dramatically. and tell you about all the good food we enjoyed. Just as Austin is known for its live music and vibrant culture, it is also known for its food – of which we happily took advantage.

Unlike back in my day when it was all done willy-nilly, students are required to make appointments these days to move into their dorms. Our appointment was on a Friday evening and after being given wrong information regarding check-in not just once, but twice in fact, we finally arrived where we were supposed to be and began unloading the vehicle right about the time the rains started.

A couple hours and a few choice words later we had everything unpacked and set up. We were hot, sweaty, tired and just ready for a quick bite before we crashed for the night. (By this time I'd already clocked 16,682 steps according to my Fitbit.) We settled for a quick, easy meal at Zombie Taco, located in the lobby of our hotel, Moxy-Austin University, at 2552 Guadalupe St. It was filling, yet light, and the perfect way to end a long day.

The following day we enjoyed an incredible brunch at a place called Phoebe's Diner, the downtown location at 408 West 11th St. I selected the chorizo hash, which was green chorizo, crispy masa cakes, over-easy eggs, corn, onion, sweet potatoes, spinach, guacamole, pickled chiles, cotija cheese and cilantro. Hubby ordered migas, which entailed Hatch chile hollandaise, scrambled eggs, onion, tomatoes, Hatch chiles, crispy masa cakes, cotija cheese and cilantro served with red potatoes and chorizo. Daughter chose Phoebe's Benedict, which was ham, over-easy eggs, buttermilk biscuits, hollandaise and green onion and was served with a hash brown casserole. Every single bite was incredible and we all agreed that we look forward to heading back to Phoebe's first chance we get.

For supper on Saturday evening we went to Moonshine Patio Bar & Grill, the downtown locahe should trust me when it comes to restaurants.

His first trip to Moonshine was back in July when we were in Austin for freshman orientation and family orientation. Moonshine is one of those places where you can't go wrong, regardless of what you order. That trip, I started with an iceberg wedge composed of bacon, tomato, blue cheese, candied pecans and ranch and then selected the horseradish crusted salmon with lemon dill butter sauce and brussels sprouts. He chose the jalapeno hanger steak with salsa verde, demi-glace and yukon mashers. Every single bite was divine. Commenting that his jalapeno hanger steak was the tenderest piece of steak he'd ever eaten, Hubby shared a bite with me and it melted in my mouth like butter. I knew that's what I would be ordering on our next trip to Moonshine.

Sure enough, I ordered it during move-in weekend and was not disappointed one bit. Hubby selected the center cut pork chop with bourbon cherry chutney, herb salad, demi-glace and yukon mashers. It may have been the thickest pork chop I've ever seen at about three inches thick. He shared a bite with me and it was moist, tender and absolutely delicious.

Daughter ordered a Sunday house club with turkey, ham, bacon, pimento cheese, red onion, house mayo, lettuce and tomato (minus the red onion) and accompanied that with baked macaroni pimen-



# HUNTIN' THE EASY WAY



Since I began writing this weekly column almost 40 years ago, I've always tried to 'take you with me' each week, regardless what I might be doing in the outdoors. I've recounted my adventures fishing in Japan and shared my trips up in the wild of Canada with you.

I've shared my North Dakota bow hunting adventure and detailed the days when I guided for elk and bear in the mountain states. But I've also shared my day-to-day adventures right here In Texas close to home, sometimes catching sunfish from a neighbor's pond or shooting ducks and geese along the Texas coast.

I've been sticking pretty close to the homestead the past couple weeks but there's lots of fun things to do in the outdoors that don't include travel if we look for them. There's some of the best hog hunting I know of within a mile of my house and I have some great friends that allow me to hunt their land. In the winter after the wild porkers have devoured all the acorns in the wood, I've been awakened many times by hogs as close as 20 feet from my bedroom window, feeding under the big oak by the house. During the period of January through March, acorns under the 10 or so big oaks in front of our home pulls hogs in by the scores. But right now, hogs are in the woods feeding on green pecans, hickory nuts, persimmons and acorns the squirrels knock out of the trees.

Through the years, I have devised many ways to hunt my close to home hogs, everything from bow hunting in my yard to using thermal scopes at night on the larger tracts of land owned by my neighbors. A couple weeks ago, I decided I wanted to use my Seneca 50 caliber Dragon Claw air rifle topped with an AGM Global Vision thermal scope to put some pork in the freezer. My plan was to smoke the choice cuts of meat and make a huge pot of chili and freeze it for use at upcoming hunting camps this fall. I usually decide just how I want to prepare the pork before each hunt, sometime the dish is a Mexican stew or chopped barbecue and sometimes it's smoked chili. I love the flavor of fresh pork that has been slow smoked with hickory in chili.

Needless to say, it's been hot lately and my plan needed to facilitate a quick way to chill the meat. It would also be nice to get up off the ground and away from the swarms of mosquitoes common this time of year. But I didn't want to hunt at night in one of my tree stands. After much thought, I devised a plan to use my truck bed as a hunting stand. I found a spot about 50 yards from my feeder where I could pull my truck between two big trees, with heavy cover of brush on either side the outline of my pickup was all but hidden from view. The hogs were coming to the feeder around 9 p.m. each evening and by then it is pitch dark. They would never see me and hopefully never smell me with the truck parked to the west of the feeder. No chance of a south or possibly north wind carrying my scent to approaching porkers.

I placed my most comfortable lawn chair in the bed to the truck and pushed it up against the toolbox which

serves as a convenient table for my glass of cold tea, and resting spot for my rifle. I have a cooler with ice that serves as a footrest while I am waiting for the hogs. I kick my boots off and get comfortable, with Thermocell to deter mosquitoes, I'm all set to hunt in comfort. I'm always conscious of snakes when hunting at night and slip into my snake proof boots when I step out of my 'blind' to the ground. I usually take only the quarters and backstraps of wild hogs when hunting at night. The last thing I wish to do is shoot a hog and stay up half the night butchering the meat. I can remove the back straps and quarters in a matter of a few minutes, place them I the cooler and get back home in time so I don't miss too much sleep. I have the self-imposed deadline of 10 p.m. as time to fire up the truck and make the five-minute drive back home.

I could use my centerfire rifle with thermal scope and back away 100 or more yards from the feeder but I like getting close to hogs. I like to set up so that I can hear them coming through the woods long before I actually see them. I limit my shots to fifty yards with the big bore air rifle and prefer them even closer. I don't want to be traipsing around the woods after dark in attempts to recover a wounded hogs. A close shot with precise bullet placement almost always drops the hog in its tracks.

My first hunt was last night from my truck bed blind

and I thoroughly enjoyed sipping iced tea while setting out in the woods listening to the coyote serenade and the hooting of a couple barred owls that I spotted with the thermal scope in nearby trees. About 9 p.m., I heard the tell-tale sound of a big sounder (herd) of hogs approaching off to my right. My feeder is on the edge of a field and rather than head to the corn, the porkers went straight across the field, probably heading for the four-acre gravel pit to cool off and quench their thirst. No doubt they would be back at the feeder sometime during the night but I had no intentions of staying past 10 p.m.

I love trying to outsmart hogs and have learned a few tricks through my many years of hunting them. Tonight, I will string corn on the ground from the travel route the hogs use going to water back to my feeder. I am pretty sure they will smell the corn when they cross it and follow the kernels back to the feeder. I'm hoping they will eat first and hit the water later after all the corn is gone.

I will be able to film the entire hunt through the camera on my Rattler thermal scope. Wish me luck! Hopefully I can also 'take you with me' via our weekly TV show "A Sportsmans Life" on Carbon TV and YouTube.

## **Eagles tame Orangefield Bobcats in season opener**

**ORANGEFIELD** – The Woodville Eagles opened their season last Friday night in Orangefield and defeated the Bobcats 27-7.

Sophomore quarterback Luke Babin opened the scoring with a 64-yard touchdown to take a 6-0 lead. Defensive end Tayvion Hunter scored on an impressive 93-yard fumble return to bring a 13-7 lead into halftime. The Eagles offense continued to score on a 16-yard pass from Babin to running back Zayon Williams to increase the lead to 20-7. Babin wasn't finished yet. The final scoring drive ended on a 27-yard reception to Kevunte McDaniel for a final score of 27-7.

Hunter was a finalist for the Dave Campbell Player of the Week Award in Texas High School Football. Hunter had 14 tackles, three tackles for losses, four sacks, and a 93-yard touchdown return

Babin completed 11/15 (71.4%) of his passes for 122 yards, two touchdowns and no interceptions. Babin rushed for 104 yards on seven carries.

Williams also rushed for 43 yards on twelve carries and three receptions for 13 yards. Gage Tolar caught passes for 60 yards.

The Eagles racked up 332 yards of total offense including 124 passing and 208 rushing. The Bobcats totaled 299 offensive yards with 77 coming in the air and 222 on the ground.

Woodville's defense was stellar on third down. Orangefield was held to a mere 1 for 13 on third down conversions. The Eagles also recovered three fumbles and had an interception. Woodville also fumbled twice and were 5 for 13 on third down.

The Eagles will host the Anahuac Panthers on a rare Thursday night game this week.

Kickoff is slated for 7 p.m. The Eagles are currently 1-0 this season.

The Lady Eagles went undefeated last week defeating Kirbyville 3-0 and Orangefield 3-1. Woodville is currently ranked sixth in state and will attend the Hardin-Jefferson Tournament. The sub varsity teams will travel to the Silsbee Tournament this weekend. Tuesday, both varsity and JV1 will travel to Deweyville to take on the Pirates.

Deeper bass bite is fair with Carolina rigs. Crappie are slow moving to and from the brush to timber. Catfish are all over the lake in 20 feet of water and in 12 feet of water in the creek channels. Lake level is fluctuating due to recent rains. Bass are biting on finesse baits, dropshot or jig head minnow or Carolina rig. Mid lake to north lake is the most productive area. Lots of fish schooling on main lake flats and ledges. Falling water creates current so fish congregate and now that the lake is risen again the fish are scattered. 

Coach Coleman Butter stated that there were lots of great plays on both sides of the ball.



Mitigation measures to be taken include: 1) Add culverts to improve hydraulic capacity for handling storm runoff that current culverts lack. 2) Regrade roadway section to proper industry standard cross slopes to facilitate correct handling of surface water runoff into ditches, culverts, etc. 3) Roadway base widths are planned to be greater than final surfacing to harden edges against water runoff prior to flows into side ditches. 4) Roadway section to be mixed and compacted to industry standard ASTM densities which will harden against weather elements. 5) Finished roadway driving surfaces to be sealed against water intrusion using asphaltic mat (either hot-mixed asphaltic concrete / oilsand stabilized material / seal coats). 6) Areas of flowing water (resulting from storm water runoff) are planned to be hardened using a combination of erosion matting overlaid with rock rip rap to reduce energy of flowing water 7) city and county ordinance and planning for flood control to ensure the safety of local citizens and preserve property. Other project mitigation includes: 1) if construction encounters endangered species, suspend work to allow for voluntary escape, provide workers with environmental awareness docs and TPWD contact information, employ impact avoidance measures for aquatic organisms, review areas prior to construction to prevent unintended impact to endangered species, use scheduling and confine work to ROW and bridges to facilitate Best Management Practices ("BMPs") for safety of wildlife, fishes and mussels and obtain regulatory permits if necessary, take specified precautions if turtles are encountered, if construction encounters endangered species, suspend work to allow for voluntary escape, provide workers with environmental awareness docs and TPWD contact information, 2) where possible construct culverts and bridges with wildlife in mind, providing space under bridges and culverts for wildlife to cross below the roadway 3) use disturbance-free buffers contiguous to wetlands or aquatic systems, where possible place top of riprap at or below the proposed streambed flowline elevation & where applicable, place culverts and riprap such that up and downstream flow connections are present under low flow conditions, 4) where possible, prevent removal of trees with large hollows for bat habitat, 5) notify TPWD if endangered species are found or if further assistance is necessary to clear and area, 6) Site(s) review for nests prior to construction to avoid disturbance from a minimum zone of 100 meters surrounding any raptor nest February 1 through July 15 or minimum zone of 25' for other bird nests from March 1 to June 30. If any nests are discovered in vegetation or bare ground of occupied nests, avoid disturbance until the eggs have hatched and the young have fledged. Construction may continue on other areas of the site. 7) Construction activities will be con-

sistent with NWP 14 for linear transportation projects as the impact to waters of the US will not be more than 1/10 acre. 8) If historic properties are discovered or unanticipated effects on historic properties are found, work should cease in the immediate area; work can continue where no historic properties are present. Contact THC's History Programs Division at 512-463-5853 and TGLO to consult on further actions that may be necessary to protect historic properties. 9) If cultural materials are encountered during construction or disturbance activities, work should cease in the immediate area; work can continue where no cultural materials are present and contact TGLO and the THC's Archeology Division at 512-463-6096 to consult on further actions that may be necessary to protect the cultural remains. 10) Locate underground utilities and pipes to avoid impact.

City of Woodville will ensure consistency with state & local floodplain protection procedures. There are three primary purposes for this notice. First, people who may be affected by activities in floodplains & wetlands those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns & provide information about these areas. Second, an adequate public notice program can be an important public educational tool. 




