Some nicknames just stick. Like Leta "Tiny" Wilson's. When she was born the smaller of twins, her parents Tom and Lois Bebout began calling her sibling Little Sis and Leta became Little Tiny. In time, the pair became simply Tiny and Sis. She's Tiny to this day more than 86 years later. She was born at home and was one of eight children. She grew up on the farm and attended Fairview School through eighth grade.

That was followed by four years at Wayne High School. Tiny graduated in May 1953. The day the Wayne seniors left on a senior trip, Tiny found a job as a telephone operator in Purcell.

It was while she was working that job that Tiny met Billy Joe Wilson in May 1954.

He was working in the oilfield and was living in Purcell with his sister.

After a whirlwind courtship - "it was quite a short romance," Tiny said - they were married July 23, 1954, at the Assembly of God in Purcell.

The newlyweds moved to Oklahoma City for a time before returning to Purcell.

Tiny resumed her job as a telephone operator and Joe worked odd jobs.

After the birth of their oldest son, Mike, Joe joined the Navy and served four years in the ranks.

They moved to Brunswick, Ga., where Joe was assigned to a blimp squadron.

Then the Navy sent him to school to become an aircraft electrician. That move sent them to Jacksonville, Fla.

Following his school, they traveled to Naval Air Station Miramar near San Diego.

The Navy assigned Joe

Shots fired in Purcell

No one injured at Star Travel Plaza

Just before 6 p.m. Tuesday, Purcell Police reported shots were fired at the Star Travel Plaza in Purcell, located at 2425 SH 74 south of town and just west of Interstate 35.

Captain James Bolling said the victim's car was parked by the gas pumps. When they were about to leave a black vehicle blocked their exit.

Bolling said words were exchanged and the driver of the victim's vehicle attempted to back up to get around the black vehicle.

The driver saw a black

person, unknown if male or female, get out of the suspect's vehicle and point a handgun at the rear of the victim's vehicle.

The victim's Volkswagen was shot two times, damaging the car but not striking anyone inside the vehicle.

"The victims were able to speed away and call 911," Bolling said.

The victims drove to Murphy's gas station where officers took a statement from them.

Bolling said the investigation is ongoing.

Officer Baca resigns

Investigation continues

Purcell Police Officer Jason Baca, Sr., has resigned from the police force here, according to Purcell Police Captain James Bolling.

Baca is under investigation by both Purcell Police and the Oklahoma State Bureau of Investigation (OSBI) for sexual battery on a 37-year-old woman.

OSBI agents report they have been contacted by three other women with similar stories.

Baca was on paid administrative leave until his resignation.

Bolling told **The Purcell Register** for information regarding any pending charges related to officer Baca to contact the District Attorney's office or the OSBI.

The display will be open from 5:30 to 10 p.m. nightly and different community groups will work the gate each night.

One featured attraction at Wednesday's event will be a personal appearance by Santa who takes time out from his busy North Pole schedule to attend every year.

There will also be a selfie booth at the entrance for visitors who want a photo memory of the evening.

NEWS FROM CAPITOL HILL

The work left to do

Congressman Tom Cole

As the end of the year draws nearer, unfinished legislative work remains for lawmakers in both chambers of Congress.

In the coming days and weeks, it is critically important that members come together to tackle the pressing work left to do.

First, Congress needs to provide full-year funding – also called appropriations – for the federal government. As you might know, annual appropriations support government programs that touch nearly every aspect of our daily lives as well as various facets of the economy – including national defense, operating national parks, law and immigration enforcement, health care research and a host of other activities.

All of these activities should be funded through 12 annual appropriation bills passed by Congress and signed into law by the president before the start of the fiscal year on October 1.

Unfortunately, that legislation has not been completed yet for fiscal year 2021. As a result,

government operations are temporarily being funded by a short-term "continuing resolution" through December 11.

I am encouraged that the Senate Appropriations Committee recently unveiled their version of annual funding legislation. However, it will ultimately require time, bipartisanship and good faith negotiation to ensure both chambers can pass and the president will sign any legislation into law.

Along with continuing the government's regular functions and preventing a shutdown, Congress still needs to act on additional coronavirus relief for the American people. Both chambers have already shown it's possible to deliver relief in a bipartisan manner, as it did four times earlier this year.

Unfortunately, Speaker Pelosi has for months intentionally stalled progress on a fifth relief package even though bipartisan agreement exists on many things, such as extending the small business saving Paycheck Protection Program.

Finally, another critical piece of legislation that awaits

completion is the National Defense Authorization Act (NDAA). This annual legislation authorizes funding for the U.S. military and other critical defense priorities and ensures our troops and their families have what they need to defend our nation.

The enactment of this complex legislation has been passed each year, for 59 years. In the coming weeks, I am hopeful that differences can be sorted out and we can send the NDAA to President Trump to be enacted to support our common defense and ensure protection of U.S. interests around the world.

Before the end of the year and the start of a new Congress, current members on both sides of the aisle and across the Capitol must work together to keep the government funded, act on another coronavirus relief package and authorize funding to support our common defense.

I remain committed to finishing that important work, and I urge my colleagues to do the same for the good of all Americans.

hero characters like Iron Man, Captain America, and the rest of the Avengers.

However, even though “The Avengers” and “The New Mutants” both share a Marvel origin, they do not inhabit the same movie universe.

Back before Marvel became the cinematic juggernaut it is today, it ran across a number of financial woes during the 1990s, licensing off a number of their most popular characters.

This included Spider-Man, which eventually ended up in the hands of Sony Pictures. Plus the Fantastic Four and the X-Men, both of which became properties of 20th Century Fox.

So, for the past 20 years or so Fox has made the most of their acquisition, arguably starting the comic book movie renaissance back in 2000 with the first “X-Men” film, and continuing to a varying degree of success with a pair of X-Men trilogies, plus spin off films featuring their most popular characters like Wolverine and Deadpool.

That’s where this film comes in.

Much like “Deadpool,” “The New Mutants” was supposed to bring a different tone than you might expect in your typical superhero movie.

But instead of going the comedic route like with “Deadpool,” Josh Boone, the film’s writer and director, sought out to make something a little more unique for the comic book movie genre. He wanted to create a horror movie.

I distinctly remember watching the first trailer for this film, all the way back in 2017 and thinking “well that’s different.” It was a distinctly horror trailer, complete with jump scares and a creepy rendition of “We Need No Education” by Pink Floyd. There’s no mistaking the tone the filmmakers were going for here.

Of course back then, the complete and total abject failure that was 2015’s “Fantastic Four” was also still very fresh in our minds, which, as I mentioned before, is also a Marvel property produced by Fox.

“Fantastic Four” was another film infamous for its production woes, including studio mandated reshoots that drastically altered the director’s original vision, and release date delays. It was also a terrible, unfinished, mess of a movie.

For me, hearing reports that “The New Mutants” was also getting reshoots, and rumors of the studio attempting to change the tone of the film, gave me nothing but flashbacks to what happened with “Fantastic Four.” And the seemingly never ending delays did nothing to dissuade my concerns.

Interestingly enough though, after all the dust had settled and the movie actually released, not much actually changed from the director’s original vision.

Thanks to Disney’s acquisition of Fox, the film’s production was halted, and those scheduled reshoots people kept going on and on about never actually ended up happening.

They didn’t even go back to shoot pickups, which are only minor scenes to help fill in the blanks during editing.

Boone said by the time the merger between the studios was done, the cast of “The New Mutants,” which were supposed to look like teenagers, had gotten

older. Old enough that I assume new footage wouldn’t look natural next to all the scenes already filmed.

So after all that drama overblown by entertainment news outlets and social media, it seems Boone got to pretty much make the movie he originally wanted to make, with all the footage he originally shot back in 2017.

Basically, it was a whole lot of bellyaching over nothing.

But enough rambling about the movie’s production, I suppose I should say what I think about the movie itself.

To be honest, I just think it’s fine.

It’s not amazing. It’s not even what I’d call good, but it wasn’t exactly bad either and it certainly doesn’t languish in the depths of terrible films like 2015’s “Fantastic Four.”

The movie has a fairly cohesive narrative, there’s generally an okay flow from scene to scene, and there aren’t any sudden time skips that fast forward the film a year into the future out of nowhere, so the movie already holds a decisive edge over “Fantastic Four.”

Performances wise, I’d say most of the actors are okay. They have their weaker moments, and some of the dialogue here definitely doesn’t help their case.

I’m gonna be honest. Blu Hunt, the actress who plays the film’s main character Danielle Moonstar, is pretty rough for most of the movie.

The film throws her straight away into some very strong emotional scenes, and sadly she just lacked the conviction needed to sell moments like that. It’s far from the worst acting I’ve ever seen, but it’s not exactly the performance you want out of your film’s lead.

Maisie Williams, of “Game of Thrones” fame, does a decent job here. In fact, as far as acting goes, she was probably the most consistent of the group.

Anya Taylor-Joy is also here, playing a Russian teenager named Illyana. Anya has quickly become a bit of a favorite actress of mine due to a number of excellent performances, most recently in a wonderful show on Netflix called “The Queen’s Gambit.”

After watching that show, it was frankly quite jarring to see her here. It’s such a different character. One that wasn’t exactly written to be terribly likeable.

Illyana’s role is basically to be antagonistic towards Danielle every chance she gets. Sure, they try to give her a sad backstory as the movie goes on, but by then the movie’s already established her as the “mean girl.”

There just isn’t enough time dedicated to making her sympathetic, which is a shame because she’s an interesting character in concept, with what looked like an interesting backstory that the film only briefly touched on.

Though I suppose the selling point here from the director wasn’t necessarily the characters, it was the genre. So just how much of a horror movie is “The New Mutants?”

Well, I’d say not too much.

Sure, there are some horror elements here. There’s some creepy visuals, and there’s some genuinely terrifying

looking creature designs here and there.

But at the end of the day these characters are all superheroes.

There’s not really an existential threat shown here that these teenagers can’t handle. They might run scared for a moment or two, but later they’ll just turn around and absolutely demolish whatever dared to threaten them.

It’s just not scary.

During the film’s climax, the movie basically transitions straight into another typical giant comic book movie slugfest. Which looks pretty cool visually, don’t get me wrong, but it’s not exactly what I’d call horror.

Fortunately, the writers here didn’t make the common mistake of raising the stakes for our young heroes too high.

There isn’t a giant blue space laser shooting up from the sky, the fate of the world doesn’t solely rest on their shoulders. They’re just a group of kids dealing with their inner demons, just more with their fists and less with their feelings like typical teenagers.

So in the end, this movie, which has been a curiosity of mine for the past three years, ended up being neither exceptionally good or unbearably bad.

It’s just okay. Which is oddly a little disappointing. Even if it was outright terrible, at least it’d probably be more memorable, though for not so great reasons.

I suppose this film will just have to be remembered for being what it is. The final movie of a 20 year era of X-Men under 20th Century Fox.

It definitely won’t be the last we see of these characters. With Disney gaining the film rights to the entire catalogue of X-Men, it’s only a matter of time before we see our favorite mutants appearing in the Marvel Cinematic Universe.

But it’s still a goodbye to this particular film universe, under a studio that seemed more willing to take more risks than Disney does, to both very good and very bad results.

I doubt a movie as bad as “X-Men Origins: Wolverine” would have ever seen the light of day under the MCU banner. Then again, I don’t know if a film as raw and gut wrenching as “Logan” would get made by them either.

For all their many faults, it was nice to have Fox out there, trying new things, stumbling occasionally, but still pushing the genre forward.

As much as I like the idea of eventually seeing the X-Men team up with The Avengers, I worry we lost something we’ll never see again with this merger. I suppose though, in the end, only time will tell.

Historic Election?

“In this historic election.” How many times have you heard this over the past two weeks? In truth, there are some historic elements. This election had the greatest number of votes cast in history. Is that historic or population growth? It’s also a higher voter percentage than we have seen in some time, but nowhere close to the highest.

A woman on the winning ticket is most definitely historic, so much in fact that I am stumped on how to make a comparison. This past week most of the attention seems to be on Trump’s refusal to admit defeat. But that is not historic either. Many have called this the most important election in our lives, whereas, in fact, it is just the most recent.

First, let’s tackle the voter turnout. At 67 percent voting at last count, the 2020 election is impressive for modern elections. The last time we cleared 60 percent was 1968. Historically, however, between 1840 and 1904 voting was always over 70 percent with the elections of 1856 and 1860 going over 80 percent and the highest election percentage of all time was 1876 with 81.8 percent. The elections of 1860, 1876 and 2020 have some similarities; they had either controversial figures or voting irregularities.

The increase in voting percentage is also impressive in 2020. Four years ago, 59 percent of the population voted, an 8 percent growth in 2020, one of the highest of all time. Much of this has been attributed to hatred of Trump more than fondness of Biden.

Though 1876 is one of the most controversial elections, the controversy was the outcome, not the candidates. There was also a 10 percent jump between 1948 and 1952. Again, nothing controversial; in fact, Eisenhower was popular with both sides in 1952. Finally, the greatest difference between elections was 1836 and 1840 with a 22 percent increase of voter turnout. In this case it was the economic Panic of 1837 had hurt the incumbent Martin Van Buren, not anything controversial.

As for Trump’s attitude towards conceding, while annoying for the Democrats, this also is not new. Historically speaking, we do not even have to go back very far, only to 2000. Anyone old enough to have gone through this election probably remembers too well the annoyingness of new vocabulary words like “hanging chads.” The Election of 2000 saw two new candidates but with familiar names, Vice President Al Gore versus George Bush. As with 2020, it was a close election on election night and whoever won Florida would win the game.

As election night came to a close and it looked as if Bush had won Florida, Gore made the concession call to Bush. However, by the next day Democrats had come out with claims of voter fraud and voter suppression in Florida, and Gore called Bush back to recant his concession. Democrats demanded a recount, which was done, but after the recount did not change the outcome, Gore demanded a recount by hand instead of by machines.

The issue was that on some punch cards, the wrong names were accidentally hit or were not punched properly. The recount took weeks, this time to the annoyance of Republicans. In the end, it took the Supreme Court to force the recount to end and declare Bush the winner.

It is always good to see democracy in action and that so many took part of the election process. This was an important election in that all elections are important, However, historically speaking, neither the percentages voting nor the squabbling after the fact are anything new.

With the election past us now, I hope everyone can put politics aside for a day and enjoy your Thanksgiving. I for one am grateful I live in a country where we can have this fight about elections. Not all nations get to do this.



navirus in our communities:

- **Wear a mask:** If spending time with anyone who does not live in your home, wear a mask, especially if there is a chance you may not be able to maintain 6 feet or more of distance at any given point.
- **Plan social distancing in advance:** Don't let yourself or attendees of any gatherings you're hosting be caught in an uncomfortable situation that could potentially promote the spread of COVID-19. Have a plan for how people who do not live in the same home can stay six feet apart – or more – at all times.
- **Be cautious when eating:** The holidays and family meals go hand in hand; however, because we cannot eat or drink with masks on, this can become a troublesome time

for unknowingly transmitting COVID-19.

If you must eat in a group setting, try to stagger the times attendees eat and ensure six feet or more of distance between each person.

Spreading out outdoors or in a larger, more open room is preferred to a more confined space, although masking and social distancing are still recommended outside.

- **Limit your numbers:** The fewer people gather together, the fewer people may be exposed to the virus if an asymptomatic person is a member of the party.

- **Keep your hands clean:** Wash hands frequently for at least 20 seconds and/or use a hand sanitizer often.

- **Don't share:** Viruses can live on surfaces, so it's best to avoid touching things that

may be touched by others. Opt for disposable items and label them to help lessen the risk guests may accidentally eat or drink after each other. Don't plan games or activities that promote several people touching the same objects.

- **If you're sick, stay home:** Even if you don't suspect COVID-19 is the reason you feel under the weather, it's better to play it safe and not run the risk of exposing others. Take advantage of videoconferencing technology to connect from a distance.

"We know that the holidays this year will be different, so having a plan is a good way to make the best of things – including when it comes to limiting the spread of infection," Kirk said. "With COVID-19 as in sports, sometimes the best defense is a good offense."



§ 106-405 Junk Vehicle on Private Property Prohibited.

No person in charge or control of any property within the city, whether as owner, tenant, occupant, lessee, or otherwise, shall allow any partially dismantled, non-operating, wrecked, junked, or unlicensed vehicle to remain on such property longer than seven days and no person shall leave any such vehicle on any property within the city for a longer time than seven days.

This section shall not apply with regard to a vehicle in an enclosed building, a vehicle on the premises of a business enterprise operated in a lawful place and manner when necessary to the operation of such business enterprise, or a vehicle in an appropriate storage place or depository maintained in a lawful place and manner by the city.

Delta Public Transit receives CARES funds for safety protections

Delta Public Transit today announced that it is receiving nearly \$133,000 in state CARES Act funding to assist in the purchase of Personal Protective Equipment and cleaning supplies.

"The health and welfare of our passengers is the number one priority of Delta Public Transit," said Terrell Turman, Delta's Transit Director. "This emergency relief funding from the state is significant for us to increase our safety protocols while at the same time saving our transit CARES dollars for other operating needs during this pandemic."

Oklahoma's public transit systems have been severely impacted by the decreased ridership and higher operational costs due to COVID-19. In late August, Gov. Kevin Stitt and Oklahoma Department of Transportation (ODOT) Secretary Tim Gatz announced that \$6 million in federal CARES Act funding would be directed to ODOT for the Protect Transit project that includes support in purchasing Personal Protection Equipment and cleaning supplies for public transit agencies statewide.

"It's good to see Delta Public Transit leading the way on putting CARES Act dollars to work protecting riders and drivers from the spread of COVID-19," Secretary of Transportation and ODOT Executive Director Tim Gatz said. "ODOT received funding requests for Personal Protective Equipment and cleaning supplies from more than 30 organizations that provide transportation services in Oklahoma."

During this health crisis, transit systems across Oklahoma have continued to perform their daily service to thousands of Oklahomans who depend upon transit as their only means to get to life-saving medical appointments, to grocery stores, pharmacies and other shopping locations, to work and to other essential places. Systems statewide have increased safety

precautions in a variety of ways including increased and deeper cleanings, personal protective actions, social distancing, changes in operating procedures and following all CDC recommendations.

"Rural transit is essential to the wellbeing of our citizens, communities and the state's economy," said Oklahoma Transit Association Chief Executive Officer Mark C. Nestlen. "The importance of transit has been magnified during the COVID-19 pandemic with systems continuing to meet the critical transportation needs of Oklahomans while at the same time increasing safety and health standards."

Nestlen said that in the long-term, the legislature must address the viability of Oklahoma's transit system on the pandemic subsidies. "Public transit will be a major component of Oklahoma's economic recovery. Without an effective public transit system operating seamlessly statewide within and between rural and urban Oklahoma, a recovery will be slow at best, if at all," he concluded.

In addition to PPE and cleaning supplies, Delta Public Transit is using the state CARES dollars to install the ProAir HEPA-3 filtration system combined with UV light to eliminate harmful airborne particulates to protect both passengers and drivers.

"The HEPA-3 system will purify the air and reduce the potential of COVID-19 contamination on the vehicles," said Brent Roy of Creative Bus Sales.

Delta Public Transit, headquartered in Pauls Valley, is a rural public transportation system dedicated to providing excellence in transportation through mobility that promotes self-sufficiency, independence and improves the quality of life while stimulating economic development with the provi-

OESC releases tips for faster ID verification

To mitigate a rise in fraudulent claims, the Oklahoma Employment Security Commission (OESC) is requiring claimants filing weekly claims on ui.ok.gov to verify their identity to process unemployment claims, as of November 12. OESC is providing a list of tips to simplify the online identity verification process.

"The rollout of online identity verification is a huge leap forward, and we want to ensure that Oklahomans are able to verify their identity as quickly and efficiently as possible," said Shelley Zumwalt, OESC executive director.

"Without verification, claimants will not be able to claim unemployment benefits. In addition, Digital ID verification

will happen every 90 days, so the sooner claimants can get used to the process, the easier it will be for future attempts."

To date, more than 65,000 Oklahomans have filed through the new unemployment claims process. For those who have not yet verified their identity, the agency encourages claimants to follow a few simple guidelines when uploading the required images of the applicant's photo ID and face.

Photo ID tips:

- Ensure all edges, especially the four corners are visible;
- Ensure the photo is not blurry and is clearly visible;
- Take the photo in a well-lit area;
- Use indirect light to avoid glare; and
- Place the ID on a contrasting background.

Facial photo tips:

- Have a plain, single-colored wall as a background;
- Face the camera directly - include your shoulders and top of your head;
- Have the camera at eye level - do not hold the camera too high or too low
- Ensure the area is well lit with no backlight; and
- Do not wear sunglasses or a hat, and ensure hair is not obstructing your face

This simplified unemployment solution is made possible by OESC's partnership with IDEMIA, the global leader in augmented identity. Since the COVID-19 pandemic began, states have seen nearly \$26 billion in unemployment fraud and spent several million more investigating cybercriminals. This technology was developed to combat fraud and ensure that residents can claim their benefits with ease.

Public input needed on planned US-77 widening

The Oklahoma Department of Transportation is hosting a virtual open house to provide updates and get public input on proposed reconstruction and widening of US-77 in Lexington in Cleveland County.

This project would continue the widening of the US-77 corridor between Noble and Lexington.

The existing two-lane highway warrants expansion based on current and future traffic volumes, and the department proposes reconstruction of US-77 to a four-lane highway from the SH-39 junction in Lexington about one mile north to just south of Moffatt Rd.

There are also several proposed design alternatives to realign the US-77 intersections at SH-39 and N.W. 3rd St. in Lexington.

Public comments are now open and will be accepted

through Monday, November 23, at www.odot.org/US77Lexington.

Right-of-way acquisition is planned to begin in Federal Fiscal Year 2021 and construction is expected to begin in FFY 2023. The highway will remain open to traffic during construction.

Due to COVID-19 precautions, this presentation will be a web-based public viewing format with no in-person meetings scheduled.

Members of the public can visit the website to view a presentation, map, video and other materials about the proposal and submit their comments through November 23.

I just want to talk about my brother.

Welcome to the 'front porch.'

Mr. Charles Nix, the man who 'discovered me,' as I like to say, once began a column for the **LaGrange Daily News** with that first line.

I say he 'discovered me' with a little laugh. What I mean is that he ran up onto Grandma and me one day broken down in her still-running 1956 Ford on the side of the Roanoke Road. We were headed out to see my Uncle Raymond.

Mr. Nix not only stopped to help us and guide us to safety; but as we talked he said he'd arrange an interview for me with the LDN editor Ms. Andrea Lovejoy, once he found out I was 'kind of a writer' and thought I had the makings for a famous columnist. That was in 1997. I'm not famous yet, but we could probably lay a pretty good claim to a little infamy.

When Grandma and I got to Uncle Raymond's house just over the Alabama line, he told me he liked Charles Nix's writing, and he added, "He had one column I'll always remember. It began with, 'I just want to talk about my brother.'"

I never forgot that nice little first line, either. And even though we've kind of gone around the world to get to it - which is very fitting in this case, as you will see - for today I just want to talk to you about my brother. I am more than honored to do this.

When I say 'brother,' I am not talking about my two Bowen brothers Tim and Wayne. I am referring to one of those brothers you don't meet until three or four years after you're born. Tim and Wayne have been my brothers since 1956. I didn't meet Ryan Howell until, say, 1962 - a little before, maybe, or a tad later. Truth is, I have known him as long as I can remember.

Ryan lived in Birmingham most of his life. We would see each other when we were younger when we went up to Birmingham for their "Spring Meeting" that ended on Easter Sunday every year. Mama would buy us new clothes, we would get all spruced up - or "High Karate'd" up - and we'd head up to Birmingham to hear the preaching of Lynwood Smith, the best storytelling preacher ever to hit the South.

The Howell family included

Ryan's mom and dad and four girls: Melondy, Angie, Donna, and Janet - and they became a part of our lives early on through church gatherings. At the first, I'm sure I liked a couple of his sisters a lot better than I liked Ryan. You understand.

When we were teenagers, Ryan, Coca-Cola Mike, and a bunch more of us all had good times when we would go to Roanoke every summer for a singing school held by Mr. Dorsey Yarbrough. That was down Ryan's alley, because everybody who knows Ryan knows he could sing with any of 'em.

Years later - after Ryan and I found the only two girls in the world who were misguided enough to marry us - Ryan and Sandy moved to Houston where the amazin' blonde and I were living. Together again, we all continued making our mark on the world. For a while we attended the same little Aurora Street church of Christ on the north side of town - and I had the privilege of sitting in front of the greatest and most enthu-

At the time Jesus spoke this parable, a "talent" was a measure of money. Over time,



Do you go to worship/mass/church regularly? It doesn't have to be every Saturday or Sunday, but do you attend a certain amount of the time, say 80 percent? Or are you a spiritual person who doesn't feel a need to be affiliated with a formal faith group? Do you think being at the lake or on the golf course is just as good as going to a communal worship service? I'm not here to condemn anyone for any of these practices. I merely want to share some of my own thoughts, as well as those that came from our adult Sunday school class.

Why do I worship regularly? It's not always weekly, but it is probably at least 75 percent of the time. When I do miss, my life lacks a certain schedule, but even more, my spirit doesn't get its regular "fill-up" similar to the gas tank in our car. Someone used the term "getting fed" spiritually, and I personally look for a group where I can learn more about what it is to follow Jesus' teachings and to give praise to God.

Another reason for my attendance is to remind me of the hope I have for my life and for others' lives. Sharing what is going on with our community, our country, and our world reminds us that, no matter what,

we are not alone. We have God and our church family with us to share our joys and concerns.

Before last March and the emphasis on the COVID-19 pandemic began, it was the place you could always get a hug for asking or even a handshake if you felt more comfortable with that contact. We could form a large circle to join hands in to share the pastoral prayer and what many of us know as The Lord's Prayer. Other faith groups may recite other special prayers together.

I really miss those hugs and those prayer circles. Before March 2020, those of us who live alone didn't always get our "minimum daily/weekly requirement (MDR)" of human physical contact. With choosing to social distance in order to preserve our and others' health, I definitely don't get that MDR that all humans need.

Even those that live in a group or family don't always get their MDR regularly. I have hope in my heart that we may be able to do that again in the not-too-distant future with the possibility of a vaccine for COVID-19 that will help control the virus.

In the meantime, our society has had to learn to do things differently. "Virtual" has become a word we are all familiar with, not just us science "nerds/geeks" who have spoken about "virtual reality" for quite a few years. Many churches have chosen to use Facebook, Zoom, or other software to share their messages, and that is good.

Many were doing that even before the pandemic, but no matter how good or uplifting the speaker is, making the direct connection with God and my church family in person fills my "cup" more completely.

What I hope for all people is that they can find a faith group,

a spiritual family, where they can build their relationship with God. It doesn't have to be a particular denomination or church organization. My prayer is it would be a place of worship for you to join with God and other humans.

Again, we don't have to believe exactly the same to be a part of the same family—look how it is within our human "blood" families, with our weird relatives and team rivalries. We don't always agree, but hopefully we can put those disagreements and spats aside for at least once (or twice or three times or more) per year to gather together and enjoy each other.

I remind myself: we may not be able to do that this year as we have in the past. But whether we're together or choose to distance for Thanksgiving, Christmas, Hannukah, Kwanzaa, or any other celebration, we can still call on the phone, or Facetime/Skype, or some other way of linking up in some approximate way. We can even send cards, letters, or emails to each other! If there's no other way, we can always pray for each other...

Besides his singing, Ryan is one of the great storytellers, too – I mean the kind that feels it to be wrong to leave out even the slightest detail in a story. He never erred from the straight-and-narrow in that regard, for sure. A bit of Ryan's long-windedness rubbed off on me, too, but I can't hold a candle to Ryan Howell on telling a story with absolute, unflappable and unmerciful, detail. He told a story in vivid flying colors, laughing every step of the way, but that isn't even all of it. Sandy, as vivacious as Ryan but more lovely, to be sure, is a super good talker, too, and she will jump in and say, "Oh, Ryan, don't forget the part about..."

When Ryan and Sandy showed up, you always wanted to make sure you had a Snickers bar in your pocket. One of his daughters told me the other day how they remembered all of us in the living room laugh-

ing our heads off and telling stories. Those moments were magical. There was always us, with Ryan – my big friend who was as silver-headed as Charlie Rich – Sandy, the Southern girl with the world's biggest and best smile – and often best friends Coca-Cola Mike and Glory – all together. It was always right. It was always perfect.

Those were the days my friend.

Ryan and Sandy lived in Houston near us long enough to have two girls, Lauren and Brittany, and then they decided to move back to Birmingham. There their baby girl Andrea came along. Their family was set, Ryan was back to his home church and to his parents and four sisters (that's right--he has four sisters and three daughters), and he worked at FedEx until just a few years ago.

We all stayed in touch all through the years, but not nearly enough to satisfy any of us, and had a full day together home in LaGrange just a year

or so ago. Since that visit, Ryan's health began to slip. It was a number of issues, and he spent several weeks in the hospital over the past month. He and I talked some while he was there, and he was in great spirits, as always. That was Ryan, of course. He was never any other way.

This past Monday morning I was just heading home from my work in Oklahoma when Marilyn called with the unexpected bad news. Ryan had died.

My heart dropped. I pulled over on the side of the road at the first exit. For a few minutes there, I spent a little time with Ryan, my friend, just as before.

I suppose it is fitting that, as we share his story this week, that it will take more than one week's writing. After all, wouldn't you expect a long story told with unassailable details and with enthusiastic flying colors.

My brother Ryan wouldn't have it any other way.
