## Mother-son facing charges

Drug trafficking and money laundering

Two people are facing criminal charges of drug trafficking and money laundering.

Late last week Acting U.S. Attorney Robert J. Troester announced a Superseding Indictment was unsealed charging Chance Alan Wilson, 36, of McAlester, and Deanna Danett

Wilson, 55, of Wayne, with conspiracy to possess methamphetamine with intent to distribute and conspiracy to launder drug proceeds.

Early in June, a federal grand jury returned a 12-count Superseding Indictment against Chance and his mother Deanna.

According to the Superseding Indictment, Mr. Wilson was the head of the Universal Aryan Brotherhood, a prison gang that operates largely within prison facilities throughout Oklahoma. It is

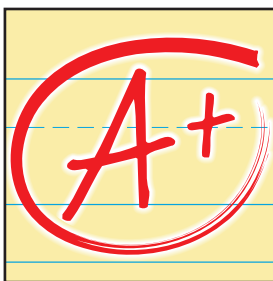

Crews cleared the Apache address by 7:18 a.m.

Both structures sustained damage.

Fireworks fun requires caution

More than a year of COVID-19 precautions and vaccinations has Oklahomans looking to Independence Day as a fireworks-punctuated opportunity to reconnect with friends and neighbors.

However, that enthusiasm could leave the community open to other risks: accidental injuries and fires.

“Fireworks are exciting and fun to watch, but they’re also dangerous. A little forethought will help ensure the holiday isn’t ruined by preventable accidents,” said, Jim Rhodes, Oklahoma State University Extension 4-H youth safety educator.

According to the federal Consumer Product Safety Commission, fireworks were involved with an estimated 10,000 injuries treated in U.S. hospital emergency departments during calendar year 2019 – not all fireworks are consumed on the holiday itself. The estimated rate of fireworks-related

injuries nationwide is 3.1 per 100,000 people.

John Weir, OSU Extension associate specialist in the Department of Natural Resource Ecology and Management, said recent wet weather will help keep grassland fires under control. Hay and forage shielded from rain could be a little drier, but overall high humidity will help keep those materials from sparking also.

“Think about the areas where you’re going to light fireworks, what’s nearby and wind direction. Be aware of materials that may be flammable,” Weir said. “Fireworks should only be used outside in clear areas away from structures and vehicles.”

Weir suggested having a handy source of water nearby, such as a garden hose or bucket. A handheld fire extinguisher should always be available in the home.

Before purchasing celebratory products, check local ordinances to ensure they can be used legally in the area.

Fireworks safety begins

ahead of the holiday, Rhodes said. Parents should have conversations with their children about which fireworks products they can operate and precaution expectations.

For example, impact-snappers seem safe because they don’t require lighting, but those products should not be thrown at or near other people or animals. Likewise with handheld sparklers: Children need to be reminded to be careful of anyone within arm’s reach and that the leftover sticks are still hot.

“When you visit a fireworks stand, try to direct your kids to the products that are appropriate to their age,” Rhodes said. “Of course, they’ll want the bigger items. That opens the conversation about who lights the fuses and how far away to stand.”

When finished, douse spent fireworks with water and put them in a metal trash can away from structures or combustible materials until the next day, when they can be disposed of safely.

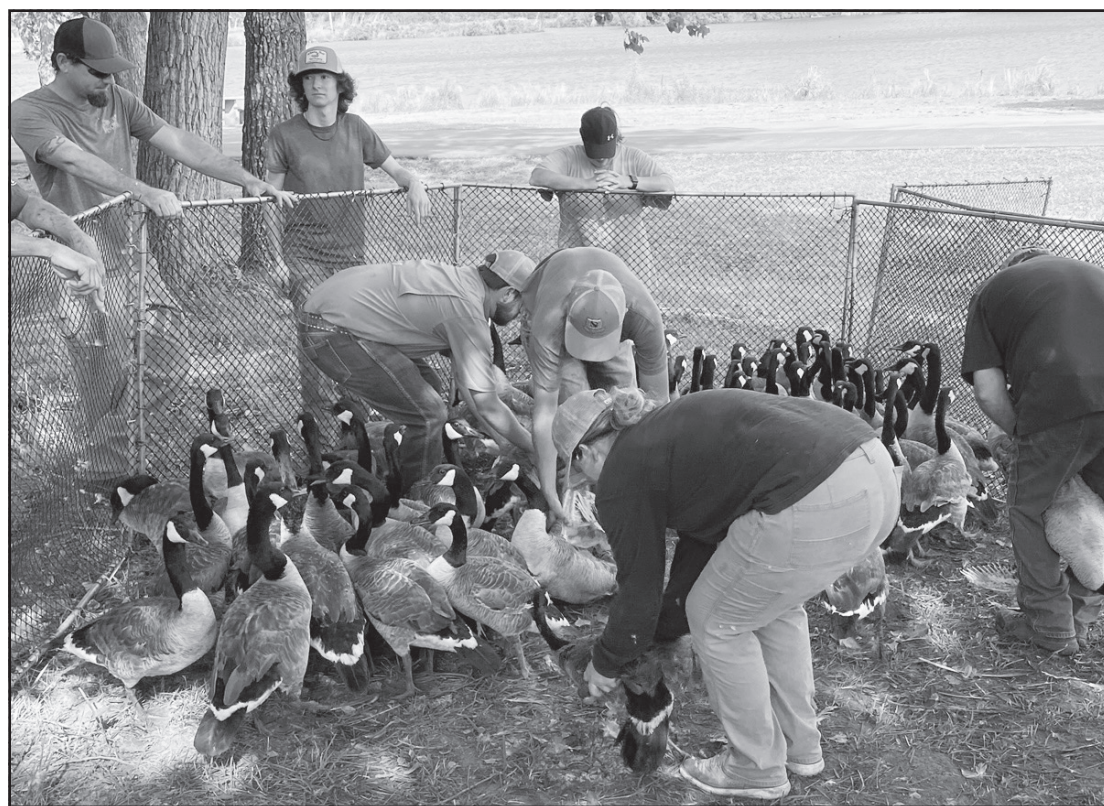
The clothes closet is now located in the former Purcell High School/Junior High Building at Apache and Green.

# Should we fear COVID variants?

A COVID-19 variant that appears more contagious than the earliest strain of the virus is increasingly circulating in the U.S. But is the mutation something to fear?

Only if you're unvaccinated, say experts at the Oklahoma Medical Research Foundation.

"Viruses mutate to survive," said OMRF immunologist Eliza Chakravarty, M.D. "Becoming more transmissible is helpful from an evolutionary perspective. But with vaccines, we can mount a defense we didn't have last year."

The U.S. Centers for Disease Control and Prevention has classified the delta variant, first identified in India, as a "variant of concern." The CDC gave the mutation that now accounts for more than 20 percent of new infections in the U.S. the designation based on growing evidence that the variant spreads more easily and causes more severe cases of COVID-19 when compared to other variants.

The variant's prevalence has more than doubled in recent weeks. What started as a seemingly small percentage of cases doesn't mean small danger for a virus that has claimed more than 600,000 lives in the U.S., said OMRF physician-scientist

## Know how horses respond to hot summertime temperatures

Equine owners would find life easier this summer if their horses could communicate as well as Mr. Ed from the popular 1960s television sitcom. The talking equine always had something to say; real horses require closer attention to understand their signals.

During the hot summer, for example, it is the responsibility of the equine manager to ensure horses are drinking enough water to maintain good health and performance, and to know when to back off an animal's level of activity, said Kris Hiney, Oklahoma State University Extension equine specialist.

"Add the values of the temperature and humidity to get the heat index when determining whether to reduce animal activity," she said. "Depending on the environmental temperature and the animal's workload, it is possible for a horse to become dehydrated in as little as two to three hours."

Complicating matters, horses

may not drink enough even when provided water, Hiney said.

Like humans, horses dissipate most of their excess body heat through sweating. When a person sweats, the electrolyte concentration goes up in the blood, resulting in thirst. A horse's blood does not increase in electrolyte concentration with sweat loss so the animal may experience a reduced stimulus for thirst.

Studies show horses will cool themselves normally – unless dehydrated or fatigued – if the heat index is less than 130. A heat index that exceeds 150 will require more assistance in cooling. If the heat index exceeds 170, consider a different activity, Hiney said.

To enhance evaporate cooling, apply cool – not cold – water to areas that have large blood vessels near the surface such as the inside of the legs and the neck, said Dr. Rosslyn Biggs, OSU Extension veterinarian and director of continuing education for the university's College of Veterinary Medicine.

"Water temperature is key," Biggs said. "Cold water can result in vasoconstriction which can limit blood flow to the horse's skin. Continuous running water also has been shown to cool the horse faster. If a hose is available, keep applying water to the horse."

Convection – heat that is lost due to air movement – is another major way that an animal loses heat. Supplying fans or keeping the horse in an area with wind flow is ideal. Fans with higher velocities provide more effective cooling.

Also, take advantage of conductive cooling, wherein a horse will transfer heat through space to any object cooler than it. For example, standing under trees allows a horse to radiate some heat to leaves, which are continually cooled by their own evaporation.

Long trips may require schedule changes to avoid the hottest time of day, Hiney said, and the muscle work of balancing in a trailer during a road trip can put an additional heat load on a horse.

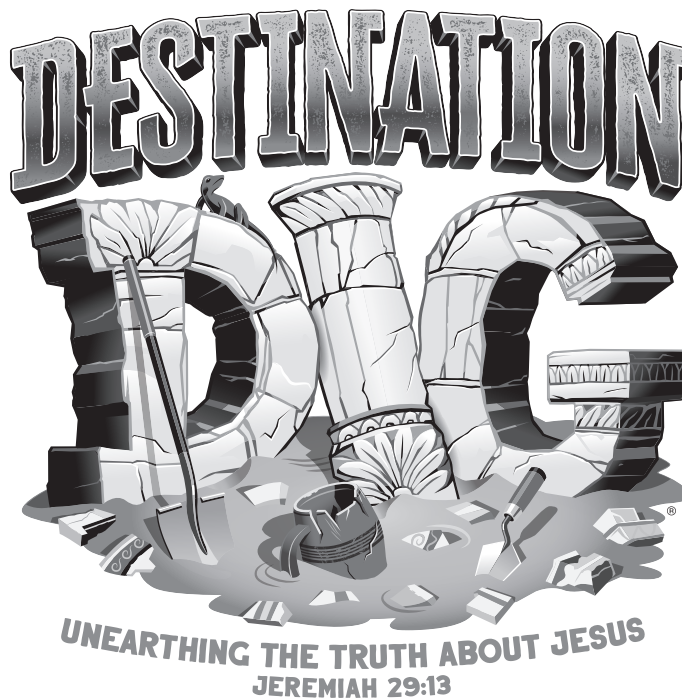

## Medical care, American dream or nightmare?

Until recently my wife and I paid over \$2,000 a month for medical insurance. We each had a \$6,000 deductible. One year we both had procedure's which meant we had \$12,000 in out of pocket expenses.

There were also some other "uncovered" medical costs throughout the year which resulted in over \$40,000 in medical insurance and out of pocket costs. The procedures themselves of course cost far and above what our out of pocket expenses were.

Most likely if we had not had health insurance the doctors and medical facilities would not have performed them.

In America, you have to have medical insurance or the means to cover the costs of your healthcare.

For the average American \$40,000 in medical costs in one year means an eternity of debt.

The prospects of such makes average Americans shy away from medical care they need.

Unaffordable medical care is not an American dream. Honestly, for too many Americans it's a nightmare.

A business owner recently told me, "I pay for insurance for my employees but it's barely enough insurance to meet the legal requirements for our business. It's terrible insurance. It pays for almost nothing and no one with our insurance would ever want to go to the hospital."

This is tragic as all Americans need good medical care. However, the insurance companies in America are making billions in profit. The way they make profit is by denying to pay for something you need.

The health insurance industry had a "net" profit of 22 billion dollars in 2019. Businesses need to make profit, but Americans need medical care, not denial

and medical debt that leads only to serious anxiety for Americans.

"If you are buying an ACA (Obamacare) plan as non-subsidized health insurance for a family of four, you can expect to pay about \$25,000 for the year in premiums and deductibles. That breaks down to an average of \$17,244 in annual premium cost for health insurance for families of four and \$7,767 in deductible expenses.

If you qualify for a subsidy this will certainly help but just the out of pocket deductible can make healthcare daunting for most." (ehealthinsurance.com)

Healthcare is a major component of financial security. Financial devastation is lurking around the corner for any American who does not have a good medical care safety net.

## NEWS FROM CAPITOL HILL

### A national crime crisis

For more than a year, dangerous crimes in cities across the country have spiked tremendously, and Americans have watched their communities become less and less safe.

Even more worrisome, crime is expected to get worse in the coming months as budgets for police departments are continuing to be cut and dangerous rhetoric against our brave men and women in blue is spread.

Last year, 63 of the 66 largest police jurisdictions saw increases in at least one category of violent crimes, according to a report from the Major Cities Chiefs Association. This comes as the same big cities were cutting funding for and dismantling their police departments. We also saw police recruiting suffer and many officers resigned due to anti-law enforcement activism across the country after the horrific death of George Floyd last May.

Just last month, Jack Rinchich, president of the National Association of Chiefs of Police, claimed that departments nationwide have struggled to retain and recruit police officers due to their demoralization. It is virtually impossible to

keep communities safe when there are not enough law enforcement officers to do so.

The fact that the U.S. Justice Department has also taken a relaxed approach to crime and keeping bad actors off the streets does not help either. For months, dangerous criminals took over and destroyed cities like Portland and Seattle.

Today, we are seeing cases against these same people being dropped. The Biden Administration must show that they will be tough on crime.

Last week, President Biden addressed our nation's crime crisis in a press conference, where he blamed it on law-abiding firearm owners.

However, just this January, the FBI's National Instant Criminal Background Check System completed more than four million background checks, marking the start of 2021 with the highest number of checks conducted in a one-month period.

This shows that America's background check system works, and Americans are buying firearms from licensed dealers. President Biden cannot blame this on lawful gun owners and must take responsibility for his party's destructive messaging

and failed liberal policies such as "Defund the Police."

Furthermore, President Biden and Democrats are also supporting efforts, such as the George Floyd Justice in Policing Act, that would tie the hands of police officers nationwide and enforce one-size-fits-all solutions.

While Republicans and Democrats agree that police reform is necessary, federal legislation must ensure that good officers can do their jobs effectively, while protecting themselves and others.

After many conversations with police chiefs across the Fourth District, I know firsthand that they are in favor of reforms that will make policing more accountable.

However, we cannot limit the ability of police officers to protect themselves and the communities they serve.

The United States is a country of law and order and during the crime crisis our nation is facing, the president and leaders of these cities should not be turning a blind eye to crime and disorder.

Ensuring safe communities is not a right versus left issue and should be a top priority for all lawmakers at federal and local levels of government.

## Not for the people

### Democratic election bill

Senate Democrats are once again trying to push through their massive federal election takeover bill, S. 1/H.R. 1, the "For the People Act." S. 1/H.R. 1 takes authority away from Oklahoma and gives Washington, DC, the power to manage and control our elections.

This DC power grab is a horrible idea, and I will vote against it. The Constitution is clear that states run elections.

It may surprise you to know that both the left-leaning American Civil Liberties Union and the conservative Heritage Foundation have come out in opposition to S. 1/H.R. 1. It's rare that those two groups are on the same page, but they both oppose this terrible bill.

S. 1/H.R. 1 guts voter ID laws, despite wide support for them across the country. The bill allows unlimited ballot harvesting, which makes it possible for political parties to collect ballots. S. 1/H.R. 1 mandates ballot drop boxes without any security protocols and restricts states' ability to maintain accurate voter rolls. Additionally, the bill lines the pockets of candidates with federal dollars by creating a six-to-one federal funding match for small donations of up to \$200. This is welfare for politicians and millions of our hard-earned tax dollars for political candidates you do not support.

I remain firmly opposed to S. 1/H.R. 1 and any legislation that takes elections out of the hands of Oklahomans. Oklahoma does a great job administering free and fair elections, where it is easy to vote and hard to cheat.

Recently, Senator Inhofe and I received a letter from Oklahoma State Election Board Secretary Paul Ziriaux. He shared his concerns with S.1/H.R. 1 and his support for Oklahoma continuing to run our own elections. Secretary Ziriaux is a credible and trusted election security professional who continues to ensure voting in Oklahoma is easy, fair, and secure. His policy concerns with S.1/H.R. 1 should not be dismissed by anyone interested in free and fair elections.

Oklahoma's simple and straightforward election process uses paper ballot backups to ensure we can audit and have confidence in our election results. It's not complicated. Our election results are usually available in the early evening hours

## Legislative session adjourned, but work far from being done

The legislative session has adjourned, but our work is far from done. The four-month session is a culmination of all the work done during the previous interim.

While we just passed the Fiscal Year 2022 budget, work is already underway on the FY’23 budget. Leaders and staffers are studying economic trends and agency budgets to see what will be needed next year. The FY’22 budget starts July 1 with the new fiscal year.

Besides budget work, the Senate and House are also getting ready to start interim studies. Since session adjourned a month ago, we’ve been meeting with constituents and advocacy groups about what issues they’d like to see addressed next session as well as to hear their concerns about legislation passed this session.

With only four months to consider thousands of pieces of legislation, we simply don’t have time to take deep dives into more complex issues that may require legislative solutions to resolve. Therefore, we have interim studies, which are in-depth meetings that can last a few hours up to several days if necessary.

They include expert testimony as well as input from citizens on how they’ve been impacted either negatively or positively by those issues. Having all these different perspectives helps members have a well-rounded understanding of these areas and how any changes might impact citizens, businesses, and the state.

This year, I’ve requested 10 studies that are currently under review by the Senate President Pro Tem. He’ll be announcing the approved list of studies in the next couple of weeks.

If approved, it is then up to the chairperson of the assigned committee whether a hearing will be granted.

My requests include a wide range of policy issues. I’d like to look into Oklahoma’s Advantage Waiver Program to ensure it is appropriately caring for recipients as well as mental health and criminal sentencing to see if mental health diagnoses are being considered during sentencing hearings.

Foster care reform is another area I’d like to look into. I want to research if our state has an ap-

propriate number of foster care homes and if they’re equally distributed throughout the state, and if bonding assessments should be used in child welfare cases.

In this same arena, I’ve requested a study to determine if our state has enough child welfare workers to properly meet the needs of Oklahomans. Another study request would examine if jury trials or non-jury trials are the most effective in handling child welfare cases.

As for healthcare reforms, I want to look at insurance payment disparities between urban and rural providers and see if this creates gaps in services.

I’d also like the legislature to study various provider settings in the state and nationwide to determine why Oklahoma’s healthcare facilities are inadequately staffed.

My last two requests deal with education and liability and property insurance. I’d like to review where state scholarship dollars are being sent for private school funding and help parents be able to compare/contrast school achievement as well as graduation and attendance rates at public, charter, online and private schools.

Finally, I’ve asked for a study to compare industry insurance options, such as healthcare, schools, etc. and determine if adequate resources are available.

Interim studies are public meetings, so citizens are welcome to attend in-person or watch live on the Senate website at [www.oksenate.gov](http://www.oksenate.gov). I’ll let you know what studies are approved.

They must be completed by November, so we have plenty of time to decide whether to file legislation based on our study findings. We then must submit our bill requests in early December, and Senate staffers will begin further researching and drafting those bills. A lot of work goes into the thousands of bills filed each session.

As always, I look forward to hearing your ideas and concerns on legislative issues. Please don’t hesitate to contact me.

two will be funded at the full requested amount.

Cole requested \$72 million, the largest of the Oklahoma delegation’s requests, for the I-35 widening project in Love County. Love County includes I-35 from the Red River to the Lake Murray exit in Ardmore. The Oklahoma Department of Transportation is partnering with the Texas Department of Transportation on widening the corridor between the states.

“So, our understanding is that the earmark funding can be put toward any one of those projects,” said a spokeswoman for the Oklahoma Department of Transportation.

This area includes Winstar World Casino, located on the Chickasaw reservation. Cole is a member of the Chickasaw Nation, which sits two miles north of the state line.

The congressman only received \$17.12 million for I-35 widening of the \$72 million that he requested.

Both Reps. Kevin Hern of Tulsa and Markwayne Mullin of Westville declined to submit projects for the bill. Hern has been outspoken about his opposition to earmarks in the past, and stated that he wanted to read the transportation bill in its entirety before deciding how he wanted to vote.

Republicans have objected to this bill because they believe that the bill would be used to advance the Biden agenda.

“Despite a narrower margin of power and the President’s call for bipartisanship, the Majority never seriously considered incorporating Republican priorities and reaching a compromise,” said Rep. Sam Graves (R, Missouri), the ranking Republican on the committee.

“So we are left with another bill that lets lengthy road and bridge project delays continue eating up precious resources, handcuffs our state and local partners, leaves rural communi-

ties behind, and prioritizes the Green New Deal to an extent that cripples the real infrastructure improvements communities across the country need.”

The legislation differs from an appropriations bill now making its way through the House committee that contains more than \$95 million in district projects proposed by Bice, Cole and Lucas.

The purpose of this bill is to replace the Surface Transportation Bill, a five-year project plan signed into law back in 2015 by President Barack Obama, and extended by one year due to the COVID-19 pandemic. The 2015 law will have to be extended again if Congress cannot come up with a new bill for President Biden to sign.

Bice’s approved projects are:

- Edmond—Bridges on I-35 at Interchanges between Memorial and 2nd Street, \$10 million.
- Oklahoma City, I-35/I-240

Interchange, \$10 million.

Cole’s approved projects are:

- Love County—I-35 Widening in Love County, \$17.12 million.
- Midwest City—S.E. 29th Street Bridge Replacement and Repair Project, \$2.88 million.
- Lucas’s approved projects are:
  - Boise City—US-287 Road Improvements from Boise City north to Colorado (Ports-to-Plains Corridor), \$3.25 million.
  - Clinton—I-40 and Exit 65 Road Improvements in Clinton and Custer County, \$3.25 million.
  - Kingfisher—SH-33 from Blaine County line east to SH-74, \$3.25 million.
  - Watonga—US-270 Road Improvements between Watonga and Seiling, \$3.25 million.
  - Durham—SH30 from SH33 N. 2 miles in Roger Mills County, \$2 million.

- Adults should actively supervise children and stay within arm’s reach of young children and new swimmers. Kids should follow the rules. ## TSET research investment yields additional funding

In addition to funding innovative science that will save lives in Oklahoma and across the world, research investment by the Tobacco Settlement Endowment Trust (TSET) has brought more than \$450 million in additional research funding to the state over the last decade.

"Funding research to prevent and combat cancer and other tobacco-related diseases is a key part of TSET's constitutional mandate," said TSET Executive Director Julie Bisbee. "This vital work is saving lives in Oklahoma and elsewhere, as well as attracting top-tier researchers and outside grant dollars to our state."

TSET funds research through grants that support the Phase 1 Clinical Trials Program at Stephenson Cancer Center, the TSET Health Promotion Research Center, and the Oklahoma Center for Adult Stem Cell Research.

With TSET support, Stephenson Cancer Center (SCC) has developed into one of the nation's leading cancer clinical trials centers. Since 2012, more than 1,700 patients from Oklahoma and 17 other states have participated in early-phase clinical trials open through the TSET Phase I Center. Those clinical trials give Oklahomans access to cutting-edge treatments close to home.

Major pharmaceutical companies – including Amgen, Astrazeneca, Bayer Health, Eli Lilly, GlaxoSmithKline, Merck, Novartis, Roche and Pfizer – now choose Oklahoma and the SCC as a site for conducting their clinical trials. Since 2012, that work has brought more than \$78 million pharmaceutical research dollars to Oklahoma.

In addition, with TSET support, the SCC has recruited 64 new faculty researchers to Oklahoma since 2012. These 64 new investigators brought more than \$34 million in out-of-state grant funding to

Oklahoma. Since arriving, they have received additional grant funding of more than \$110 million.

With all funding sources combined, TSET support has directly contributed to leveraging over \$223 million in additional research grant and industry contract dollars between 2012 and 2020.

In addition, SCC is affiliated with the TSET Health Promotion Research Center (HPRC), which has a mission to reduce the burden of disease in Oklahoma by addressing health risk factors such as tobacco use, sedentary lifestyle, poor nutrition, and risky alcohol and other substance use through research and development of new intervention tools and techniques.

For every TSET dollar awarded to HPRC since 2016, researchers have obtained an additional \$2.56 in grant funding from other sources. TSET support has led to an additional \$56 million in grant funding to HPRC investigators since 2016.

The Oklahoma Center for Adult Stem Cell Research was founded in 2010 to promote research in the field of adult stem cell biology and regenerative medicine. Since then, OCASCR has helped recruit 30 scientists to Oklahoma with expertise in diabetes and obesity, heart disease, lung disease, cancer, premature births and autoimmune diseases.

In 10 years, OCASCR has leveraged around \$25 million in TSET funding for more than \$175 million in additional grants from other sources.

"TSET researchers are exploring new ways to improve health and combat addiction," said Michelle Stephens, chair of the TSET Board of Directors. "At the same time, TSET support is bringing new investment to Oklahoma and creating a nationally recognized research hub that benefits institutions statewide."

## Skunks can cause more than smelly problems

The nose knows. Even the slightest hint of a skunk's presence can send pet owners scrambling to find a way to get rid of the scent.

But it isn't just the odor that is cause for concern. Skunks are the primary reservoirs of rabies in Oklahoma, followed by bats, said Dr. Barry Whitworth, Oklahoma State University Extension veterinarian.

When it comes to rabies, Whitworth said, "an ounce of prevention is worth a pound of cure."

"Economically, it's much cheaper to prevent disease than to treat it, and disease prevention is better for the animal. Some diseases, including rabies and canine distemper, usually are fatal," he said.

Oklahoma recognizes one- or three-year vaccines; however, local governments may have ordinances that require yearly vaccines. Small pet owners need to consult a veterinarian about which rabies prevention vaccine is best for

their location. In addition, pets should be seen at least once per year for a general checkup.

Rabies clinics often take place in the spring or early summer because that's when skunks are more active.

However, Whitworth said dogs and cats should be vaccinated for rabies based on the age of the animal, not necessarily the time of year. In small animals, that is usually at three months of age with a booster for 1-year-olds.

"Rabies can present in a couple of ways. First is the aggressive form most people recognize, the typical 'mad dog.' Animals with this form will be aggressive, hypersalivate, vocalize and wander," Whitworth said. "The second form is the paralytic or dumb form, which often isn't recognized by pet owners. These animals appear to be in a stupor, and the infection is seen in wild animals that people encounter."

In such cases, the rabid

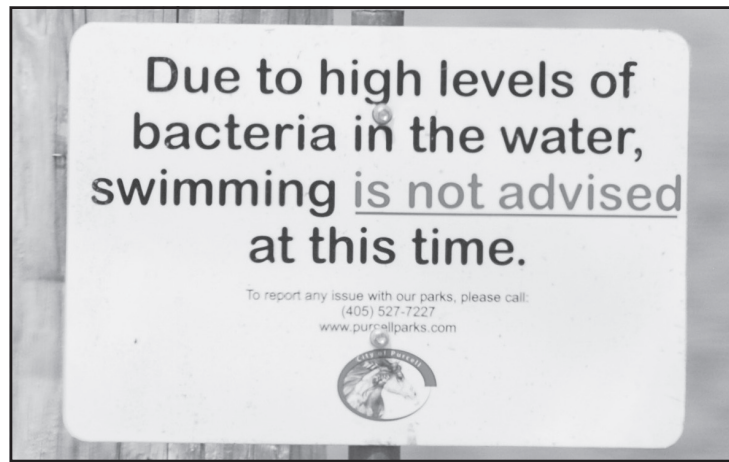

## OSDH adds ‘Will Call’ to vital records services

The Oklahoma State Department of Health (OSDH) announced that beginning on Tuesday, July 6, Vital Records lobbies in the state will offer a Will Call service, giving people the option to pick-up orders placed online for birth and death records in-person.

According to Oklahoma Vital Records Director Kelly Baker, this new service offering will result in quicker turnaround times for records requests.

“We closed our lobbies to the public last year due to the pandemic, but have learned from that experience that we can serve Oklahomans faster and more efficiently with an online approach,” Baker said. “Complete online orders can typically be processed in two days and then either placed in the mail or made available for pick-up at Will Call.”

Will Call applicants will receive two emails – one to

confirm the order was placed and a second to confirm the record is ready for pickup.

OSDH offers three Vital Records Will Call-only locations where people can pick-up their online and phone orders for birth and death certificates: Oklahoma City, 375 N. Broadway Ave., Plaza 321; Tulsa, James O. Goodwin Health Center, 5051 S. 129th E. Ave.; and McAlester, Pittsburg County Health Department, 1400 E. College Ave.

People can order online or by phone (877-817-7364) with our partner VitalChek, and choose between receiving records by mail or pick-up at Will Call within two business days. Records which require amendment or other action will take longer to process.

## Variants:

Hal Scofield, M.D.

“The delta variant appears prime to become the dominant coronavirus strain in the U.S., as it is now in the United Kingdom and India,” said Scofield, noting that the variant is striking teens and young adults with increasing speed. “For communities with low levels of vaccination in Oklahoma, this could mean serious trouble come fall.”

There is good news for the fully vaccinated, Scofield

said. In a study published in May, researchers in the U.K. found that a two-dose regimen of the Pfizer vaccine was 88 percent effective against symptomatic Covid-19 from the delta variant.

CDC officials anticipate similar results for Moderna's vaccine. And the effectiveness of Johnson & Johnson's one-dose shot appears only slightly lowered — 60 percent, vs. the 66 percent seen in clinical trials — against

the variant.

Despite this, in the same U.K. study, scientists found that one dose of the Pfizer vaccine is just 33 percent effective against the virus.

“It's a reminder of how critical full vaccination is,” said Chakravarty. “If you are unvaccinated and waiting to see whether there will be a spike in cases before getting your shot, or if you've delayed in getting your second dose, the time to act is now.”

Although infections of COVID-19 are rare in fully vaccinated people, Scofield said that testing should remain top of mind to track the progression of the delta variant in the state.

“If you're vaccinated, we're on the cusp of returning to regular life,” said Scofield. “But if you're sick with symptoms such as coughing, fever and difficulty breathing, you still need a COVID test.”

## Skunks:

animal isn't afraid of people; nocturnal creatures will be seen more often during daytime; and in some cases, the infected animal will approach humans or try to get into their homes. Unfortunately, this is when people most often get exposed because they don't realize the animal is sick.

"It's important for pet owners to realize rabies is almost always fatal and that's why vaccines are so important. Experimentally, animals have survived the disease, but treatment isn't practical in clinical settings," he said. "The dangers to veterinarians and staff don't warrant treating animals."

Rabies aside, what should pet owners do if a furry friend has a skunk encounter and comes out on the smelly end of things? Although getting a dog inside the house and into a bathtub might seem like the obvious solution, it's best to keep the pet outside, said Dr. Rosslyn Biggs, OSU Extension veterinarian and director of continuing education for the university's College of Veterinary Medicine. Scent molecules spread from surface to surface and stick around.

"Skunk spray is produced by

the anal glands of the skunk to defend against predators and contains sulfurous chemicals called thiols," Biggs said. "The best recipe for getting rid of that smell is a mixture of food-grade hydrogen peroxide, baking soda and liquid soap."

In a bucket, mix four cups peroxide, one-quarter cup of baking soda and two teaspoons of liquid soap. While the mixture is still bubbling, apply it to the dog's dry coat, taking care not to get it into the pet's eyes or mouth. Lather and rub the mixture into the coat and skin for about five minutes or until the smell starts to dissipate.

To de-skunk the face and ears, apply the mixture with a sponge, making sure to cover the dog's chin, cheeks, forehead and ears. Rinse thoroughly, making sure to tilt the dog's head upward to avoid getting the solution into its eyes and mouth. This process may need to be repeated.

Biggs stressed that a horrible odor is still not as problematic as rabies, however.

"If you suspect your pet has been bitten by a rabid animal, contact your veterinarian immediately," Biggs said.

## Drugs:

alleged that he, using contraband cell phones from his prison cell, organized and led a conspiracy to distribute methamphetamine throughout Oklahoma and surrounding states. Officials said he allegedly relied on a network of individuals outside of prison to distribute methamphetamine, collect proceeds from that distribution and launder those proceeds. The Superseding Indictment alleges that one of those individuals assisting Mr. Wilson’s activity was Deanna Wilson. It is alleged that she accepted large sums of drug proceeds from him and used those funds to purchase various assets, including a \$138,000 manufactured home, purchased with cashier’s checks and cash. If convicted on the drug trafficking charges, Chance Wilson faces a potential penalty of at least 10 years and up to life in prison and a fine up to \$10,000,000. If convicted on the money laundering conspiracy charge, they each face a period of imprisonment of up to 20 years’ and a fine of up to \$500,000. If convicted of engaging in a monetary transaction using drug proceeds, Deanna Wilson faces a period of imprisonment of up to 10 years, a fine of not more than \$250,000 or a fine of twice the value of the property involved in the transaction whichever is greater. The case is a result of an investigation conducted by Homeland Security Investigations, the Internal Revenue Service – Criminal Investigations and the Oklahoma City Police Department. Assistant U.S. Attorney Tom Snyder is prosecuting the case.

with the speed of the bridge replacement between Purcell and Lexington, however. That work was fast tracked. Rather, actual construction is still four years out – sometime in 2025. In the meantime, there are the preliminaries that precede the actual plans. In fact, the Oklahoma Department of Transportation is just three months into an environmental impact study – a study that can take up to a year to complete. If an environmental concern is found, it could scuttle the whole project, according to city manager Dale Bunn. Bunn said the study will take into account anything historic or buried, as well as endangered species. None is anticipated, but the possibility exists. One concern now is OGE lines to the west of where SH 74 passes beneath the interstate. The options are moving the lines or design ramps beneath them. At present, it’s still up in the air where the ramps will be located and how many there will be. In an online survey, residents preferred a total of four ramps.

Carli, who will be in the eighth grade, showed sheep last year and earlier this month competed in her first cattle show, bringing home a second and a third. Carter missed the cattle show after making the all-star team in his baseball league. He will be in seventh grade. Last week Erica met with Purcell FFA officers, some of whom left Sunday for a leadership camp. “They are kind of excited to get back out,” she said. The chapter currently has six officers, but there are openings for new posts. Interviews for officer candidates will be in August. It may be summer break, but for Erica the preparations for a new school year continue. Always with a central goal: “investing in my students to help prepare them for life.”

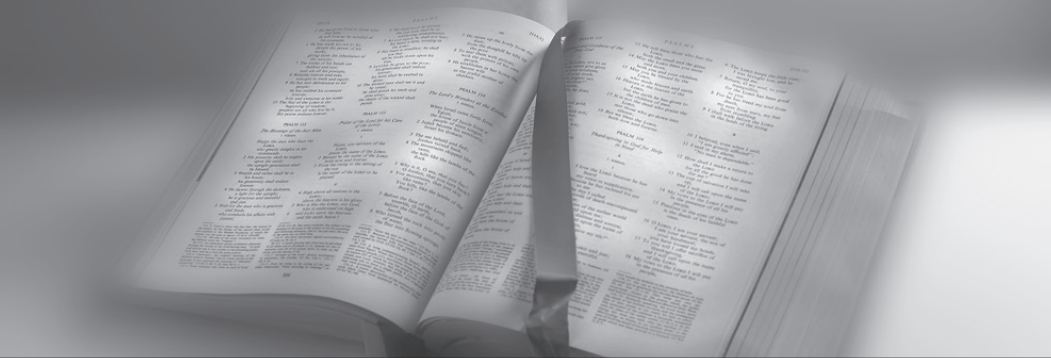
A person could figure he'd get to that question down the road when he has time to think; but, truth is, it's not a question you can put off for later. With faith,

This coming weekend, we Americans will be honoring our country on the 4th of July. On this day we remember it as Independence Day (July 4, 1776) when a group of men in our country signed a proclamation, a Declaration of Independence, that the 13 original colonies no longer recognized

themselves as being governed by England. [I hope this is an adequate description!]

As a part of that celebration, we recognize those who died in the Revolutionary War (and other conflicts in our history) who fought for our freedom as a “stand alone” country. We take a lot of pride in this freedom and think of ourselves as especially chosen by God.

Yet, in all disagreements, all factions feel that God is on their side, no matter what religion, color, or nationality they may be. If we’re honest about it, most wars are fought not for ideals or principles but for political stances, national economics, or religion. Examples include whether the Christians or Muslims or Jews are the only “right” religion and that God chooses to support only one of the groups.

We need to remind ourselves that all humans are God’s children and that God loves us all the same. God loves Iraqis the same as any other nationality, whether it be the Syrians or us Americans. God loves Jews the same as Christians, God loves Republicans the same as Democrats, and God loves Methodists the same as Baptists! \*grin\*

One of my favorite hymns is “This is My Song” (page 437 in the The United Methodist Hymnal published in 1989). It usually brings tears to my eyes when I read or sing it. The words were written around the mid-1930s.

This is my song, O God of all the nations, a song of peace for lands afar and mine. This is my home, the country where my heart is, here are my hopes, my dreams, my holy shrine; but other hearts in other lands are beating with hopes and dreams as true and high as mine.

is within all of us either a will to believe, or there’s a will not to believe. Some choose not to because they can’t seem to be able to wrap their minds around the Bible’s teachings. As young people step into the classrooms of what we call higher education, they are about to hear many skeptics stand in front of them with world views that are a mile and a half from the Bible.

So, I’ll be the first to say in regard to biblical reliability: There’s plenty of biblical, historical, literary, scientific, and archeological evidence to support faith in the Bible. But, as is attested by some of those intellectuals who will stand before you, if a man doesn’t want to believe he can find enough “evidence” otherwise to talk himself out of it. (If you need some shoring up in that area, pick up any book by Lee Stroebel or Josh McDowell. Even better, roll your sleeves up and spend some serious time in the Bible. That’ll do.)

By the way, in case someone decides to just remain neutral, I’ll tell you that, unfortunately, you can’t accept the lovely Rose of Sharon and reject the validity of the Bible. The two will have to go together.

But what we’re talking about here is not just a decision to believe or not to believe in the Bible and Jesus of Nazareth. It’s more of a decision to live

it or not to live it. That’s what it comes down to. To live it is going to make you choose not to go to certain places and hang out with certain people, and it’s going to demand that you ‘be’ a certain kind of person.

It won’t take you long to figure out that it isn’t just something hidden away in the back roads of your mind, something that you don’t really have to use. People sometimes try that; but your faith sits right there on your front porch for everybody to see. It’s not just something up in your head. It’s in your arms and legs, too.

Faith really is a funny thing. Sometimes it feels strong, and sometimes it needs life support. The good news is that even the great men and women of the Bible experience doubts, and they have their share of failures. So why are they considered men of faith? I think it’s because in all their lives, they never lose their will to follow the Lord. They choose faith even when they realize they had just failed in faith.

They skid off of the road from time to time; but they find some way to pull themselves out of that ditch (with Providential help, of course) and to plod on down the road of faith again. That’s what faith looks like, I think.

One of the best pieces of advice I’ve heard comes from an

old Canadian preacher named Lynn Anderson, a preacher Lee Stroebel interviews in his classic book, *The Case for Faith*. Stroebel asks Anderson for a good starting place to developing faith. Mr. Anderson replies that a person needs to surround himself with the right things: the right people, the right reading materials, the right influences, and he needs to go to the right places.

Then he makes it real: “After all,” he says, “if you want to grow roses, you don’t buy an acre at the North Pole. You go to where roses grow.”

“Ah, that’s the key!” I could not help but think when I read that. If you want to walk by faith, you’ll have to go where faith is.

Right now, then, before you take another step out into the world, and before you make the next of the 10,000 decisions you are going to be make in your life, tuck that one point safely down into the corridor of your mind:

If you want to grow faith, you have to go where faith grows. That’ll do.
