As a Gen -X person (those born from 1965-1980), a significant portion of my lifetime, as it pertains to Sullivan County, has been spent working to help Sullivan County make an economic comeback to equal or surpass its best years. Those took place many decades ago.

It has been a tough ride to get where we are today. It was not too long ago that our future looked bleak. Most main streets featured shuttered businesses.

Our unemployment remained steady in the mid-double digits. It seemed everything that was attempted did not take. We have had endless ideas, startups, expansions, and dedicated programs to try to jump start our area economically.

A few worked... most faltered. Yet today we see the fruit of our efforts. Bethel Woods began as an idea and the Gerry Foundation, through the generosity of its namesake Alan Gerry, began a journey whose investment and vision sparked a revival of the Sullivan Catskills as a premier tourist destination.

The Sullivan Catskills Visitors Association, born from the collaboration of public and private sector efforts, has become one of the premier visitors bureaus in the State and has steadily helped grow the Sullivan Catskills to become a

world-renowned destination.

We have secured several signature projects, like Resorts World Catskills, Kartrite, Monticello Motor Club,

PepsiCo, Kohl's, and others, which have generated job opportunities – growing to 3,000+ jobs over the past five years.

The Center for Discovery and other healthcare facilities saw expansion that has made this industry the number one employer in the county. The Center took a defunct facility at the heart of Sullivan County and repurposed it to soon become a beacon, attracting the most sophisticated healthcare professionals from throughout the country to treat the most fragile disabilities in children.

Today, even more investment continues with the recently built Eldred

Preserve, the ever-growing Foster Supply Hospitality destinations, and preapproved sites that will ultimately help diversify our economy.

Our western Sullivan main streets are once again thriving and stable. This has brought Sullivan County from desperation to once again this year, the fastest job growth county in the region, with unemployment in the low to midsingle digits (currently at 3.4%).

So where do we go from here? There are those who think putting up a drawbridge and stopping growth is the answer, fearing change in the utopia they have found or created here.

Even trying to stop projects that are appropriately zoned and exhibit less impact on our environment!

She states that M&H has "truly become a family business" since she joined the Tango Cafe.


"My family has helped navigate the business without me having to be at every event." said Jaycox, "I brought skills from Milk and Honey, AND ice cream, to Tango!"







**¬**he golden shovels, emblazoned hard hats and letters of thanks that grace the walls of Advance Testing's corporate office in Campbell Hall are all a tribute to the high standards which the company was founded on.

Forty years ago, a 27-year-old man by the name of James P. Smith Jr. left his job with Yonkers Contracting / Plaza Materials, where he was Chief Quality Control Technician, to found a company which today is one of the leaders in the field of construction materials testing.

"It was during this time that Jimmy [Smith] decided he could make an impact in the industry by starting his own company," Christopher McCracken, who is the Director of Business Development at Advance Testing said.

So in May of 1984, Jimmy Smith founded Advance Testing with a vision to provide the highest quality services available within the materials testing


The early years were marked by incredibly hard work, as Jimmy drove to New York City in his station wagon to work on a night project reconstructing Manhattan streets, combined with working



day shifts at IBM's East Fishkill campus, often stopping at a parkway rest stop in between assignments to get some sleep.

s a business owner, you are well-served by collecting emails and running an email marketing campaign if for no other reason than to remain top-of-mind with your customers. When they're getting emails from you with exciting news and great deals (who couldn't use those these days?) they'll get used to hearing from you and seeing your name.

But you want to do more than just be recognizable and remain topof-mind. You want your emails to drive purchases. Even if you don't sell online, emails are an excellent motivator and nurturer for in-person purchases—if you can get recipients to open them.

#### The Trick to Email Opens

There are two things that motivate people to open your emails—the sender and the subject line. Additionally, it helps if you're sending them at a time when the recipient isn't overwhelmed by other emails or in a hurry. Sending it when you're not competing for attention is a good thing.

But since it's difficult to know when someone is coming back from vacation or just broke up with their significant other (and so not in the mood to read anything), let's concentrate on what you can control—the subject line.

#### **Examples of Great Subject Lines**

I get a lot of junk and I haven't seen inbox zero in my personal email since I opened the account. But here are a few subject lines that stood out to me this week and why I thought they were great pieces of email marketing.



I'm so sorry Jaime:(

Is that a cliff hanger or what? It's personalized to me, so it doesn't look like a generic email (although it is. She's a fitness guru I follow but don't know personally.) And she somehow thinks she has wronged me. Of course I'm going to open it because...curiosity makes me.

This is not a subject line you can use all the time. Save it for special occasions when you want to get someone's attention. It's perfect if you sent out a notice for a time-sensitive promotion that your recipient didn't take advantage of. You can resend it with this subject line and

copy that reads, sorry you missed this spectacular ...

Then proceed to extend the deal after you've made them wish they could turn back time.

Have you seen these crazy new snack container

Another great example of curiosity driving an email open. What is this new crazy snack container? What could be so crazy about it?

I need to know.

You can use this technique for anything from a new item in your store to a new food you're offering. You can also use it for a trend like "Have you heard about the latest whacky AI tool?"

#### Thorntons Refreshin. Don't miss out! Fill up today and save 15

Nothing like using fear of missing out and a deadline of today. Am I running out to get gas now? I would if I wasn't such a homebody. \$.15 per gallon is a big savings.

Give your audience a deadline and be direct about what you're offering.

I'm sorry Jaime:(

This guy is a very well-paid speaker and speaker trainer. He's not at all buttoned up and stodgy so this tone works perfectly with his audience.

He also uses curiosity to drive clicks. When can I punch him in the face and why would I want to?

You don't have to promote violence in your messaging, but you can say something equally as interesting like "You can buy me a coffee and call me your bestie." Or "If you don't agree, I'll buy you a drink." Everyone will want to know what they should not be agreeing to.

I'm sorry Jaime :(

Dr. Mindy Pelz writes about the importance of knowing your audience. She has a largely female audience as the author of Fast Like a Girl. And what is one problem that seems to plague all of us these days (besides feeling like you have to take out a mortgage when you go to the grocery store)?

A lack of sleep (or insert whatever other common problem your audience faces).

Who couldn't use this? Makes you want to click doesn't it? Finally, while these are fun examples, it's important not to take advantage of your audience. Don't offer them something that they won't get (no promising images of Bigfoot unless you really have them) when they click. Click bait is the worst and it takes advantage of the trust they've extended you.

It will only happen once and then they'll probably never click on any of your other emails.

Have some fun but always deliver on your promises.


