and Wisconsin. Donald Trump ended up carrying those states by razor thin margins and just 47% of the

This year the polls indicate that Trump is once again likely to lose the nationwide popular vote, but the Electoral College is a coin toss. Even a handful of votes cast for the Green Party in states like Pennsylvania and Michigan could put Trump back in the White House, which is certainly not the result that most Green Party

voters are seeking. While it's too late to do anything about the "spoiler" problem this year, there is a simple, solution that can eliminate it in future elections. It's called Ranked Choice Voting. Using RCV, a voter ranks all the candidates on the ballot according to their preference. For example, if a voter prefers the Green or Libertarian candidate, they can pick that candidate as their first choice and then select a Republican or Democrat as their second choice. When the votes are counted, the candidate with the fewest votes is eliminated and the votes cast for that candidate are re-allocated to the voter's second choice. This process is repeated until one candidate receives more

than fifty percent of the vote. Ranked-Choice Voting is not new. It's been around for over one hundred years. It's used in other countries and in scores of municipalities

throughout the United States. Both Alaska and Maine already use RCV to elect members of Congress and in presidential elections.

RCV can be a boon for third parties because it gives voters the freedom to cast a ballot for their favorite candidate without worrying about the "spoiler" effect. With RCV, the true depth of support for policies and positions can be revealed because voters are able to vote with their heart rather than for purely pragmatic reasons. And of course, increased support at the polls could lead to more serious consideration of the ideas and philosophies

espoused by third parties. I suppose we shouldn't be surprised that there are forces opposed to RCV, apparently because it empowers the individual voter. Alabama, Mississippi and Kentucky are among several states that have outlawed Ranked Choice Voting in all elections within their jurisdiction.
