### Scoring Better with your Wedges Part 1

If you want a sure way to lower your scores, practice with your wedges. Chipping, Pitching and Full wedges are used on almost every hole for your average golfer.

Chipping: Chipping is really an extended putt and should be treated as such. If you are only a few feet off the green use the club with the loft you need to get the ball on the green. After it's on the green it should be rolling like a putt.

Sometimes you might chip with a sand wedge if the hole is only 15 feet from where your chipping. If the hole was 50 feet away, use the same method with a lower lofted club. It might be 9 iron

for that shot.

Use a putting stroke with your regular grip and you will see more success. No Wrist hinge is needed in chipping.

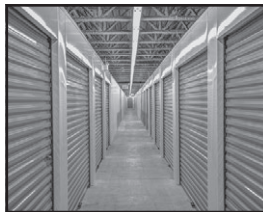
