INSIDE Freedom group plans for 9/11

Veteran Tim Estes of Bedford County works as a defender of freedom and liberty. One of his goals is that no one forgets the Sept. 11, 2001 attacks, especially on the 20th anniversary.

"To me, at my age, which when that happened, I was 36 years old. I look at it as if was the Pearl Harbor of my generation 77 years

So, he and several other veterans and volunteers are planning a special 20th anniversary remembrance 10 a.m. Saturday, Sept. 11, at Shelbyville Central High School Auditorium. The free event will feature guest speaker Jeffrey Johnson, a senior Marine instructor and retired U.S. Marine Corp colonel.

The free program for the community will be sponsored by Defenders of Freedom and Liberty of which Estes serves as treasurer. The group will also be displaying American Flags around town in memory of lives lost that September day.

Organizers note this upcoming 9/11 program will definitely be a handover-heart day-one filled with sadness but also one filled with patriotism.

Putting on his boots

Estes said he was put-

ting on his shoes the day the terror attacks took place at the World Trade Center in 2001. After turning on the TV, upon the advisement of his mom, he really thought a crop duster-size airplane had just gotten off schedule in New York City.

Of course that was not the case. America had been attacked by terrorists.

"When I turned it on, I see one of the towers burning. The news media is trying to figure out what's happening. Within about 6 or 8 minutes of watching it, then we see the other jet fly into the other tower."

That's when Estes says he believes, like the popular 911 Alan Jackson song goes, "the world stopped turning." He was serving in the Tennessee Army National Guard at the time, so he realizes the magnitude of that day and the lasting effects it would have on him but most importantly, America.

"I can't tell you how many days my TV stayed on that coverage," says Estes.

Veteran reflects

Veteran Donnie Porter, also a supporter of the 9/11 event, was in the Air National Guard, stationed in the 118th Airlift Wing in Nashville on Sept. 11, 2001. He was working as

an aircraft maintenance supervisor.

He recalls he was going to a doctor's appointment in Nashville that ill-fated day. He had not even gotten off the base when he heard the news coverage about a plane crashing into the World Trade Center.

"Even the news media was still thinking that it was a small plane, because the word had not spread it was an airliner."

Because he remembered how a small plane had previously crashed into the towers, he didn't think much of the news at the time, he says.

"I was sitting in my doctor's office Oddly enough, my doctor was

Jordanian, a Muslim." He explains there was also a Christian and Jewish doctor on the medical staff, but the Jewish doctor was the one who initially told him the news. There sat Porter in his uniform, unaware what had actually happened - a course of

City, County putting 'best foot forward'

During a quarterly luncheon last Thursday, City and County leaders spoke about the area's growth and infrastructure changes—those designed but yet to come to fruition.

From the County

Bedford County Mayor Chad Graham spoke about his initiatives to give Bedford a better "quality of place"-for the young or old, current resident or prospective resident. The mayor explained this can be done through public safety, education, and economic development.

Graham said one of his main goals is to provide high-speed internet across the county. "Some people cringe when

I say this...but I would argue that broadband, high-speed internet connection, I like to say, is more important than water," he said during the event.

The mayor explained that without

high-speed internet, people are "not

coming to where your water is at if you don't have broadband." In other words, people need that internet connection to live in community.

United Communications sponsored the Thursday event. United Communications CEO William Bradford said the company has invested \$20 million in Bedford, hired 120 local employees, and awarded \$2.5 million-worth of grants to the county in order to bring fiber to the Shelbyville square and businesses throughout Bedford. Graham said, "If we're going to

attract entrepreneurs, business profes-

sionals, millennials—and I believe that's the core of making a difference in our community to strengthen ityou've got to have high-speed inter-Bringing in younger business profes-

sionals, Graham says, will help prevent "brain drain" --a common term used to describe when young people grow up in town, go to college, and then move

Armed robbers hit at residence, store

"Hurry up, I'm not playing," an armed robber told a Shelbyville convenience store clerk Tuesday night while holding a gun in her face. "Give me everything."

The armed robbery at T&M Market, Depot Street, was

one of two reported Tuesday afternoon in Shelbyville. Another was reported around 5:30 p.m. at a residence

police are describing only as "on the east side." Police declined to give more details on that robbery. Suspects in both were described only as "two black males," Detective Sgt. Sam Jacobs of the Shelbyville Police

Department said. Detectives were attempting Wednesday to determine if the same suspects were involved in both robberies. The clerk at T&M Market said one of the men came to

the counter at 8:49 p.m., pointed the gun at her face and demanded "all the money." Another man stood in the doorway, she said. No one else was in the store at the time

Before she could get the cash drawer open, the man demanded she hand over the entire drawer. The clerk did so and the men ran from the store, she said.

"One of the men wore a bandana around his face, only exposing the area around his eyes," Officer Letisia Diaz's report said. "She stated she was too afraid to notice any-

thing but that the gunman was wearing red. Police had not determined exactly how much was taken in either robbery as of Wednesday morning, Jacobs said.

Taliban celebrates victory setting new order in Afghanistan

Thursday, September 2, 2021

KABUL, Afghanistan (AP) — The Taliban reveled in their victory after the American withdrawal from Afghanistan, reiterating their pledge Tuesday to bring peace and security to the country after decades of war. Their anxious citizens, meanwhile, are waiting to see what the new order looks like.

Having humbled the world's most powerful military, the Taliban now face the challenge of governing a nation of 38 million people that relies heavily on international aid, and imposing some form of Islamic rule on a population that is far more educated and cosmopolitan than it was when the group last governed Afghanistan in the late 1990s.

Thousands who had worked with the U.S. and its allies, as well as up to 200 Americans, remained in the country after the massive airlift ended with the last U.S. soldiers flying out of Kabul international airport just before midnight Monday. President Joe Biden defended his handling of the withdrawal, saying the U.S. government had reached out 19 times since March to encourage all American citizens in Afghanistan to leave.

While his blood pressure was being checked, the doctor told Porter, "you better get ready, because you're going to war. We've been attacked."

The doc was right. Porter would eventually be deployed seven times, mainly during Desert Shield, Desert Storm and Operation Iraqi Freedom. This is why he really

has a vested interest in 911 remembrances. "Sadly, we have grown a successive generation," says Porter, "that if you just went out one of these younger people who are reaching adulthood ... what 9-11 mean to them, they would have a blank look on their face."

He encourages everyone to attend the upcoming 911 remembrance program at SCHS. It's a time, he adds, for everyone to put away their cells phones and come out of those closed off social circles to remember that September day.

More than ever, he says he's a firm believer in the phrase that goes back to World War II: "United we stand, divided we fall."

Mom remembers

Cindy Cartwright, who works with Estes and is involved in many veterans' events here, remembers that her son, Sam, now a medical student, was a young boy on Sept. 11, 2001; they watched the events unfold on TV.

She now works with the veterans' groups those which Estes and others have made a post-military career mission. Her son is also now a great supporter of Estes' group Defenders of Freedom and Liberty and works with Estes in the

Vietnam Vet reflects

Roger Wood retired from corporate America in 1999. He was scheduled to play golf the morning of Sept. 11, 2001; he had also enrolled in real estate school at Motlow State Community College in Lynchburg.

This Vietnam veteran says his day started off with leisure time, but ended on a much sadder note, as numbers that night were coming in about those who had lost their lives in the Twin Towers and abroad the aircraft involved.

"I sat there and watched a 737 fly into the World Trade Center . . . second tower. That's when, not only my phone started ringing . . . I also started calling family members, just to say simply, 'I love you' and 'I don't know what's going to

happen."

Wood retired from the military service in 1973. He says he was "in and out" of Vietnam many times before the war officially ended.

He now dedicates a lot of his time veteran services.

While it would be nice to believe that such terrorist attacks are a part of history, Wood notes how he believes terrorists live in America and for that reason, maybe more than ever, patriotism and defense of freedom is a necessity of life.

away to another, usually larger, city because there are more opportunities or because it's a more attractive place to live.

"Some of that is always going to happen," Graham told the Times-Gazette. "But the more we can do to improve our quality of place, the better chance we have of keeping our graduates here in town or attracting the young professionals who would be needed by the high-tech, good-paying industries we're trying to recruit. None of that takes anything away from our existing residents."

Education is one of the platforms Graham promoted that he says adds to "quality of place." For example, the new Tennessee College of Applied Technology-Shelbyville facility, which will be located at the 231 Business Park, will be important in attracting the kind of professionals the mayor and his office want to see in Bedford County.

"It's not about benefitting young people at the expense of an older generation, it's about making the community more attractive for everyone," he told the

Shelbyville City Manager Joshua Ray also spoke about making the Shelbyville-Bedford area a better place to live, work, and raise a family. "The City is in good shape. The City and County together as a partnership is in amazing shape," Ray spoke about the

"I certainly don't have all the solutions, but a conversation within the community deserves to happen," Deeds recently told the T-G.

An owner of the business told police employees sometimes leave their vehicles there with keys inside.

MILDEW ON HEIRLOOM QUILTS

Dear Heloise: I just discovered a couple of handmade quilts that have mildew on the backing. They've been folded up in a closet for who knows how long. They are 50-plus years old and are hand-stitched and not suitable for dry cleaning. Do you have any ideas? I would like to hang these quilts as wall hangings. --Katherine, via email.

Katherine, these are family treasures and look great displayed as wall hangings. Mildew is a common problem; here's how to eliminate it. Mix equal parts of water and white vinegar, and dampen a sponge with this mixture. Lightly press the sponge onto the affected areas to kill the mildew. When the mildew is gone,

air out the quilt. Vinegar should be essential in every home! Also use these hints. Wash only two pillows at a time. Check the ticking to be certain it's strong and the seams sewn firmly, because you don't want to have a washer full of feathers! Then fill the washer with water and gentle detergent, put the pillows inside and wash for four to eight minutes. Rinse in warm water two or three times to get rid of all the detergent. Sept. 11 vs. Pitt

The second game on the slate should be the first true test for the Tennessee offense. The Pitt Panthers are predicted to be in the mix of the ACC. Pitt returns a talented core of offensive players and could be a competitive game for the Vols early on. Newton to Nashville?

Former MVP has intrigue as Titans backup QB

On Tuesday, the NFL had its annual judgement day in which teams had to cut to the 53-man mandate roster and among the roster purges was former NFL MVP Cam Newton as he was cut from the New England Patriots.

Newton, who was drafted by the Carolina Panthers in 2010, led the Panthers to the Super Bowl during the 2015 season and earned MVP honors in the process. But since then, Newton has

been plagued with injuries that led to a pair of shoulder surgeries and a foot injury that ultimately led to his departure from Carolina. Last season, Newton was signed

by the Patriots to a league minimum deal, but a less-than-stellar outing prompted the New England front office to draft a quarterback in 2021. On Tuesday, it was announced

former Alabama quarterback Mac Jones would get the nod and start as QB1 in New England — and that Newton was out of a job.

Why it makes sense

There's zero question that Ryan Tannehill is the leader of the Titans. His resurrected career is nothing short of a phoenix tale that has the Titans poised for a super bowl run, but depth can be a scary thing in the era of COVID. As the Titans found out last

week with several key players, including Tannehill and head coach Mike Vrabel, being quarantined and forced to sit for the preseason finale. Since Marcus Mariota's depar-

ture, QB2 has been a bit of a revolving door for the Titans and truly, the 2021 roster battle was no different. Logan Woodside and Matt

Barkley were the only two quarterbacks on the roster to make an appearance in the preseason finale Barkley threw for 126 yards,

against Chicago. but completed just 7-of-15 passes with an interception. Woodside looked more polished, perhaps to

his familiarity with the playbook, completing 12-of-17 passes for 100 yards, with a touchdown and an interception. The question becomes, can Newton deliver something either

Barkley or Woodside can't? And

the answer is yes.

Newton's game is incredibly diverse, when healthy. He can deliver the ball downfield, but can also tuck and run the ball. Newton's sheer athleticism is

what he hung his hat on for all the seasons in Carolina.

Newton completed 66% of his passes a season ago for more than 2,600 yards, but had just eight touchdowns against 10 interceptions. Where he stands out from most backups is his ability to rush the ball. For New England last season, he ran the ball 137 times for 592 yards and had 12 touchdowns.

This stat alone makes defense play honest and quite frankly, opens the playbook. He's been known to run the

ball perhaps a little more than he should, but imagine a backfield in which Derrick Henry lines up and you have Cam Newton snapping the ball. If Cam is healthy, that's a dangerous combination, should Tannehill be sidelined for what-Another big addition is the

intangibles. Cam is a proven leader and has a magnetic personality. He could be a great locker room

presence and give this team more

personality than it perhaps already

has. Newton is a vocal guy who

isn't afraid to speak up. If healthy, Cam Newton is a more-than-adequate backup and certainly would be ahead of a Logan Woodside or Matt Barkley should Tannehill be

Why it doesn't make

Cam Newton won the NFL MVP during the 2015 season. He truly hasn't been the same since.

He's had two shoulder surgeries and suffered a Lisfranc injury in 2019 that ultimately ended his time in Carolina, following the departure of then-coach Ron Rivera. Newton posted his most accu-

rate passing season in 2018, completing nearly 68% of his passes for just short of 4,000 yards. But injury struck and he finished his season on the sideline.

In 2019, when he suffered his Lisfranc injury, his ability to run the ball became somewhat diminished. He appeared in just two games. Since then, it's been a

mixed bag of results. Surely the potential of a career resurrection is there, but we're talking about a backup role for the former MVP, not a primetime

Titans add Jones, revamp defense

NASHVILLE — The Tennessee Titans have made clear that five straight winning seasons, three playoff berths and one AFC South title simply aren't enough.

Not this season.

Reaching the Super Bowl for the first time in 22 seasons is squarely in the Titans' sights for the 2021 season. Coach Mike Vrabel isn't shying away from the lofty goal for a franchise that has reached the league championship only once in

its history. "Our job is to continue to raise expectations for our football team, for our coaching staff, for just our entire organization," Vrabel said. "That is what we have been charged to do, that is our job. There is a plan to

doing that." The Titans see no reason why they can't contend for the AFC championship, a game they lost in Kansas City in January 2020. They have Derrick Henry, the AP NFL Offensive Player of the Year and back-to-back NFL rushing champ and Ryan Tannehill who helped Tennessee rank fourth in scoring last season.

Tennessee ended one drought last season, winning the AFC South for the first time in 12 seasons. But the Titans lost in the wildcard round when Baltimore found a way to smother Henry and the offense.

That's why general manager Jon Robinson traded for Julio Jones, hoping the seven-time Pro Bowl wide receiver can help Pro Bowl receiver A.J. Brown provide balance. Robinson also revamped a defense that was among the NFL's worst in several categories last season with six new

"Being able to win the division was good, but that is not why we compete in this game," Tannehill said. "It's not to win the division. It is a step, but ultimately it's

Henry became the first to lead the NFL in rushing in back-to-back seasons since LaDainian Tomlinson in 2006-07, he also was the eighth man to run for at least 2,000 yards. Nobody in the NFL has carried the ball as much as Henry the past two seasons, and the Titans limited his work this preseason to keep him fresh as possible.

Asked about his motivation for this season, Henry made clear he remembers being held to 40 yards on 18 carries.

"You're only as good as your last game, and that's the last time I played," Henry said.

Ida sends Saints on the road

The New Orleans Saints will play their season opener in Jacksonville after being displaced by Hurricane Ida.

Instead of playing in the Superdome for the Sept. 12 opener against the Green Bay Packers, the Saints will host the game at the home of the Jaguars, the NFL announced Wednesday.

While the Superdome appears to have been spared significant damage from the powerful Category 4 hurricane, there are logistical challenges with staffing an NFL game there in the near future because of the widespread damage in the New Orleans area.

"I am proud of the collective communications that occurred between many entities in a short amount of time that led to us making this decision," said Saints owner Gayle Benson. "It is never easy to make a decision that involves not playing a Saints home game in the Caesars Superdome, but I am confident that this is the right decision for our city at this juncture."

The Saints evacuated before the storm to North Texas, and have practiced this week at AT&T Stadium, the home of the Dallas Cowboys. They are remaining in Texas for workouts next week, and will travel to Jacksonville the day before the season opener.

Penny Hardaway believes the new name, image and likeness rules helped him land another top recruiting class at Memphis.

Hardaway said Tuesday the NIL rules helped ease the strain on players weighing their options between earning money by going to the NBA's G League or going to college. Now Hardaway can add NIL options when aggressively pitching himself, his staff and what he's building at his alma mater.

"You can come to college now and and get deals for yourself and learn and develop at the same time," Hardaway said. "You don't have to go to any other level to get that."

Hardaway, who had his first No. 1 recruiting class in 2019, lost five-star guard Jalen Green to the G League in 2020 after the first-round NBA pick was lured by money and endorsement opportunities. Hardaway made clear G League was approaching potential one-and-done

Thanks to the new NIL rules, that wasn't a problem this offseason. Hardaway convinced

former NBA coach Larry

Brown to Memphis to join his coaching staff, then hired a 16-year NBA veteran and champion Rasheed Wallace. He also finalized a recruiting class led by a

pair of five-star recruits in Emoni Bates and Jalen Duren, two players who reclassified from 2022 to 2021, to earn his second No. 1 recruiting class at the American Athletic Conference program. Hardaway's sidekick Lil'

Penny from his Nike shoe commercials during his playing days also pitched in. Lil' Penny made an appearance in photos Bates posted on social media during his official visit to Memphis when he posed in a Tigers' uniform.

The Michigan native

originally committed to Tom Izzo and Michigan State last year before changing his mind. The 6-foot-8 guard has been called a generational talent and projected to be the No. 1 overall pick when he's eligible for the NBA draft in 2023 after turning 19.

He considered Oregon and the G League before committing to Memphis and Hardaway.

Hardaway joked the photo and coming out of retirement was Lil Penny's "It's a part of who I am,

it's a part of that what we do and how I made my name in the industry, in the NBA and with marketing and things of that nature and having Lil Penny here is self-explanatory," Hardaway said. "It's a part of my history. And it's also funny as well."

In the end, Hardaway believes the basketball side won over Bates and Duren even though Memphis hasn't reached the NCAA Tournament since 2014. Memphis returns three of its top five scorers from the team that won the NIT championship last spring. "They really knew

what they wanted out of this basketball thing," Hardaway said. "And the development, the teaching and understanding, being around brilliant minds on the staff is what they really wanted."

Wallace is eager to help the Tigers get whatever money they can earn through the NIL rules. He said former NBA players helped pave the way for him to make what he was paid once he arrived in the

"Now we paved the way for this generation to receive the dollars that they get," Wallace said. "So it's it just all goes hand in hand. So I want to see my young guys get that money so I can't take this knowledge to the grave with me. And it'll be an injustice to the basketball world if I did."

Milley: US coordination with Taliban on strikes 'possible'

WASHINGTON Army Gen. Mark Milley, chairman of the Joint Chiefs of Staff, said Wednesday that it's "possible" the United States will seek to coordinate with the Taliban on counterterrorism strikes Afghanistan against Islamic State militants or

Milley did not elaborate, and his comment did not appear to suggest immediate plans to work with the

U.S. military commanders coordinated daily with Taliban commanders outside the Kabul airport over the past three weeks to facilitate the evacuation of more than 124,000 people. But that was a matter of convenience for both parties and not necessarily a sign that they will pursue, or even want, a regular relationship in the future.

The U.S. military ousted the Taliban from power in the fall of 2001 and fought against them for the 19 years that followed.

The extent and nature of a U.S.-Taliban relationship, now that the war is over, is one of the key issues to be worked out. The U.S. diplomatic presence in Kabul has been moved to Doha, Qatar. President Joe Biden has noted several times recently that the Taliban are avowed enemies of the Islamic State group in Afghanistan, suggesting a shared interest with the United States.

At a Pentagon news conference with Defense Secretary Lloyd Austin, Milley called the Taliban "ruthless" adding, "Whether or not they change remains to be seen." He suggested that the recent cooperative arrangement with the Taliban at Kabul airport was not necessarily a model for the future.

"In war you do what you must in order to reduce risk to mission and force, not what you necessarily want to do," Milley said.

Biden has promised further targeting of the IS group in Afghanistan in response to the IS suicide bombing last week at a Kabul airport gate that killed scores of Afghans and 13 American

in Afghanistan that it said killed two IS planners. On Tuesday, Biden said, "To ISIS-K: We are not done with you yet," referring to the IS group. Targeting Islamic State militants or other extremist

with assets based elsewhere in the region. Although the Taliban oppose IS, it's far from clear that they will be inclined to work with the U.S. military or the Central Intelligence Agency now that they have regained power in Kabul.

Milley has recent experience with Taliban leaders; twice last year, most recently in December, he met face-to-face with them in an attempt to slow their attacks on the U.S.-backed Afghan government, which collapsed in mid-August,

led evacuation. Austin sounded at least as skeptical as Milley regarding the possibility that the coordination in recent days at the Kabul airport suggests a future relationship with the Taliban.

"I would not make any leaps of logic to broader issues," said Austin.

Both Austin and Milley commanded troops in Afghanistan during the 20-year war and their comments at Wednesday's news conference largely focused on tributes to those who served in Afghanistan, including those who died or were wounded. They also thanked all who contributed to the final airlift, which Austin called the largest evacuation of civilians in American history.

Milley and Austin urged war veterans to view their service as worthwhile and appreciated by the American public, while acknowledging that the memories can be painful.

'War is hard. It's vicious. It's brutal. It's unforgiving, Milley said. "Yes, we all have pain and anger. When over the last 20 days, that creates pain and anger." With the U.S. involve-

ment in the war over and all American military out of the country, Biden is grappling with the prospects of a new relationship with the Taliban. He has tasked Secretary of State Antony Blinken with coordinating with international partners to hold the Taliban to their promise of safe passage for Americans and others who want to leave in the days ahead.

Marine Gen. Frank McKenzie, head of U.S. Central Command, has described the U.S. relationship with the Taliban during the evacuation as "very pragmatic and very businesslike," saying they helped secure the airport. But other reports from people in Afghanistan described shootings, violence and Taliban moves to block desperate Afghans from getting through the

Biden in an address to the nation Tuesday defended his decision to end America's longest war and withdraw all U.S. troops by an Aug. 31 deadline.

"I was not going to extend this forever war," Biden declared from the White House. "And I was not going to extend a for-

ever exit.' Biden is coming under heavy criticism, particularly from Republicans, for his handling of the evacuation. But he said it was inevitable that the final departure from two decades war, first negotiated with the Taliban for May 1 by former President Donald Trump, would have been difficult, with likely violence, no matter when it was

"To those asking for a third decade of war in Afghanistan, I ask, 'What is the vital national interest?" Biden said. He added, "I simply do not believe that the safety and security of America is enhanced by continuing to deploy thousands of American troops and spending billions of dollars in Afghanistan."
