Private Act, wheel tax split commission; motion fails amid 'distrust'

A motion to introduce and authorize a Private Act that would empower the Bedford County Commission to enact a Motor Vehicle Privilege Tax ("wheel tax") failed at Tuesday's commission meeting. The commission was split 9-9.

The vote came after a lengthy session of public comments and discussion from the commission. The goal of the motion was to

give the county the option to utilize

a wheel tax in order to fund school resource officers in every school, according to Commissioner Tony Smith who motioned the resolution at the last Financial Management Committee meeting.

Though most commissioners and citizens who made comments were for the idea of getting an SRO in every school, the issue was how the wheel tax was going to be enacted — through a Private Act versus a referendum. Essentially, the consensus among the opposition was that a private act takes away the vote from the people.

However, Commissioner Linda Yockey, who seconded Smith's previous motion, explained that the vote was only to allow and provide the commission an option for a wheel tax. "Property owners in my district

are tired of being the only ones to fund the county. Fifteen thousand property owners out of a population of 50,000 carry the burden for the whole county," said Yockey.

She continued, "Should monies be needed and a referendum were asked this year, it would be December — at the earliest —

before a special election could be called for at a cost of \$30,000. So, you might as well wait for the March primary." According to Yockey, if this referendum were to fail, another year will have gone

Yockey also said based on precedence and past decision, a referendum will not pass in this county.

"In 1988, under Paul Parker, it was a no. A wheel tax in 2005 under Jimmy Woodson, no. A wheel tax in 2016 under Mayor

Vanderbilt solar farm in full operation

A "Flip the Switch" ceremony was held for the Vanderbilt I Solar Farm on Frank Martin Road Tuesday.

This partnership is the first of its kind under the new TVA Green Invest Program, which matches demand for green power from large business and industrial customers.

"The energy generated goes on to the TVA grid with that energy comes a renewable energy certificate that is required by

someone to have who says they're using green energy," said Matt Kisber, Board Chairman for Silicon Ranch. "Those certificates will be retired on Vanderbilt's behalf so it offsets Vanderbilt's energy consumption.'

Vanderbilt is served by Nashville Electric Service (NES) which is served by TVA. Essentially, Silicon Ranch sells the power to TVA, who in turn works with NES and Vanderbilt.

Last January, the solar farm held a groundbreaking event amid rain and mud. But on the bright,

clear Tuesday, visitors could see in full the rows of solar panels soaking up the sun.

With over 150,000 solar modules, Silicon Ranch has invested more than \$50 million to install the project which will generate 35 megawatts of energy through the Tennessee Valley Authority. Nashville-based Silicon Ranch is the largest owner and operator of solar facilities in the

TVA valley, according to Kisber. Solar Energy Industries Association (a U.S. trade association) calculates that on

average one megawatt of solar power generates enough electricity to meet the needs of 164 U.S. homes. Essentially, what could power 5,740 houses will be going

to Vanderbilt. Vanderbilt Chancellor Daniel Diermeier, who attended the event Tuesday, said the solar field will reduce the university's electrical

power use by 70 percent. Since January, some 250 craft workers were hired for the


project, including some recruited ➤ See Solar, Page 2A

April 4, 2023



(Continued from Page 1) [Eugene] Ray, no...and as soon as those referendums failed, there was a property tax increase," said Yockey.

First-year Commissioner Eric Maddox, who made the motion for Tuesday's public comments to be added to the agenda, was vocal against the private act. He called out Yockey during the meeting, saying he received a call from her on March 7 where she gave him a heads-up on the resolution. He said he voiced his disapproval of the process in how the wheel tax motion got on the agenda or rather how it was not on the agenda at the financial committee meeting, leaving citizens in the dark.

"A handful of you here in this room have succeeded in circumventing the citizens that trusted and voted you into office," he said. "I strongly feel that how we got here today is disrespectful to the citizens of the county and inappropriately handled at best. "Overall, I feel that peo-

ple do not trust this local government administration. And, quite frankly, I don't blame them because I don't either," Maddox said. In a similar sentiment,

first-year Commissioner Drew Hooker said, "I have received dozens of phone calls, messages, voicemails, and texts with a very

obviously frustrated and furious community that has felt betrayed by the very elected officials they trusted to serve them.

"We need to dive into this budget and find money, not always raise taxes,' said Hooker.

However, Commissioner

Smith who's been on the commission for 20 years, said, "Currently, this county is spending every dollar of our taxpayer's money the way that the prior commission voted it to be spent." He also cited how the cost of materials and equip-

ment has continued to go

up, which puts a larger bur-

den on the taxpayer as deci-

sion are delayed. In other words, short-term thinking ends in long-term debt. Smith said, "We need a couple more wings added to the schools; we need ambulances, firetrucks, police cars, a juvenile detention...If you add all this up, we're looking at \$20 million that's needed right now in Bedford County. If we wait, it's going to be seven or eight years before we can borrow this kind of

money. How much is this

\$20 million going to be

in eight years from now?

We're going to add another

eight to 10 million dollars

to our tax payers. This is

what I'm trying to avoid." This decision also came right before the Gov. Bill Lee announced a plan of more than \$200 million that would put SROs in

every school. However, Smith said these funds will only pay part of the total cost to fund the nine SROs needed.

> Biff Commissioner Farrar read off data from the County Technical Advisory Service (CTAS), which state 59 counties across Tennessee have a wheel tax, while 36 do not (this includes Bedford).

> Commissioner Adam Thomas suggested citizens vote for the wheel tax only if it goes to referendum and a detailed plan is laid out for how SROs will be funded.

> "I do not believe that it is our right course of action to circumvent the people's right to vote on something that has always been their right to vote on. We cannot go around something solely based on the fact we believe the people of Bedford County will vote against it," he said.

Public comments

Kathy Reed, principal of Deery-Eakin Elementary and someone who has been an educator in the community for 36 years, spoke in support of the motion. She said SROs are needed today, not only for intruders, but also to protect educators against upset par-

"I've had situations in the last two weeks where I've needed support," she said. "While I don't want anyone's taxes raised, it is time to protect our children

and do what's right...We elected you to do what's right for our community and sometimes you have to make a hard decision."

Gene Vedak, who was a police officer for 27 years, said he was in the middle on the issue. He said after contacting the clerk's office, he found out there are almost 53,000 vehicles in the county, and essentially, a \$10 wheel tax wouldn't be enough, and a \$75 tax would be too much. "I think we need to be transparent...and say this is where the money is going," he said.

Or as Brooke Sanders put it, "If you want to take a private act, that's fine. But have a detailed plan. Show us where the money is going."

Many who spoke were against the private act.

Stephanie Resident Rieford said, "What really concerns me is how the decision is being made. And, honestly, I'm not sure if everyone on this committee truly represents our community."

Then, there were a few concerned citizens who were against the wheel tax all together.

To sum up the overall feeling from citizens in attendance, resident John Clark said, "You've got enough money; you don't need my wheel tax money."

AG: Guardsman to be charged with removing classified info

A Massachusetts Air National Guard member who has emerged as a main person of interest in the disclosure of highly classified military documents on the Ukraine war was taken into custody Thursday by federal agents, Attorney General Merrick Garland announced. Investigators believe that

the guardsman, who specializes in intelligence, led the online chat group where the documents were posted. Garland identified the guardsman as 21-year-old Jack Teixeira, and said he would be charged with the unauthorized removal of classified national defense information. FBI agents converged

Thursday at Teixeira's Massachusetts home and heavily armed tactical agents took Teixeira, who was wearing a T-shirt and shorts, into custody outside the property, "without incident," Garland said. He will be charged with unauthorized removal of

classified national defense information, Garland said, and will have an initial court appearance in federal court in Massachusetts. It was not immediately clear if Teixeira had a law-

yer who could speak on his behalf, and a phone message left at a number believed to belong to his mother was not immediately returned.

Law enforcement officials roped off the street near the home. The New York Times, which first identified Teixeira on Thursday, said that a man who had been standing outside the Teixeira home earlier said that "he needs

Feds will be around soon, I'm sure."

The emergence of Teixeira as the apparent primary suspect is bound to raise questions about how the highest-profile intelligence leak in years, one that continues to unfold with almost daily revelations of highly classified documents, could have been caused by such a young, low-ranking service member.

The Biden administration has scrambled for days to contain the fallout from the leaked information, which has publicized potential vulnerabilities in Ukraine's air defense capabilities and exposed private assessments by allies on an array of intelligence mat-The National Guard did

not confirm his identity but said in a statement that, "We are aware of the investigation into the alleged role a Massachusetts Air National Guardsman may have played in the recent leak of highly-classified documents." Air Force Brig. Gen.

Pat Ryder, the Pentagon spokesman, referred all questions about the case to the Justice Department. But he said: "We have rules in place. Each of us signs a nondisclosure agreement. This is a criminal act, a willful violation of those." The Biden administra-

tion has been working to assess the diplomatic and national security consequences of the leaked documents since they were first reported last week. A top Pentagon spokesman told

reporters earlier this week

that the disclosures pres-

ent a "very serious risk to

national security," and the

WASHINGTON (AP) are going right now. The Justice Department opened through secure computan investigation to identify the person responsible.

> "We're getting close," President Joe Biden told reporters in Ireland on Thursday. He said that though he was concerned that sensitive government documents had been disclosed, "there's nothing contemporaneous that I'm aware of that is of great consequence."

The Justice Department declined to comment Thursday.

It's possible the leak may have started on a site called Discord, a social media platform popular with people playing online games. The Discord site hosts real-time voice, video and text chats for groups and describes itself as a place "where you can belong to a school club, a gaming group, or a worldwide art community."

In one of those forums, originally created to talk about a range of topics, members would debate the war in Ukraine. According to one member of the chat, an unidentified poster shared documents that the poster claimed were classified, first typing them out with the poster's own thoughts, then, as of a few months ago, uploading images of folded papers. Discord has said it was cooperating with law

enforcement. There are only a few ways the classified infor-

mation that was leaked could have been accessed, which may provide critical clues as to who is responsible. Typically in classified briefings, as with the slides that were placed on Discord, the information is shared electronically.

That is done either

er terminals where users gain access based on their credentials or through tablets that are distributed for briefings and collected afterward. If the slides need to be printed out instead, they can only be sent to secured printers that are able to handle classified documents - and that keep a digital record of everyone who has requested a printout. It's those digital clues

like the record of printouts that may help investigators hone in on who took the documents. In most of the photographs of documents posted online the pictures are of paper copies that look like they had been folded into quarters — almost as if they'd been stuffed into someone's pocket. In the days since the

leaks came to light, the Pentagon has deferred questions on the investigation to the Justice Department, stating that it's a criminal matter. Even if the person who leaked the files is an active duty member of the U.S. military, the Justice Department would likely still have the lead in the prosecution until it was ready to turn the matter over to the Defense Department, a defense official told the AP on the condition of anonymity to discuss sensitive This has been the case in previous criminal cases,

such as when two Marines based at Camp Pendleton in California were arrested on drug trafficking charges in 2020, the official said. If the person responsible turns out to be a civilian, the Justice Department will be responsible, the official Shelbyville Times-Gazette Saturday, April 15, 2023 3A

Dear Heloise: A





Ain't got no place to lay your head, Somebody came and took your bed, Don't worry, be happy....The landlord say your rent is late, He may have to litigate, Don't worry, be happy....Cause when you worry your face will frown, And that will bring everybody down, So don't worry, be happy...'

Someone once said, "Worry is like a rocking chair-it gives you something to do but it doesn't get you anywhere."

We are faced with all kinds of things in life that we could be worrying about, but we need to focus on more productive things than worry.

And it's not good enough to just tell someone not to worry but be happy.

There must be some solution.

On a large wooden plaque right above my computer monitor is a quote from Jeremiah 29:11. It says, "For I know the plans I have for you," declares the LORD, "plans to prosper you and not to harm you, plans to give you hope and a future.

Years back, I went through a rough period in my life with numerous hospitalizations and sur-

I learned just how meaningful it is to have others praying for me.

I didn't spend my days worrying during those times. I prayed and I knew others were praying for

I woke up in my hospital bed one day and I saw my friend, Dennis Pratt from Memphis, Tennessee, sitting across from me with his head bowed in prayer. He was praying for me, and it brought me great comfort.

One of the women in

the church I was pastoring at the time, brought me a prayer shawl that she had crocheted, and laid that over me. It had been prayed over by the folks at the church and that brought me great comfort.

Another one of the women in my church, brought me a quilt that she had made. Around the edges of that quilt, she had stitched this prayer: "Lord, we thank you that you are always ready to help. Surround Doug with your love and grant him peace of mind, peace of heart, and peace of soul. Wrap him in your tender care. Amen."

We can find comfort and peace in times of trouble, if we learn to pray and learn to depend on the prayers of others.

In Psalm 46 we read, "God is our refuge and strength, a very present help in trouble. Therefore we will not fear..."

We all need to learn Apostle Paul's admonition, "Don't worry about anything, but pray about everything."

Bulk collection starts on Monday; however, actual collection time will vary due to total volume and type of materials set out. This program is for items that are not normally hauled by your
- Items must be sorted and stacked separately with like items such as wood, metal,
- and household items. All City residents have one pick-up per household. Any items placed curbside
- All mattresses must be placed in a mattress bag which can be purchased from retail stores such as Amazon, Lowe's, and Walmart ETC...
- Any items containing glass, the glass must be secured with plastic or tape to eliminate breaking.
- Paint and/or paint cans will not be accepted. Paint and paint cans can be disposed of at the city transfer station located at 712 Blue Ribbon Parkway Shelbyville, TN 37160. • All rims must be removed from tires before being placed curbside. Any tires with



State History Day Competition

NASHVILLE - After months of research and success in local and regional competitions, over 200 students from across Tennessee will compete for honors at the annual Tennessee History Day (THD) competition in

Nashville today. Each year, all research topics are based on a specific theme. This year's theme is "Frontiers in History: People, Places, Ideas." While all projects must relate to the annual theme, students are encouraged to be creative in their execution. Students presented their work at regional competitions in various ways by creating exhibits,

documentaries, performances, websites or papers. Prior to the state competition, regional contests



Simmons thanks Titans owner for her trust

NASHVILLE Tennessee Titans took plenty of heat for selecting defensive tackle Jeffery Simmons at No. 19 overall in the 2019 NFL draft.

Not over the left ACL he tore that February. It was a 3-yearold arrest and video showing Simmons punching a woman that made it so surprising the lineman was selected by a team controlled by one of the NFL's few female

Simmons, who signed a four-year contract extension on Wednesday, said he texted Titans controlling owner Amy Adams Strunk to thank her for trusting him. She answered back that he promised he would never let her down and he hasn't.

"That right there, it hit something inside because, you know, to have a female owner, a lady

owner, in the NFL to trust in you so much from kind of the adversity I went throughout my journey to get here, it means so much to me," Simmons said.

The now two-time Pro Bowler said he appreciates "Miss Amy" so much after both Strunk and her new general manager, Ran Carthon, who was hired in January, made clear he wasn't going anywhere anytime soon.

"To the Titans' organization we have a lot of work to do," Simmons said. "We just getting started."

Simmons and the Titans agreed on April 7 to the extension reportedly worth up to \$94 million, with \$66 million guaranteed, including a \$24 million signing bonus. The Titans announced the extension Tuesday and gave Simmons and his family the chance to celebrate a day later after the signing.

The deal includes a fifthyear option and keeps Simmons under contract through 2027 at an annual average of \$23.5 million per year. That trails only the \$31.6 million per year averaged by three-time AP NFL Defensive Player of the Year Aaron Donald of the Los Angeles Rams among defensive tackles.

Simmons paused and had tears streaming down his face at one point Wednesday. He said he now has generational wealth after being raised by a single mother with four siblings, moving from apartment to apartment, house to house, sharing a bed with a brother in Mississippi. "That's why I do it ... man

every day I wake up," Simmons

With this deal done before the draft that starts April 27, the Titans avoided last year's drama when they couldn't reach a new contract with Pro Bowl wide receiver A.J. Brown, who was traded during the first round to Philadelphia for the 18th pick

They already had picked up Simmons' fifth-year option for

Simmons has 21 career sacks, second on the Titans behind outside linebacker Harold Landry III, who has 26 1/2. Simmons has 196 tackles, 19 passes defended, two forced fumbles and three recovered fumbles. He has started 54 of 56 games after missing the first six games as a rookie. He led the NFL's stingiest run

defense in 2022, allowing only 76.9 yards rushing per game, and was named to a second straight Pro Bowl after posting 7 1/2 sacks. Only Simmons and J.J. Watt of Arizona had at least seven sacks and seven passes defended

Carthon said talks on this extension started right after the Senior Bowl. "There's a model for what you

want a player to be and what you want your organization to look like, and I think Jeff is one of those models for us," Carthon said. "So this was something that was a priority to get done." Coach Mike Vrabel recalled

Simmons truthfully answered all the questions they threw at him during a visit to Mississippi State.

"You've earned this," Vrabel said. "We're going to continue to hold you to a high standard. That'll be the fun part, but certainly embody everything we believe in here as a team captain and a leader in your performance on the field."

Spring turkey season set to open

NASHVILLE — Tennessee's 2023 statewide spring turkey season is set to open Saturday, April 15. The statewide opening date is two weeks later than in previous years. The Young Sportsman Hunt was April 8-9.

Hunters are also reminded that the bag limit has been reduced from three birds to two birds, and only one bird can be a juvenile or jake. The changes were made by the Commission to benefit the state's wild turkey population. After hearing growing reports of decreasing turkey populations, the Tennessee Fish and Wildlife Commission voted to delay the statewide turkey season to improve reproduction and nesting success.

New turkey regulations will be in effect on select Wildlife Management Areas (WMAs) and hunters are reminded to check each WMA they hunt in the 2022-23 Tennessee Hunting and Trapping Guide. The practice of fanning or reaping turkeys is now prohibited on all WMAs statewide due to safety concerns.

"This spring season is shaping up

to be a good one," said Roger Shields, Wild Turkey Program Coordinator for the Tennessee Wildlife Resources Agency. "We had very good production across the state in 2021, so now we are seeing a lot of 2-year-old birds coming into maturity. If we have decent weather during the early part of the delayed season, we should have excellent hunting."

This will be the fourth spring turkey season to "Tag Before You Drag" where hunters tag their big game animal in the field prior to moving. Hunters can use the TWRA on the Go app to simply E-tag and report their harvest in the field in one easy step, with or without cell phone service, prior to moving.

Hunters not using a phone can attach one of the temporary transportation tags printed at the bottom of your license. Hunters using temporary tags have until midnight on the same day of the harvest (or before leaving the state) to check in a harvest online at GoOutdoorsTennessee.com or in person at one of several manned check stations. Temporary transportation tags can also be obtained by logging in at GoOutdoorsTennessee.com. A combination hunting nd fish-

game license, or a sportsman license is required. To purchase a license online, visit GoOutdoorsTennesssee. More information on the 2023 spring turkey season can be found in the 2022-23 Tennessee Hunting &

Campbell was a mainstay in Westwood for the past four seasons after missing his freshman year with a knee injury.

The senior from Cedar

Rapids, Iowa, averaged 13.4 points, 5.0 assists and 2.6 rebounds while playing all 37 games this past season. Campbell led the Pac-12 in assist-turnover ratio (3.2) and also finished third in the nation in that category. He also led the league in free-throw percentage at 85.6. He finished second

on the school's all-time assists list with 655 and 10th in games played at

Campbell earned firstteam All-Pac-12 honors for three years and was an honorable mention this past season.

He helped the Bruins reach the Final Four in 2021 and the Sweet 16 in 2022 and this year.

"This was an emotional last run for the two of us, as we both worked so hard together to make UCLA elite again," coach Mick Cronin said in a statement. "We know that Tyger has a long future in pro basketball, and I hope that I'm coaching long enough to hire him on my staff someday, as well."

Campbell and teammate David Singleton, who is out of eligibility, are set to compete in the Portsmouth Invitational this week, a pre-draft showcase in Virginia. Jaquez, a senior, is

headed to the draft after deciding to forgo an extra year of eligibility available because of the COVID-19 pandemic. Clark, a junior, has said

he will enter the draft. However, he did not indicate whether he would hire an agent ahead of the June 22 draft or retain his remaining eligibility.

NFL adopts QB specific helmets

The first quarterbackspecific helmet designed to help reduce concussions has been approved for use by the NFL and NFLPA, the AP has learned.

The helmet, manufactured by Vicis, reduces severity of helmet-toground impacts, which league data says account for approximately half of quarterback concussions, including the one suffered by Miami's Tua Tagovailoa last season when his head slammed violently against the turf during a Thursday night game against Cincinnati.

"We've now analyzed with our engineers and with the Players Association sions on field, we have a pretty good database of how these injuries occur," NFL executive Jeff Miller told the AP about the helmetto-ground impacts. "This helmet performs better in laboratory testing than any helmets we have ever seen for those sorts of impacts."

The helmet performed 7% better than the most popular helmet worn by quarterbacks last season, the league said in a memo sent to team executives on Thursday.

Jason Neubauer, an executive for Vicis, said the company began designing its Zero2 Matrix QB helmet in early 2022.

"The unique thing is that it has a deformal outer shell,

which means when you take an impact in any location on that helmet, it will deform or basically dent in that location to absorb the impact," Neubauer said. "What that means for us, as we're looking to optimize it for different types of impacts, we're able to change unique locations to try to optimize the impact mitigation in any one area."

It's unknown how many quarterbacks will switch to the new QB-specific helmet. The league and the players' union share information from the helmet studies with teams so players make informed decisions on helmet choice. The only other position-specific helmet already approved is the Vicis Zero2-R Trench for offensive and defensive

The memo sent to teams also includes the results of the 2023 helmet laboratory testing study. Miller told seven helmets the league highly recommended in 2020 have now been downgraded to prohibited

as a result of new testing. "That's a great sign," Miller said. "Hopefully we can continue to stimulate that either with positionspecific helmets designed for each position group or for a general all-purpose helmet to be able to say to players: 'Work with us, be willing to change helmets because better and better products are coming online every year."







Minneapolis to pay \$8.9M over Chauvin's actions before Floyd

The city Minneapolis agreed Thursday to pay nearly \$9 million to settle lawsuits filed by two people who said former police officer Derek Chauvin pressed his knee into their necks years before he used the same move to kill George Floyd. John Pope Jr. will

receive \$7.5 million and Zoya Code will receive \$1.375 million. The settlements were announced during a meeting of the Minneapolis Council. Both lawsuits

stemmed from arrests in 2017 — three years before Chauvin killed Floyd during an arrest captured on video that sparked protests worldwide, prompted a national reckoning on racial injustice and compelled a Minneapolis Police Department overhaul. The lawsuits stated that if the city had acted sooner to discipline Chauvin, "history could have been stopped from repeating itself

with George Floyd." Bob Bennett, the attorney for Pope and Code, noted in a statement that other officers failed to intervene or report Chauvin, and police leaders allowed Chauvin to "field train

sanction and to continue his predatory ways for years." Council member Elliott Payne said what happened to Code and Pope were reminders of what happened to Floyd

"And it's actually not a Derek Chauvin problem. It's an institution problem," Payne said. He hoped the settlements "bring some closure to this era and is a stark reminder of the work we have lying

Code, who has a history of homelessness and mental health problems, was arrested in June 2017 after she allegedly tried to strangle her mother with an extension cord. Pope was 14 in September 2017 when, according to his lawsuit, Chauvin subjected him to excessive force while responding to a domestic assault report. Both lawsuits named

Chauvin and sever-

al other officers. The lawsuits alleged police misconduct, excessive force, and racism Pope and Code are Black; Chauvin is white. They also said the city knew that Chauvin had a record of misconduct but didn't stop him. Criminal charges in both cases were eventually dropped. The lawsuits said

body camera recordings showed Chauvin used many of the same tactics on Pope and Code that he used on Floyd. Chauvin was sentenced to 22 1/2 years in prison on a state murder charge in 2021 for killing Floyd by pressing his knee to Floyd's neck for 9 1/2 minutes as he pleaded that he couldn't breathe. The city also paid \$27 million to Floyd's fam-

Code's lawsuit said she was in handcuffs when Chauvin slammed her head to the ground and pinned his knee on the back of her neck for 4 minutes and 41 seconds. A second officer didn't intervene and

Pope's lawsuit said his mother was drunk when she called police because she was upset that he and his 16-yearold sister left their cellphone chargers plugged in, leading to a physical confrontation. It alleged Chauvin struck Pope in the head with a large metal flashlight at least four times. It says he then put Pope in a chokehold before

and putting his knee on Pope's neck. "Chauvin would proceed to hold John in this prone position for more than fifteen minutes, all while John was completely subdued and not resisting," the complaint alleged. "Over those minutes, John repeatedly cried out that he

could not breathe." complaint

alleged that at least eight other officers did nothing to intervene. It said Chauvin did not mention in his report that he had hit Pope with his flashlight, nor did he mention pinning Pope for so long. Chauvin's sergeant reviewed and approved his report and use of force "despite having firsthand knowledge that the report was false and misleading,"

the lawsuit alleged. Chauvin admitted to many of Pope's allegations when he pleaded guilty in December 2021 to federal charges for violating the civil rights of both Floyd and Pope. He was sentenced in July to 21 years on those charges. Chauvin is serving

his sentences in a federal prison in Arizona.

As Earth warms, more 'flash droughts' suck soil, plants dry

fast so you don't have

Climate change is making droughts faster and more furious, especially a specific fastdeveloping heat-driven kind that catch farmers by surprise, a new study found.

The Thursday's journal Science found droughts in general are being triggered faster. But it also showed that a special and particularly nasty sudden kind called "flash droughts" by experts — is casting an ever bigger crop-killing footprint.

It comes only in the growing season mostly summer, but also spring and fall - and is insidious because it's caused not just by the lack of rain or snow that's behind a typical slow-onset drought, hydrologists and meteorologists said.

What happens is the air gets so hot and so dry that it sucks water right out of plants and

"It's the increasing thirstiness of the atmosphere," said UCLA and National Center for Atmospheric Research climate scientist Daniel Swain, who wasn't part of the study. Swain relevant in a warming climate." The term flash

drought was coined around 2000 but it really took off in 2012, when a \$30 billion sudden drought struck the central United States, one of the worst droughts since the infamous Dust Bowl devastated the Plains in the 1930s, according to the study.

"Because it occurs very, very fast people started to focus on this phenomenon," said study lead author Xing Yuan, dean of the School of Hydrology and Water Resources at Nanjing University of Information Science and Technology in China. "For the 2012 drought, actually the drought just developed in a very severe condition just within a month."

Most of China's Yangtze River basin last summer was struck by a flash drought that developed within only a month due to high temperatures, which also triggered wildfires, Yuan said. Parts of the river dried up and there was an energy shortage in southern China because hydropower wouldn't work, he said.

"It developed very

enough time to prepare for this drought," Yuan Another sudden

drought happened in the U.S. Southeast in 2016 and was a factor in devastating wildfires in Gatlinburg, Tennessee, said Jason Otkin, a study co-author and an atmospheric scientist at the University of Wisconsin, Madison.

The current drought in the Oklahoma-Texas panhandle and Kansas started two years ago as a rapid onset drought, said Joel Lisonbee, a climatologist at the National Oceanic and Atmospheric Administration's Integrated Drought Information System in Colorado. He wasn't part of the study but praised it, saying "essentially a warmer world allows for faster onset of drought."

Yuan, Otkin and their research team looked back at droughts, how fast they occurred and what kind they were, across the globe since 1951 and found flash droughts are happening more often in nearly three-quarters of the climate regions of the world. They also found droughts of all kinds happening faster. Although couldn't quantify how much faster because of

and times, Yuan said it would be fair to say droughts are happening weeks earlier than they once did. Yuan said some of the bigger increases in sudden droughts have been in Europe and Australia. Outside experts pointed to the

used computer simulations - both with worstcase warming and more moderate warming - and projected that the proportion of flash droughts will increase in a warmer world and droughts will continue to keep happening fast-By definition, flash

droughts - because they result from low soil moisture levels - are especially bad for agriculture, experts said. The trouble is there

has been an old way of thinking that "we have months or years before we need to worry about drought," said Mark

Svoboda, director of the National Drought Mitigation Center at the University of Nebraska-Lincoln.

That's the reason why Svoboda, who wasn't part of this study, said he pioneered the term "flash drought" and wanted to "dispel the notion that droughts only manifest themselves over long period of time."

Svoboda's agency recommends that farmers, ranchers, municipal water suppliers and hydropower plants come up with plans for droughts. For example, farmers and ranchers should know how susceptible they are to drought and have alternative plans for plant-

ings or foraging. NOAA's Lisonbee said in an email that the problem is "in a slowly evolving drought if a farmer thinks the season ahead will be dry, they may consider a more drought-tolerant crop that season, but when a flash drought occurs it is likely the crops are already in the ground and there is little that can be done."
