CERNY Courier Publisher **DENVER** – Former Alamosa School Board President Elias (Eli) Heredia, 45, appeared in Denver County Court Friday morning on a complaint of sexual assault filed by school board member Katrina Brown. He has not been formally charged but was ordered to appear in court again on August 12.

The presiding judge ordered a personal recognizance bond of \$1,500 without supervision and issued a protection order against Heredia on Brown's behalf. He surrendered Thursday on a warrant and was jailed at the Denver Downtown Detention Center.

Brown had received a temporary restraining order against Heredia from Alamosa County after a July incident involving her keys.

Heredia appeared in court virtually as did his attorney David Kaplan of Denver. The judge stated that Friday's first appearance was based on an "investigating arrest" and that charges had not yet been filed.

The complaint alleges that Heredia assaulted Brown at a Denver hotel on Feb. 27, 2020, while the two were attending a legislative meeting for the Colorado School Boards Association, according to a Facebook post by Brown.

Heredia was later issued a summons for tampering after allegedly removing Brown's keys from her vehicle in the City Market parking lot on July 6. Brown said the keys were eventually

#### **Creede receives over** \$300,000 STAFF REPORT

**DENVER**-A conditional grant award of \$1,000,000 for the Ski Hi Park Multi-Purpose Facility project was approved this week by the Colorado Department of Local Affairs (DOLA). In a letter to Monte Vista Mayor Dale Becker, DOLA approved the request for state Energy and Mineral Impact Assistance funds. Revenues are derived from oil, gas, carbon dioxide, coal and metals extracted in Colorado. In a separate award, the City of Creede received a grant of \$322,847 for completion of the Creede Early Learning Center

expansion project from the same fund. Both grants will be from state severance tax proceeds which may cause the cities to go to election to receive and spend the funds.

Q: What is positivity rate?

A: The positivity rate is the percentage of total COVID-19 tests that have a positive result. For example: If 100 people were tested in a two-week period, and 20 of those tests showed positive for COVID-19, the two-week positivity rate would be 20%.

Q: What does the positivity rate tell scientists? A: The percent of positive tests helps Public Health determine whether enough symptomatic people in the community are being tested. This gives us a good picture of the level of virus spread in the community, and how likely it is that there are people with COVID-19 who have not been tested.

Q: How is knowing the positivity rate of a jurisdiction helpful?

A: Positivity rate is a helpful indicator of how broadly a certain jurisdiction is testing. If a high proportion of people are testing positive, that indicates that we're probably identifying only the most severe cases and aren't testing widely enough.

Q: What's our current positivity rate?

A: The San Luis Valley's two-week positivity rate has been trending down recently and it is currently just above 3%.

Q: How can the SLV region maintain its positivity rate? A: The way the SLV region can maintain a low positivity rate is if enough people who have symptoms pursue a COVID-19 test, even if symptoms are mild.

# How not to get lost in the woods

In the 1980 movie classic, "The Mountain Men", the character Henry Frapp is questioned by a young greenhorn: "Haven't you ever been lost?" Frapp scratches his whiskers and after a recollecting pause, replies, "A fearsome confused for a month or two... but I ain't ever been lost!"

For the fur trappers, wandering through a vast and unexplored country, "lost" would have been something of an oxymoron. Not knowing where you were was a necessary part of the mountain man business. The blank space on the map was as much "home" as it was wilderness, and "lost" was more a state of mind than a physical dilemma.

When the mountain men plunged head-long into the unknown, they knew that where they were going there would be no restaurants or hotels. So they planned accordingly. They learned quickly where to find food and how to get it; how to mend equipment, to make new or make do; they could sleep in a log, a cave, or just plain under the stars–and survive! How did they accomplish this incredible feat? Simply, they were prepared--mentally and physically.

Today, the same principles apply. When you head out into the woods, be prepared: for cold, rain or snow; to tend an injury; or to stay the night in the woods. It's not as difficult as it sounds. Here are a few nuggets of Mountain Man wisdom to help you survive:

Staying Found

The old timers relied on "Dead Reckoning" for navigation: utilizing a compass to guide them in the general direction they wished to go. Sometimes in the absence of a compass, they relied only on "reckoning": as in "I reckon camp is back that way." The contemporary woodsman may have the handiness of a GPS, but owning one of these high-tech gizmos is not an adequate substitute for map and compass skills. Just as with other conveniences (cell phones, cameras, flash lights), the batteries will invariable go dead just when you need them the most.

Learning how to read a map is not that difficult; up is north, left is west and so on. The closer the lines are together the steeper the country. Water is shown as blue, while man made objects are black. It is simply a two dimensional rendition of a three dimensional world. Using a map and a compass to show you which way is north, you'd be hard pressed to get seriously lost. Sure, some practice is required, but that's all part of the preparedness thing.

Paying attention to where you're going can also be a big help to staying found. As you pursue your quarry, notice which way the shadows are falling. Have you been mostly climbing, or descending? Look for landmarks as you go. Not stumps and rocks, but BIG landmarks that give your relative position to the valley below, or that craggy peak to the west. Turn around and look behind you, what would it look like if you were going that way – back to camp or the truck?

#### The Essentials

Unless your trip is taking you across the Gobi or the Brooks Range, you probably don't need to carry 50 feet of copper wire or spare fishing line and hooks. The largest wilderness area in Colorado can be traversed in a day or two. So what are the essential essentials you need when you're on your own hook?

Water. Without it, you're dead in three days. Without it for a few hours, at 9,000 feet above sea level, you're not dead, but you may wish you were. Dehydration can lead to altitude sickness and hypothermia. But even worse, it can impair your judgment, induce panic, and result in a fatal case of Lost.

Fire good... Fire friend... Fire number two in importance. Learn how to build one, WITHOUT toilet paper and gasoline. It's as easy as one two three: One, you need dry tender. Scratch around under grass tussocks for the driest stuff. Get lots of it, about a volley ball sized bunch; two, kindling. You want about twice as much as the tender you gathered. Kindling is small stuff - matchstick sized. Three is the fuel itself. Gather up plenty if it looks like you may have to spend the night. Pick dry branches one to two inches in diameter--these burn without difficulty and make it easy to control the heat. Of course we can't overlook the match. You don't need to be proficient with a flint and steel, but you should have at least a couple of ways to start fire; it doesn't matter if it's a lighter or a fire plow, as long as you can get it lit. Shelter. Now don't jump right into bivy sacks and backpacking tents. Let's take a step back and start at the beginning. Shelter starts with your clothing. Dress for the worst. And in a Colorado autumn, the worst can be pretty harsh. Pick synthetics - like fleece or polyester blends - but wool is best. Dress in layers: long handle union suit, light mid layer(s), and warmer outer layer. Dressing appropriately when you leave camp will find you well on your way to surviving a night in the outback even without a buffalo robe. Make a plan and let someone know what it is. Leave a map open on the dashboard of the truck. You don't have to give up your secret spot with an "I AM HERE" arrow, just circle a square mile or two. When you leave camp, a plain old "I'm gonna work this ridge out and come back down the crick" is enough to give your buddies a place to start looking for you if you should become "a fearsome confused." The important thing is to stick to your plan. As you head into the high country this fall, see yourself as one of the Lewis & Clark Expedition; be prepared, both mentally and physically for the challenges of the unknown. Keep your powder dry and your eyes on the horizon and you'll know that "lost" is, by and large, just a state of mind.



returned to her husband, Dylan, by an overnight package from Heredia and therefore the incident was not considered theft.

At a July 27th school board meeting, Heredia resigned as president and board member citing "a one-sided presentation of the facts" related to the February incident in Denver and his tampering charge in July. He claims that Brown invited him to her hotel room after the pair shared dinner and drinks.

'To each of our embarrassment, regret and shame we eventually kissed," Heredia said in his statement at the board meeting. "Immediately recognizing our profound transgression, we began

to apologize to each other as I left the room."

He didn't comment further on the tampering charge, citing the fact the charges are still pending.

In an interview with the Valley Courier, Brown said she had planned on keeping the February incident private until the July incident involving her keys. She then chose to post on Facebook about the hotel encounter without naming Heredia.

"He stole my keys leaving me stranded and feeling helpless and out of control all over again," Brown posted.

She claims Heredia kissed and "groped" her in her room at the Denver hotel after which she asked him to leave. Denver police have not responded to a request for the official complaint.

# Head Start program receives governmental review

ALAMOSA— The Department of Health and Human Services administration recently reviewed the Head Start program performance of the Rocky Mountain Ser, a state non-profit that provides early childhood education, workforce development and community development throughout Colorado.

Here in the San Luis Valley, RMSER has a community center on Hunt Avenue in Alamosa, a Head Start program in Conejos and an early learning center in Sanford. Its early learning center in San Luis is currently vacant.

After reviewing the performance standards, the report indicated that there was only one area of deficiency in its Head Start program, that of ongoing fiscal capacity. The report indicated a deficiency in the organization's ability to "plan and implement a fiscal management system that supports the organization's ongoing capacity to execute its budget over time and meet the needs of the organization.'

This deficiency only related to the monetary award the federal government awarded to the organization by way of a grant, which was not renewed.

RMSER was first awarded the Head Start grant in Pueblo in 2002 and was able to expand to the San Luis Valley areas of Alamosa, Costilla and Conejos counties. The organization eventually was able to expand to 11 counties throughout the state, which allowed it to become the first "super-grantee' for Head Start in the state of Colorado.

I was lucky enough to earn a position as a ceramic apprentice my freshman year and spent the rest of my college career learning the craft.

I appreciate the integrity of clay as a medium and the functionality of the finished pottery. I also admire the permanence of the final piece. Pottery has taught humans so much about past civilizations. I find the process of 'throwing' (aka, creating) pots on the pottery wheel very therapeutic. I trained on both the kick-wheel (manual) and the electric wheel (automatic).

The wheel is where a potter starts, to throw their pots. Once all of the moisture is gone from the pots, they go

What a week! It's hard to believe it is almost the middle of August---how did that happen? Sometimes I have a pretty good feel for what winter is going to be like, but this year I don't have a clue.

through what is called a 'bisque' firing, where the remaining water and organic material is essentially baked out. The temperature depends on the clay the potter has used - low-fire, mid-fire, or high-fire. Then the potter glazes their work before the pots go into a final firing. The temperature of the final firing differs depending on the clay and glaze used, as well as the potter's preference.

I adore the seemingly endless variety potters can utilize when firing their final pieces -- one can pit fire, gas fire, wood fire, etc. While vitrifying the pots is the main goal of a final fire, the visual effect is drastically altered by which final firing process the potter chooses.

Of the entire pottery process, throwing Is certainly my favorite. I prefer the kick-wheel, as it provides a more intimate throwing session. Potters have been making pots on a kick-wheel for ages – some scholars date the first




kick-wheel back to Mesopotamian civilizations. When working on one, the potter is in complete control of the process. It's also incredibly convenient and efficient to work without electricity.

When I'm throwing the rest of the world melts away. The clay demands the attention of my entire body and mind and I gladly give in.



Broyles is a long-time resident of Alamosa, is an Alamosa City Councilor for Ward 2 and was president and CEO of First Southwest Bank.





# RMAC Fall team sport postponement

COLORADO SPRINGS — In a meeting on Friday the Rocky Mountain Athletic Conference (RMAC) Presidents' Council postponed conference schedules and championships for fall sports (Football, Men's Soccer, Women's Soccer, Volleyball) to the spring semester except for cross country which shall compete as originally scheduled. Additionally, the Council agreed that men's and women's golf could continue its nonchampionship segment competition this fall.

After considerable deliberation. the Council's decision was made based on the recent National Collegiate Athletic Association (NCAA) Board of Governors' mandate of the NCAA Resocialization principles and the Division II Presidents Council decision to cancel fall championships. The RMAC decision allows league members further opportunity to align with the student-athlete safety measures outlined in the NCAA document to prepare for competition.

The determination on sport status was made based on the NCAA risk rankings of sport. As it stands currently with NCAA guidance, cross country and golf are lower risk than all other fall sports. Further details on the structure and scope of the spring semester practice and competition schedules for postponed sports will be released in the coming weeks.

Practice opportunities will be available in the fall semester for fall sport student-athletes per Division II rules and at the discretion of each RMAC member institution. As has been the case throughout the past five months, the RMAC will continue to monitor local and national developments regarding health and safety, along with association guidance to make any necessary

ficials understand the significant impact these decisions have on our student-athletes and stand ready to provide support and guidance in any way possible. Questions related to eligibility, scholarships and academics should be directed to member institutions as always.

On the heels of the announcement from the RMAC, Adams State posted their own statement:

Adams State Athletics supports the difficult decision made by the Rocky Mountain Athletic Conference Presidents' Council to postpone conference schedules and championships for fall sports. This decision includes postponing Football, Volleyball, Women's Soccer, and Men's Soccer until the spring semester. Men's and Women's Cross Country will be allowed to compete as originally scheduled.


The Adams State Athletic Staff has worked diligently to provide an environment focused on health and safety for our student-athletes, staff, the campus and surrounding community. As we move forward, continued focus will be placed on providing the best experience for our Grizzly student-athletes.

We also want to emphasize practice and continued workout opportunities will be available, as per NCAA rules, for those sports affected by this decision. It is important to note eligibility-related flexibility will be given to
