Twenty-nine total people have been hospitalized, and 257 have completed isolation. Monday Rio Grande County confirmed their first fatality. There have been 6 fatalities of individuals with COVID-19. There are currently approximately 108 active cases in the Region.

While numbers can be useful, sometimes they can be misinterpreted, especially if not all factors and variables are considered in applying calculations. Case rate is one example. In the San Luis Valley, our population numbers are too low to accurately calculate the case rate in comparison to other areas of the State. Without a robust

it is difficult to make statistical determinations that can support certain conclusions, and the data can easily be skewed. It can feel frustrating to not have a clear way to compare our area with other areas of the State, but it is important to avoid making false assumptions.

be used when interpreting rates in counties with small populations. "In smaller populations with fewer cases, there is not enough information to make a valid comparison [to counties with larger populations]."

DEL NORTE — The Astronaut Kent Rominger Airport (RCV) was distinguished as the "2020 Colorado Airport of the Year" by the Colorado Department of Transportation (CDOT) Division of Aeronautics and the Colorado Aeronautical Board. The Colorado Airport of the Year Award is presented annually by the Colorado Division of Aeronautics to recognize Colorado public-use airports that exhibit outstanding contributions to the Colorado Air & Space System. Airports distinguished with this recognition demonstrate values that fall in line with the CDOT Division of Aeronautics' mission to advance a safe, efficient, and an effective statewide air and space system through collaboration, investment, and advocacy. In 2010, the Division of Aeronautics supported one of the largest state/

local-funded runway projects at Del Norte, which addressed the growing medical evacuation needs of Del Norte's new Rio Grande Hospital. The airport also recently completed the construction of a pilot shelter and camping facility, funded entirely by the airport and the Recreational Aviation Foundation. The volunteer leadership of the airport has helped make RCV one of the shining examples in Colorado of what a small rural general aviation airport can do to support its community and its residents and visitors. According to the 2020 Economic Impact Study of Colorado Airports, the Astronaut Kent Rominger Airport is responsible for supporting 31 jobs, producing over \$1.36 million in annual payroll, while generating \$5.38 million in overall business revenue.

night on Ellingwood Point after she slipped on a snowfield and slid down

over 100 feet, according to Shawn Woods, Alamosa County Undersheriff. During the slide, she felt her knees pop and had instant pain and could not walk.

Woods said the entire party of four sustained some minor bumps and bruises during the incident which began on the South Zapata approach to Ellingwood.

Most of the family was from Denver and were visiting a family cabin on the Los Pinos in Conejos Canyon, Woods said.

A call was made to Colorado Search and Rescue Association by Alamosa Volunteer Search and Rescue (AVSAR) to request mutual aid from neighboring teams, Woods said, with both Custer County and Chaffee County South SAR responding.

Reach Air Medical Services was called in to assist with a helicopter, airlifting six SAR team members one-by-one to a landing site about 1,000 feet above the injured woman while another nine team members were on their way on foot.

Once rescuers reached the injured woman, they began a low angle scree evacuation down approximately 1,000 feet. The patient was then carried to the helicopter to be medevacked to San Luis Valley Health hospital in Alamosa.

Woods said all teams then began the descent down the South Zapata Trail and were back at incident command by 1 a.m. Monday.

"A big thanks to Alamosa County Victims' Advocates for bringing much-needed food and water to our teams coming off the mountain," Woods said, "and also thanks to Dominos for donating over 20 pizzas."

Coloradans encouraged to return ballots by drop box

Ballots returned by mail after June 22 may not arrive by June 30 election day deadline

DENVER — Beginning June 22, Colorado Secretary of State Jena Griswold encourages Coloradans to return their statewide primary ballot by drop box rather than through the mail. In Colorado, ballots must be received by 7 p.m. on Election Day to be counted. Ballots mailed after Monday may not arrive by the June 30 Election Day deadline. Voters are encouraged to drop their ballot off at the nearest 24-hour drop box to help ensure they are received in time to be counted.

Monday also marked the start of early, in-person voting at Voter Service and Polling Centers (VSPCs). Voters are encouraged to submit the ballot they received by drop box if possible to limit the spread of COVID-19. However, in-person voting is still available for those who must register to vote or cast their vote in person. To make voting as safe as possible, the Colorado Secretary of State's office has funded and helped counties secure Personal Protective Equipment (PPE). The Secretary of State's Office also worked with the Governor's office and the Colorado Department of Public Health and Environment (CDPHE) in issuing emergency election rules and guidance for county elections officials for conducting elections during the COVID-19 pandemic. "Wa want to make sure Coloradans have the informa-

"We want to make sure Coloradans have the information they need to cast a ballot in our June 30 Statewide Primary and feel safe doing so," said Colorado Secretary of State Jena Griswold. "To avoid the possibility that a ballot is not received in time to be counted, I encourage all voters to drop their ballot off at a ballot drop box. In-person voting also begins Monday for those who need that option. We have worked to make voting inperson as safe as possible for both voters and election personnel." and hands-on experience in multiple disciplines including drawing, painting, metalwork, sculpture, ceramics, dark room experience, digital and graphic art, and printmaking. She also chose Adams for its size, which made the learning experience more intimate. In addition, Adams State was more affordable than CU Boulder or CSU Fort Collins.

Eugene Schilling, professor of art, was crucial to Andrew's success as a student and painter. He took time to get to know her as an artist and student. "He pushed me to step out of my comfort zone and challenged me to experiment with different techniques. I would never have made it into grad school without his guidance."

Andrews will pursue a Master of Fine Arts at University of Alaska, Fairbanks. She hopes to return to the San Luis Valley and begin a career in art education and continue work as a wildlife activist, including research, writing, and producing work focused on the valley wildlife and communities.

To help offset the cost of her education, Andrews received several scholarships, worked as a resident assistant in Family Housing, and assisted in the Adams State art gallery and the artist in residency program. The opportunities working with the gallery team and resident artists were rewarding. She learned about the art profession and made connections with artists and the community.

Although she was nervous about fitting in, Andrews soon discovered her place at Adams State through clubs and organizations. She served as copresident of the League of the Arts (LOTA) and as president of Art Hop.

The level of growth Andrews experienced at Adams State goes beyond the classroom. "Words cannot express what I have gained as an artist and person. I am grateful to all who embraced me and made me feel a part of a much bigger picture."

Participation in the Temporary Emergency Food Assistance Program is available to all eligible persons regardless of age, race, sex, handicap or origin.



Colorado Division of Motor Vehicles adjusts licensing fees

for first time in years

LAKEWOOD — The Colorado Division of Motor Vehicles (DMV) will adjust its licensing fees by about 10% by July 1, 2020, in accordance with Colorado Revised Statute 42-2-114.5. The adjustment will apply to all driver licenses, instruction permits and identification cards, and their renewals.

The adjustment means a standard driver license will cost \$30.87, up from \$28 while an ID card will cost \$12.67, up from \$11.50. Most licenses only need to be renewed every five years. The adjustment will come in two phases with the first starting Tuesday, June 23, 2020 and adjusting the fee by 5%. The second phase will adjust the fee by 5% at the start of the State's new fiscal year on Wednesday July 1, 2020.

The fee increase is being made to ensure the cash fund that covers the majority of expenses related to providing licensing services for residents across the state remains solvent. One of the causes of reduced revenue is demographic shifts causing a decrease in the number of driver licenses issued. The situation has recently been compounded by the closures and loss of revenues due to COVID-19.Further depletion of the fund would create the need for drastic cuts to services provided to Colorado residents.

Despite the change, Colorado licensing fees will still be lower than most other states. Prior to this change, the DMV last adjusted its licensing fees by \$1 from \$27 to \$28 in 2018. For more fee information, please visit www.colorado.gov/dmv/dmv-fees.

Additionally, Coloradans seeking DMV services are strongly encouraged to #SkipTheTripCO and use any of the DMV's 35 online services at www.myDMV.Colorado.gov.

Coloradans who need in-office-only services should visit www.myDMV.Colorado.gov to schedule appointments. It's easy to set up your visit, just click "Driver/ ID Services," then select "Schedule an appointment".

However, for the general public, rather than targeting and staying away from a specific location or business, the best strategy to avoid infection is to assume the virus could be anywhere, anyone can have it, and even you yourself may be infectious and take precautions. Tree watering necessary during drought conditions

SOUTHWEST COLO. June 22, 2020 – Despite occasional showers in certain areas of southern Colorado, persistent drought conditions have parched the soil over much of the southern part of the state, stressing even irrigated lawns and larger landscape trees. During these periods of drought, homeowners should consider supplemental watering to keep their trees healthy.

"Adequately watering your trees is the best way to ensure optimum growth and vigor during the summer months,' said Donna Davis, urban and community forestry specialist for the Colorado State Forest Service.

"Drought-stressed trees become susceptible to root and branch die-back and subsequent insect and disease problems."

All of southern Colorado is currently experiencing some form of drought, in many places "severe" and "extreme," according to the latest data from the National Drought Mitigation Center.

The CSFS offers the following tips to keep trees healthy during summer drought:

_Mulch. Mulch is an inexpensive solution to retain soil moisture and save water. Apply 4 inches of organic mulch onto bare soil within 2 to 3 feet from the base of the trunk (removing any grass

first, if necessary). Do not allow the mulch to directly contact the trunk.

• _Water a wide area. Tree root systems may spread much wider than the height of the tree, with most absorbing roots in the top foot of soil. Apply water to soak the entire area underneath the full span of a tree's branches.

_Water slowly. To ensure soil penetration, use a deep root fork (inserted 8 inches or less), soaker hose on low setting or soft spray wand to apply water gradually to the full area.

• _Keep the yard green. Trees located in irrigated lawns generally do not require additional water, as long as the area surrounding the tree receives adequate moisture. Conversely, a dry, yellowish yard means the roots of any trees present are also dry.

_Provide enough water. For trees 1-3 inches in diameter, apply 10 gallons of water for each inch of tree trunk diameter once a week. For medium-sized trees, those 4-9 inches in diameter, apply 10 gallons of water for each inch of trunk diameter three times a month. For larger trees over 10 inches in diameter, apply 15 gallons of water for each inch of trunk diameter twice a month.

_Focus on new and non-irrigated trees. Water newly planted trees and seedlings more frequently than once a week, following the rates listed above, as they have lessextensive root systems. To avoid stress during drought conditions, trees that do not receive water from sprinkler systems or irrigation can also benefit from additional water.

COLORADO STATE UNIVERSITY **Rio Grande National Forest offers free** personal-use firewood

MONTE VISTA – The Rio Grande National Forest is extending its availability of free personal-use firewood cutting to the general public through December 31, 2020. The free-use authorizations are for personal use only and exclude commercial purposes. Forest users are required to comply with all Forest regulations and normal permit requirements, even when collecting forest products under the free-use allowance. Actions that damage the resources are strictly prohibited. These free-use authorizations are valid for cutting up to a maximum of 20 cords of personal-use firewood. A cord is the amount of tightly piled wood in a stack four feet

high by four feet wide by eight feet long. The authorization letters are limited to one per household and only individuals that are 18 years or older may participate in the free personal-use firewood program.

The Forest is providing free-use firewood authorization letters to the public in the following ways:

This program will end December 31, 2020, when normal firewood procedures will resume.

Conserving water during drought and dry periods

Weather can be unpredictable. Carefully developed plans for days spent in the great outdoors can be derailed by unexpected rainstorms, while sudden bursts of sunshine can turn overcast afternoons into chances to get outside and breathe some fresh air.

Lawn and garden enthusiasts know just how mercurial Mother Nature can be, especially during summer. The specter of drought looms every summer, but the National Weather Service's Climate Prediction Center does not anticipate any broad-scale areas of drought developing in the Lower 48 states in 2020. While that's good news for lawn and garden enthusiasts, it's wise to remain prepared for drought.

In recognition of the difficulties drought can pose, the Environmental Protection Agency offers the following tips to homeowners to ensure that water is available to meet critical needs.

· Learn local regulations. During dry periods and droughts, local water utilities put restrictions in place. These restrictions are not meant to be nuisances, but designed to ensure water is available to fight fires and meet other critical needs. Adhering to these guidelines, no matter how difficult they can be, helps your community stay safe. Periodically visit local water utilities' websites to learn if there are any restrictions in place.

• Inspect fixtures for leaks. Conservation is the goal of water restrictions. Leaky fixtures compromise conservation efforts, so inspect all interior and exterior faucets and pipes for leaks and fix them immediately.

Look into upgrades. Upgrading outdated bathrooms and other water features can be a great way to conserve water without changing daily habits. For example, the EPA estimates that water-conserving toilets can reduce water consumption by as much as 60 percent each year. That saves consumers money while also helping them to conserve during droughts or periods of dryness.

Water wisely. The EPA notes that experts estimate that as much as 50 percent of the water we use outdoors is lost to evaporation, wind or runoff due to overwatering. The EPA recommends watering primarily in the early morning and evening, after the sun goes down, so less water is lost to evaporation. If you have an irrigation system that uses a clock timer, consider replacing the timer with a WaterSense labeled irrigation controller, which acts like a thermostat for a sprinkler system, using local weather and landscape conditions to tell the sprinkler system when to turn itself on and off.
