This never deterred her from family, career, or helping others. Jeanne "Gigi" was born to Dr. Alfonso E.L. Darricades and Catherine Visart Mullin Darricades on December 29,

Chile. She spent her early childhood in Chuquicamata. Gigi attended and graduated from Bishop Strachan Boarding School in Toronto, Ontario, Canada. Gigi moved to California and attended De Anza Jr. College, then UC Berkeley where she earned her Bachelors of Arts Degree in Political Science ('74). She obtained her Master's Degree in Public Health ('76) at UC Berkeley, thus following her father's passion for

She began her career in rural health care in New Mexico, establishing clinics in western New Mexico.

community health.

In 1978 she moved to Gallup, New Mexico as Administrator of the McKinley General Hospital after working in Ālbuquerque as the Assistant Regional Administrator for the Presbyterian Hospital Center. It was there that she met the love of her life, Mike Gibson. They moved to Salt Lake City, Utah, in 1981 where she joined Intermountain Health Care Inc. serving in various capacities, including Director of Medical Affairs. While in Salt Lake City she earned her Juris Doctor from the University of Utah, and subsequently was admitted to the Bar in New Mexico, Wyoming and Colorado. Mike and Gigi moved to Gillette, Wyoming, where she practiced Health Care They moved to Colorado in 1997, first living in the City of Craig where Gigi practiced Health Care Law. Gigi and Mike then settled in the City of Alamosa in 2000, and Gigi continued to practice Health Care Law. She subsequently practiced Environmental Law, becoming an expert in Land Conservation Law, representing the Rio Grande Land Trust and numerous private landowners.

In 2011 she was appointed President and CEO of Valley-Wide Health Systems, again returning to her passion of rural health care. In this capacity, she and her Management Team added clinics to the organization in San Luis, Antonito, Monte Vista



and Canon City. new Canon City Health Center was dedicated to Gigi on June 11, 2019. She served as an Officer on a number of statewide boards, including the Medicaid Provider Rate Advisory Committee, Colorado Foundation for Universal Health Care, Colorado Community Managed Health Care Network, and Colorado Community Health Net-

The latter organization recognized her contributions by naming her the CHAMPS 2018 Stanley J. Brasher Legacy Award Winner, recognizing her dedication to solving problems of health, poverty, and human rights. In 2020 the organization declared March 6th. Gigi Darricades Day, stating that "She had earned the admiration and respect of her colleagues and staff for her dedication, professionalism, leadership, enthusiasm, fabulous sense of humor, and

a legal mind with a big heart". She retired from Valley Wide in 2019.

In Alamosa, she embraced the community by serving on several Boards including KRZA, the community radio station, the San Luis Valley Immigrant Resource Center, Adams State College, and the San Luis Valley Federal Bank. She was a supporter of nonprofits, including La Puente, the San Luis Valley Animal League and the Boys and Girls Club, the Rio Grande Headwaters Restoration Project, and the

Rio Grande Land Trust. Gigi enjoyed traveling with Mike as they visited England, Africa, Cuba, and Canada. While in New Mexico she fell in love with ballooning and in Utah she obtained her Commercial Hot Air Balloon Certification. She and Mike participated in numerous balloon rallies and they organized a trip to England to fly there with friends. She also loved challenges on the ground and enjoyed White Water Rafting.

Gigi's love for animals gave her much joy always having dogs and cats in her life. At the time of her death, her animals were close by. The cats were Coco and Pixie and the dog Lady, who she enjoyed walking along the nearby Rio Grande.

In addition to her parents, Gigi is preceded in death by her sister Irene "Renee" Cox, husband of niece Stephen Sproule and great-nephew

Danny Sproule. is survived by her husband of 38 years, Mike Gibson. Also surviving Gigi is her sister Constance "Tonton" (Edwin) Baumgartner of Merced, California, brotherin-law Sandy Cox of Langley, B.C. Canada, sister-in-law Miriam (Simon) Richardson of Bedford, England. # Fill the van

La Puente AmeriCorps Vista ALAMOSA—Across the San Luis Valley, there is a network of 15 food pantries. Each one shares a vision to serve each person who has a need for them. During this time of COVID 19, these small pantries have seen a major increase in need, with many more families that have come for the first time in March of this year. With only two paid staff, La Puente's Food Bank Network depends on over 60 volunteers to run the day-today operations of these food pantries. None of them are paid. They have chosen to continue to serve their communities, often in innovative ways. The people they serve are their friends and

tirelessly to ensure their clients are well-fed. Sherice Shiner, the Healthy Communities Organizer for the Food Network Bank of the San Luis Valley, has said about her work "I have the privilege to work with these amazing people, every day, every week... I'm in the big green van that you see zooming around town. Every week I work to make sure these outlying pantries have enough fresh produce, bread, dairy, and canned goods to keep going.'

With recent community support, La Puente was able to purchase a semi-truck load of food to help ensure these panties have enough food to keep up with the increase in demand. But food is not all the food pantries need to actually help ensure our neighbors are With an increase

in food pantry customers, there has also been an increase in the need for cardboard boxes, plastic bags, and egg cartons to help carry their emergency food home.

This is why La Puente has

decided to host their annual Fill the Van event as part of their Hunger Education Week, though it will be held in a different way than in the past. The event will take place at the corner of 6th and State, in the parking lot by the Alamosa Food Bank. Volunteers will be stationed by the iconic green van to accept donations and take pledges to volunteer with local hunger relief efforts. Donations can be as simple as. If you wish to donate your time instead the food bank could always use more of La Puente volunteers. They are asking for help from the community to make this event a success. Their goal is not only to help the Food Bank but also to bring together the community during this time of crisis and

WASHINGTON - While taking active measures to protect the public and employees and minimize exposure to COVID-19, the Bureau of Land Management (BLM) continues to reduce hazardous fuels across the West and Alaska and to plan for the upcoming fire season by maintaining and strengthening firefighting capabilities. In conjunction with Federal, state, and local partners, the BLM will use its full suite of resources to prevent and suppress wildfires as the agency adjusts to rapidly changing outbreak circumstances.

"We are committed to protecting our colleagues in the BLM and those with whom we come in contact during this challenging time; however, as westerners we know we must fight fire all year long and we will do exactly that," said BLM Deputy Director for Policy and Programs William Perry Pendley. "Guided by the Center for Disease Control and Prevention as  $well as \, state \, and \, local \, health \,$ authorities, we continue to implement proactive CO-VID-19 measures to protect employees and the public, but, when it comes to fire, we havenointention of standing down.'

Every year, the BLM works with its Federal, state, andlocalpartnerstoconduct initial attack on all wildland fire incidents to suppress wildfires as soon as they ignite. Aggressive initial attack is the single most important method to ensure the safety of firefighters and the public; it also limits suppression costs. During the COVID-19 outbreak, the wildland fire agencies will continue to work to suppress wildfires with the goal of reducing wildfire size and intensity.

The BLM is also working with its Federal, state and local partners to develop specific COVID-19 wildfire response plans to provide for wildland fire personnel safety. These plans outline best management practices

to limit the spread of the virus and to provide a safe working environment for all wildland fire personnel.

The wildland fire agencies maintain a full aviation fleet to suppress wildfires and concurrently plan for above-normal fire activity with additional contract and partner surge capacity. The BLM will have on contract 34 Single Engine Airtankers (SEAT), combined with four water scoopers, seven smokejumper planes, 19 tactical support aircraft, and 25 helicopters for wildfire suppression efforts this year. In addition, the BLM has access to more than 660 helicopters, 100 SEATs, 14 Large Airtankers and Very Large Airtankers, 22 water scoopers and over 400 tactical support aircraft through partnerships and call-when-

needed contracts. The BLM Fire and Aviation program works closely with, and relies on, its state and local partners for all wildfire suppression efforts. During the COVID-19 outbreak, some state governments have declared they will not permit state and local resources to respond to wildfires outside of their local jurisdiction, which will greatly limit the national response capabilities of these valuable resources. The BLM is working with these governments to address concerns and to ensure, to the greatest extent possible, that shared resources are available to be deployed wherever need may be greatest.

 $\hbox{``In order to ensure smooth'}$ interstate wildfire suppression operations, all wildland firefighters must be permitted to cross state boundaries without restriction to ensure safe and effective wildfire operations throughout the country," said Pendley. "We beseech our federal, state, and local partners to ensure that ability.

The BLM will also rely on its employees across the nation who are not full-time fire personnel but maintain essential wildfire qualifications and thus provide

critical wildfire response capabilities during heightened fire activity. These employees greatly augment the national fire workforce every year; therefore, the BLM will continue to enhance its workforce with these personnel during the COVID-19 outbreak. The BLM and its partners will also work closely with contractors, emergency hires, and other seasonal employees, as the BLM does every year, to greatly enhance firefighting

Overall, wildfire suppression operations will require adjustments and new tactics during the COVID-19 outbreak. Fortunately, the BLM and its partner agencies are skilled in aggressive initial attack operations, as limiting wildfire spread is always paramount, no matter the situation. The BLM and its partner agencies are prepared for wildfire response and will work to suppress all wildfires before they become large, problematic incidents.

# Seasonal closure for the west side of Valle Vidal area goes into effect May 1

TAOS, NM-The seasonal closure for the west side of the Valle Vidal area of the Carson National Forest will begin on May 1 and will continue through June 30. The Carson National Forest closes this special area every year to provide a suitable habitat for elk calving.

The designated roads will remain open for travel. However, visitors to the area will not be permitted to go off the road or leave their vehicle. In addition, camping in the area will not be allowed.

During May and June, elk cows seek areas for calving that have suitable cover and forage. Disturbances, such as human interaction, can cause the cow to abort or abandon her calf. Once the cow calves, mother and calf will remain in an area for about 10 days or until the calf is strong enough to follow the cow to higher country. Forcing a cow elk to a less adequate site for birthing can result in a weakened calf with less of a chance for survival.

Visitors traveling to the adjacent Rio Costilla Park should be aware that the park is closed until May 15. Contact Rio Costilla Park directly at 575-586-0542 or check their website at www.riocostillapark.com for more information.



Nielsen. Shares of Beyond Meat, a prominent plantbased meat brand, rallied by 60 percent.

A Washington Post investigation found that coronavirus outbreaks in more than 48 U.S. meatpacking plants have sickened at least 3,300 workers and killed 17. The companies failed to provide adequate protective gear to the workers and forced some with Covid symptoms to keep working. USA Today reports that more than 150 of U.S.'s largest plants operate in counties with the highest rate of coronavirus infection.

In addition to the generally accepted consumer


Regretfully, a large gathering is not allowed, instead they are being asked to participate in the procession, which will drive past Chris's family,

Information Director **ALAMOSA** — In what was a season that abruptly ended less than 24 hours before the National Championship meet in Sioux Falls, SD, one could only speculate as to who would be National Champions and earn All-America honors, as qualifiers did not have the chance to compete against the best in Division II.
