Grant will fund construction and operation of San Luis Valley Animal Center

DENVER — Animal Assistance Foundation has awarded a \$350,000 grant to support San Luis Valley Animal Center, a new animal shelter that will be built and operated by the Dumb Friends League in Alamosa County, CO.

Fire restrictions are imposed

Stage 1 in Alamosa County

ALAMOSA — Stage 1 fire restrictions were put in place Wednesday by County Sheriff Robert Jackson and will continue for one week, through April 22. This includes agricultural burning.

Both Conejos County and the Rio Grande National Forest are under Stage 2 fire restrictions.

Fire restrictions help land management agencies reduce fire risk and prevent wildfires during periods of high to extreme danger.

Prohibitions under Stage 1 include building, maintaining or using a fire, campfire or stove fire, including charcoal barbecues and grills, except those using certain permanent fire pits and some items using gas, jellied petroleum and pressurized liquid fuel.

San Luis Valley looks to flatten curve

SAN LUIS VALLEY — SLV Emergency would like to thank everyone for continuing to do their part to slow the spread of COVID-19 in the San Luis Valley. It is working. The SLV have no new cases today. The total of confirmed cases so far in the San Luis Valley is 22. Thirteen cases have completed their isolation period and have been free of symptoms for more than 72 hours. Further details on San Luis Valley case counts, as well as a link to the SLV Symptom Tracker Survey, can be found at www.slvemergency.org/ slv-covid-19.

It is understood that this is not easy. Whether following stayat-home orders that apply to everyone, or following the more restrictive guidelines for quarantine and isolation, it can be difficult to be separated from others and to have routines disrupted.

If you have been exposed to someone who may have COV-ID-19, you should not leave home for 14 days, except to receive necessary medical care as directed by your doctor. Emotional reactions during quarantine and after coming out of quarantine

may include:

Guilt about not being ableto perform normal work or parenting duties during quarantine

Stress from the experience of monitoring yourself or being monitored by others for signs and symptoms of COVID-19

Fear and worry about your own health and the health of your loved ones

Sadness, anger, or frustration because friends or loved ones have unfounded fears of contracting the disease from contact with you, even though you have been determined not to be contagious

Mixed emotions, including relief after quarantine Other emotional or mental health changes

Children may also feel upset or have other strong emotions if they, or someone they know, have been on quarantine. These reactions are normal. If you need support, reach out to San Luis Valley Behavioral Health Group at (719) 589-3671.

Second arrest in Cuevas-Garcia death

PUEBLO — KKTV is reporting that a second person was arrested in the disturbing case of where a Colorado man is accused of murdering his own mother, stuffing her body in a suitcase and throwing the suitcase in a dumpster in Pueblo.

On Thursday, Pueblo Police announced the arrest of 36-year-old, Melanie Cuevas. She was picked up by authorities Thursday morning in Monte Vista and is facing a charge of accessory to first-degree murder. Police continue to ask anyone with information on this case to contact (719) 320-6022.

The victim, whose remains were found in a trash bin in the area of Ivywood Lane and Vinewood Lane on Oct. 17, was identified by the Pueblo County coroner Oct. 21 as Maria Cuevas-Garcia. Authorities did not immediately announce how they tied Melanie to the case. Melanie Ann Cuevas, Anthony's wife, was also arrested Oct. 18 for a criminal impersonation warrant. Antonio Cuevas, already wanted on a parole violation, was arrested Oct. 18. Police confirmed to 11 News that Cuevas is the victim's son.

HobbyTown USA added to city register of historic places

ALAMOSA — For the second time Alamosa City Council held their bi-monthly meeting by Zoom webinar. The council voted unanimously to add Hobbytown USA's current location at 709 Main Street as a historic place within the Alamosa City Registry. The council also discussed topics including Riparian Park, a mobile stage and the reappropriation of funds to a Master Utility Infrastructure Plan. All of which got approved.

Hobbytown USA just recently moved to their current location from the Villa Mall this past winter. After settling in Hobbytown USA's owners Matt and Tammy Abbey applied for the designation. Following review by the Historic Preservation Advisory Committee it was recommended for review by City Council. The resolution passed on first reading with an unopposed 7-0 vote.

Wearing a homemade mask in public can help prevent the spread of COVID-19. Social media represents friends and neighbors cheerfully sporting their masks to do their part, and for that many are grateful. But not everyone experiences this recommendation in the same way. One thing that is especially common during disease outbreaks is increased stigma. According to the Centers for Disease Control Center for Preparedness and Response, "Stigma can affect people, places, or things. It occurs when people associate a risk with something specific—like a minority population group—and there is no evidence that the risk is greater in that group than in the general population." For people of color, racial bias and stereotypes of criminality have created real fears about going out in public with a face covering. There have already been accounts of people of color being removed from stores for wearing masks and many fear for their lives. Because of this threat, some people of color have chosen not to wear masks in public, which has created the equally inappropriate response of shaming them for not doing so. Remember that these are difficult times for everyone and we are all in this together.

Smoking is also prohibited except in an enclosed vehicle or building, a developed recreation site or while in an area at least three feet in diameter that is barren of flammable material.

Other restrictions apply relating to use of chainsaws, welding and use of explosives. Stage 2 prohibits all of the same,

but also includes use of fire in developed camping and picnic grounds. Sheriff Jackson said his seven-day

fire ban will remain in effect through at least April 22 unless the area receives significant moisture. His decision was based on the advice of local fire experts citing dry fuel (vegetation, etc.) conditions and nearly daily Red Flag Warnings due to high winds.

"There is no exception for agricultural burning," Jackson said, "so if they haven't burned already, they're going to have to wait until we get moisture or at least seven days.' He added that the word hadn't

adequately gotten out on Wednesday resulting in several fires north of town.

In a daily update from SLV Emergency, residents were reminded "If you reside in a county that does not currently have fire restrictions in place, please ensure you check the weather prior to burning and do not burn on a day with a red flag warning. Also, consider not burning at this time for the air quality concerns for those who have a chronic or acute respiratory illness.

Dear patients and families:

Rio Grande Hospital and Clinics wants to assure our patients and community that we are closely monitoring and responding to the COVID-19 pandemic. We are doing our best to protect and serve you and our community. We are writing this letter to update you on what is happening at Rio Grande Hospital and the things you can do to prepare yourselves and your family.

The Rio Grande Hospital Clinics have expanded our services to offer telemedicine (telehealth) to limit the risks of in-person visits, especially for high-risk patients: this includes anyone over the age of sixty-five or those with underlying medical conditions including but not limited to asthma, COPD, heart disease, advanced kidney disease or

COVID-19 planning may be different than what you are used to for several Most people who get COVID-19 have

mild to moderate symptoms and can be treated at home. Those who do have a severe case are

often older and sicker, and symptoms often progress rapidly.

Some people with COVID-19 may become so ill they need a breathing machine for many weeks in the ICU. Even with this support, many people will not survive.

We hope by now you have heard all the ways you can protect yourself, but here is a reminder.

Practice physical distancing. Maintain a six-foot distance from other people and wear a mask when out in public. Practice good hand hygiene.

Don't touch your face with unwashed hands Reach out and support neighbors,

friends, and family who may be more susceptible to this infection. Stay informed of guidelines from the de-

partment of public health and government. What you can do to plan ahead in case you do require hospitalization due to COVID-19:

Choose a Medical Decision maker (or "medical power or attorney")

This person will speak for you if you cannot speak for yourself. He/she will make sure your doctors know about the care you want

A good medical decision maker is someone who:

Knows you, your values, and your wishes

You trust to follow your wishes and what is best for you

Is available to talk to your doctor and care team by phone

Talk to your medical decision maker and let him/her know your wishes. This is the most important step. If you know what you want for your medical care, share this now.



Where is god in covid crisis? That's part of the story

Queen Elizabeth II has seen more than her share of good and evil during her 68 years on the British throne.

Candles shining in the darkness just before Easter are familiar symbols of the presence of good, even in the hardest of times, said the 92-year-old queen in a

recent address about a single subject affecting her people: the coronavirus crisis.

"Easter isn't canceled. Indeed, we need Easter as much as ever," she said. "The discovery of the risen Christ on the first Easter Day gave his followers new hope and fresh purpose, and we can all take heart from this. We know that coronavirus will not overcome us. As dark as death can be -- particularly for those suffering with grief -- light and life are greater."

An ancient question loomed over the queen's remarks: Where is God during this global pandemic that threatens the lives and futures of millions of people?

Theologians have a name -- "theodicy" -- for this puzzle. One website defines this term as "a branch of theology ... that attempts to reconcile the existence of evil in the world with the assumption of a benevolent God."

In his book "God in the Dock," the Christian apologist C.S. Lewis of Oxford University argued that "modern man" now assumes, when evil occurs, that God is on trial. This process "may even end in God's acquittal," he noted. "But the important thing is that Man is on the Bench and God is in the Dock.'

This tension can be seen during news coverage of tragedies, wars, disasters and pandemics. Ordinary people

involved in these stories often address "theodicy" questions, whether journalists realize it or not. This is a pattern I have observed many times -- since this past week marked my 32nd anniversary writing this nationally syndicated "On Religion" column. The late Peter Jennings

of "ABC World News Tonight" noted that, whenever news teams cover disasters, reporters often **Terry Mattingly** ask questions that sound like this: "How did you get through this terrible experience?" Survivors frequently reply: "I don't know. I just prayed.

> have made it." What happens next, Jennings once told me, illustrates the gap that separates many journalists and most Americans. There will be an awkward silence, he said,

and then the reporter will say something

like, "That's nice. But what REALLY got

Without God's help, I don't think I could

Here we go again. The COVID-19 crisis will, for many ordinary people, raise unavoidable questions about darkness and light, evil and good. Journalists will have to face this, since we are dealing with one of the biggest stories of our era.

How big? We don't know yet. However, I believe that -- depending on the final death toll -- this could be the biggest global "theodicy" story since World War II. The health and financial toll will cause many people to reject God, while others will dig deeper into their faith traditions. It's crucial that journalists see the

personal faith issues in this crisis, rather than thinking in "impersonal" terms about major historic events, like the Black Plagues or the Holocaust, said Russell Moore, leader of the Southern Baptist Convention's Ethics and Religious Liberty Commission in Nashville and Washington, D.C.

With Sept. 11, he said, it was easy to see parallels to Pearl Harbor and other acts of terrorism -- events that affected our parents and grandparents. "So journalists may have been rattled" by terrorism, he said, "but they knew where they thought

that story was going to go. They had seen this before.

Now, the world faces a disaster that resembles plagues of the past, combined -- potentially -- with a major economic depression, said Moore. It's a story that "no one really expected and nobody really knows how this will end."

For religious believers, this crisis

is causing a kind of grief and lamenting that "is truly unique and very personal" since, in their attempts to fight the virus, they can't even come together in worship to share their questions, pain and suffering.

The church has been through things like this in the past, and we see that in scripture and in our hymns and in church history," said Moore. "What many people are struggling with is trying to understand that something like this could happen in our world today -- in 2020."

Charitable giving can come in the form of volunteerism as well. The National Philanthropic Trust says approximately 25 percent of the adult population volunteers their time. Americans contribute what would equate to \$193 billion of their time to various efforts.

Know Your Enemy, Win the War

The Bible teaches us about spiritual warfare and that we have an enemy, the devil. I Peter 5:9 say to resist the devil and stand firm in our faith in God. And Ephesians 6 tells us about the armor of God that helps us overcome our struggle "against the powers of this dark world and against the spiritual forces of evil in the heavenly realms" (v. 12 NIV).

Some people deny the existence of the devil and of hell. They don't believe a loving God would really send anyone to a place of eternal torment. But the Bible teaches us that we do have an enemy and there is a place called hell, so we're deceiving ourselves if we refuse to believe it.

The Bible also says that God is patient, "not wanting anyone to perish, but everyone to come to repentance" (2 Peter 3:9). And John 3: says, "For God so loved the world that he gave his one and only Son, that whoever believes in him shall not perish but have eternal life.

The Truth About Our Enemy

An effective strategy to gain victory over any enemy is to know who he is and how he operates. The Bible has a lot to say about the devil. John 8:44 (NIV) says, "He was

a murderer from the heginning, not holding to the truth, for there is no truth in him. When he lies, he speaks his native language, for he is a liar and the father of lies." And 1 Peter 5:8 tells us to "be alert and of sober mind. Your enemy the devil prowls around like a roaring lion looking for someone to devour.

Deception is the devil's primary strategy to keep us from growing spiritually and fulfilling God's purposes for our lives. To be deceived simply means you believe a lie. This is dangerous because if you believe a lie. then it will become your reality even though it isn't true. For example, you can believe someone doesn't like you and be upset about being rejected when the truth is they haven't thought one

bad thing about you. Everyone is affected to some degree

by lies they believe. I used to believe I would be able to have a second-rate life because my father had sexually abused me and I was "damaged goods." If I hadn't come to know the truth about God's love for me and how He could heal and restore my soul, my life would be much different than it is today. I seriously doubt I ever would have become a Bible teacher who is helping others discover how they can know God and become everything He has created them to be in Christ.

We need to pray for God to reveal any deception in our minds because every lie we believe represents something the devil is stealing from us that God wants us to have. I'm talking about real peace and joy, freedom from constantly feeling guilty about something you've done, the ability to have healthy relationships, or any of the other promises God gives us in His-

Be Liberated by the Truth

Our thoughts are so important, and that's why I teach about the "battlefield of the mind." We need to be more diligent to think about what we're thinking about and choose on purpose to think in ways that line up with God's Word, Jesus said, "If you abide in My word...you are truly My disciples. And you will know the truth ... and the truth will set you free" (John 8:31-32 AMP).

The key here is to "abide" in God's Word. To abide means to live and remain in it. As we spend time each day meditating on Scripture, rolling it over and over in our minds, we will gain freedom from wrong mindsets and Here's a practical way to apply this

principle. The next time you're feeling discouraged or having a pity party, ask yourself, "What have I been thinking You've likely been molling over thoughts about what people don't do for you, what you don't like about yourself, what you don't have...and on and on.

The solution to turning your attitude around is by thinking about God and what He says about you.



Romans 5:8 says God loves you unconditionally and that while you were still a sinner. Christ died for you. Psalm 139:14 says that God created you by His own hand in your mother's

womb and you are wonderful.

Ephesians 2:10 says you are "God's handiwork, created in Christ Jesus to do good works, which God prepared in advance" for you to do.


And Romans 8:37-39 says you are more than a conqueror through Christ, and there is nothing that can separate you from God's love.

Great Sand Dunes National Park and Preserve Closed Until Further Notice

MOSCA – Great Sand Dunes National Park and Preserve is announcing additional modifications to operations in response to a request from the Alamosa County Public Health Department. The health and safety of our visitors, employees, volunteers, and partners is our number one priority.

Effective Friday, April 17, at midnight, Great Sand Dunes will be closed to all park visitors until further notice. This closure includes all public access points, park roads, and backcountry access. We will notify the public when we resume full operations and provide updates on our website www.nps.gov/grsa and social media channels.

"We have been monitoring conditions at the park and working closely with the local public health officials," stated Park Superintendent Pamela Rice. "Due to increasing visitation, we can no longer mitigate the risk of exposure to the novel coronavirus and agree that it is in the public's best interest to close at this time."

Despite stay-at-home orders across the country, Great Sand Dunes continues to see increasing visitation, crowding, and a high percentage of out-of-state visitors. A park closure will align with the county's request to further minimize the risks associated with the novel coronavirus and not compromise the local healthcare system.

"As a former park ranger at the Great Sand Dunes, it gives me no pleasure to recommend closure of one of our national treasures, even for a brief period of time," Alamosa County Public Health Director Della Cox-Vieira said. "However, it is my duty to protect the people of Alamosa County during this pandemic, and that includes the staff of Great Sand Dunes National Park and Preserve and any potential visitors."

Rice added, "We look forward to the day when we can welcome visitors once again to enjoy the amazing resources and recreational opportunities at Great Sand Dunes."


However, for the younger grades where hands-on learning is still very important, Sanford Schools has found a way to minimize risk to those students picking




