Russell to present on Secretariat, cranes supporting Jocelyn's art career

hometown artist, Jocelyn Russell, will be presenting an encore slide show at Society Hall in Alamosa, CO on Sunday, March 15th, at 4:00 p.m. The presentation will highlight the completion and installation of the largest Secretariat bronze monument ever sculpted.

In addition, Jocelyn will share a sneak peek at the new largerthan-life Crane Monument she is currently sculpting on behalf of the GFWC Woman's Citizenship Club. The club has initiated funding to cover the foundry cost and Jocelyn will donate her time to the project.

This enterprise is a thank you to the people of the San Luis Valley for following and since childhood. A small clay sculpture of the crane monument will be on display for the presentation.

The dynamic Secretariat monument depicts the racing legend with Ron Turcotte astride, crossing the finish line in the Kentucky Derby win of the Triple Crown in 1973. The iconic team set the track speed record for all three of the famed races, including the Belmont race with an unprecedented 31 length victory.

The monument was commissioned by Triangle Foundation in Lexington, Kentucky, and cast and completed at the Crucible Foundry in Norman, Okla.

Leadership Summit is April 7 Women's

ALAMOSA – The inaugural San Luis Valley Women's Leadership Summit, with proceeds to benefit women studentathletes at Adams State University, will be held on Tuesday, April 7 at the Adams State Student Union

Building. The event will feature Colorado Department of Higher **Education Executive** Director Angie Paccione, Ph.D., and Margaret J. Matson Norris, Ed.D., a national expert whose work has led to establishing and maintaining a positive school culture and creating safe learning environments.

San Luis Valley Health CEO Konnie Martin, Alamosa County Administrator Gigi Dennis, and Adams State President Cheryl D. Lovell, Ph.D., are among a group of panelists who will also address participants. Other panelists are Dee Ann Espinoza, CEO of Espinoza Consulting, and Jaime Green, head women's basketball coach at Adams State. Wendi Seger, Ed.D., owner of Locavores restaurant, will moderate the panel discussion.

Adams State Athletic Director Larry Mortensen formed a committee to plan the women's leadership summit as a way to recognize and support women's athletics at Adams State, and Adams State plans on making it an annual event to "empower and inspire women to recognize, embrace, and act on

their full potential." "Adams State and the San Luis Valley have many strong female leaders who have contributed a great deal to the growth and development of our area, said Mortensen. "The committee for the SLV Women's Leadership Summit hopes to provide resources and inspiration to all women and help them recognize their potential to become influential leaders in their communities

and organizations." The cost to attend is \$50 per person. Money raised from the event will go toward scholarship support for women athletes at Adams State. Individuals can pay to attend by texting the words Summit2020 to 71777. Or email Adams State Associate Athletic Director Kateyln Smith at

Registration begins at 9 a.m. followed by a welcome address by Norris, an educational leader who combines the experience she gained as a scholar and practitioner of the 20th Century with the wisdom and knowledge she has nurtured as a lifelong learner, researcher and consultant of the 21st Century.

Keynote Speaker Dr. Angie Paccione

The keynote speaker, Dr. Paccione, executive director of the Colorado Department of Higher Education, has more than 20 years of experience in secondary and postsecondary education. She was a high school teacher, coach and administrator at Smoky Hill High School in the Cherry Creek School

District before earning a Ph.D. in education and human resource studies from Colorado State University. There, Paccione served on the CSU faculty for nine years as a teacher educator in the "Project Promise" program, a nationally recognized program of excellence in teacher preparation for mid-career professionals. She also conducted research in the teacher education field, examining educators' life events that led them

to become committed to issues of diversity and inclusion. Her findings informed a teacher preparation program and were later published in Teacher's College Press, which has been cited in over

75 academic papers. Paccione left higher education to pursue public service and was elected to two terms in the Colorado House of Representatives, rising to become house majority caucus chair. She served on the Education Committee during all four years in the legislature, helping guide the education environment for the state of Colorado. In 2006, she ran for U.S. Congress

and came within 2.5

percent of unseating

the incumbent. From 2007 to her appointment as executive director, Paccione worked for Verus Global where she specialized in the areas of leadership development, diversity and inclusion, talent development and change management. She has worked with leaders from the shop floor to the C-suite in 40 countries and all 50 states. Paccione has also co-authored two books on leadership: One Team: 10-minute Discussions that Activate Inspired Teamwork; and Do Big Things: The Simple Steps Teams Can Take to Mobilize Hearts and Minds, and Make an Epic Impact.





Local groups provide Dr. Seuss books

ALAMOSA - In celebration of Dr. Seuss' birthday on March 2, Seussloving adults from three agencies have collaborated to collected 100 Seuss books to be given out to children who come through the Valley-Wide health system. Each child is given a book to take home with him/her.

"We're deeply grateful for the donation of these books to our Reach Out and Read program. Early reading education is an important part of childhood development, and we're pleased to be able to provide free books to children in our community," says project coordinator, Julie Nuanes. Reach Out and Read (ROR) is a national campaign launched in 1998 by the then First Lady Hillary Clinton. Shortly after that, Valley-Wide Health Systems was selected to participate in a ROR pilot project. We are happy that 21 years later, Valley-Wide's ROR program is still going strong.

In 2019 alone, more than 3,700 books were given to patients from infancy to age 5 during their well child checkup

and dental clinic waiting rooms, WIC clinic waiting rooms, local Head Start programs and at community outreach events. VWHS staff, foundations, community members, and local libraries donated about 3,900 books to the Reach Out and Read program last year."

For the Woman's Citizenship Club, the challenge had been given to them by their umbrella organization the General Federation of Women's Clubs, to collect books to be given to schools and reading programs in their community. Valley-Wide Health Systems and their Reach Out and Read programs was one of their choices.


Russell offered an initial presentation to Valley residents at Society Hall in August of 2018, during the early phase of the project

ALAMOSA — I am a Courier subscriber and this letter is a response to the Renewable Water Resources response, published March 3. Personally, I am undecided on the merits of exporting water from the SLV. It depends.

On one hand, the concerns of agencies and activists is worthy. It is true that initial trans-mountain diversions in other parts of the State have tended to encourage others, and if this happened in the Valley, it could undermine our agricultural character. However, this is not a foregone conclusion, and it should be noted that Valley agriculture has done a pretty good job of depleting the Valley's water resources over in the last 60 years, exporting it in crops that helped to keep the national cheap food policy healthy.

On the other hand, I farmed for over 40 years and side with the opinion that farmers should have options with regard to their property, particularly since farming requires top-heavy capital formation while being inconsistently profitable. A farmer may need to sell some or all of the capital base of the farm to retire, meet medical expenses or move on. In this regard, I sympathize with what Tonner and RWR are proposing. However, based on their recently published response, they have a lot of work to do in articulating the particulars of their project.

Mr. Tonner suggests that RWR came to the Rio Grande Water Conservation District and asked them to "release 2.5% of the confined aquifer water" for Colorado's municipal and industrial (M&I) needs. This is nonsense. The District does not have the authority to release water from the Valley. Any export project will have to go through the State and the Courts. For sure, the District can be a powerful objector in the Courts, and the District can rally opposition in the local population, but to set the District up as the Bad Guy is misplaced, mostly because the District is doing something about the declining aquifers though the sub district network, an effort that is in process and deserves time to work out, even if achieving consensus among a group of farmers can be like herding goats.

Further, Tanner's repeated branding of the District Board as "unelected," seems small minded, in that RWR itself was not elected, nor are the thousands of government agency employees that do a lot of the spadework of administering resources. It would be inefficient, and probably dangerous, to make every government bureaucrat an elected position, a prospect that would make electioneering more important than engineering. The current system works through a kind of block-chain of representation: If you want to change the disposition of government agencies and/or political subdivisions, you need to elect representatives who can, albeit slowly, change the make-up of the bureaucracies-something we are currently seeing on the national level where an effort is under way to "deconstruct the administrative State." ("Be careful what you wish for").

In the case of the District, the Board members are appointed by elected County Commissioners, so if RWR wants to change the make-up of the District Board, the place to start is with electing Commissioners sympathetic to the RWR proposal, and that clearly will require more clarity by RWR as to what they

are actually proposing.

In some of the early presentations by RWR, the export plan stated it would replace the proposed 22,000 acre feet of annual removals with 30,000 acre feet or more. What happened to that? That was the one piece of the AWA plan that differentiated it from AWDI and Stockmans Water Company. This one-for-oneplus proposal could be a good thing for the Valley, in that it would require a pay-it-forward structure in which AWA acquired, say, 90,000 acre feet of historically consumed water and banked that water in Valley aguifers before any acre feet were exported.

Subsequent removals from the confined aquifer drew on that bank when/ if needed, but the bank had to maintain a minimum balance of, say, 60,000 acre feet. Such a proposal would clearly contribute to sustainability of Valley

When Tonner recalls, in any form, the old AWDI and Stockmans arguments that water can be removed from deep (3,000 feet or more) in the confined aquifer without injury to the regime, he takes a foolish step backwards from the

one-for-one-plus proposal made by AWA earlier, and smells like a bait and switch. The confined aquifer was determined tributary in the AWDI case, meaning that there is no unappropriated

water in the Valley and the State maintains a determining interest in meeting Rio Grande Compact obligations, so there is no water that can be "released" or removed without serious proof that there is a one-for-one replacement. One-for-one-plus replacement with an enforceable pay-it-forward provision is the only option that might be worthy of consideration — in my opinion.

As for the economic stimulus to the Valley that can result from a transmountain diversion (TMD) of Valley water, we all understand that water can flow uphill toward money. But the magnitude of the magnetism is often underestimated. A TMD of 22,000 acre feet can be reused to extinction, meaning that on the Eastern Slope, 22,000 acre feet can amplify to 200,000-22,000 acre feet through repeated reuse in M&I systems that are often as low as 10% consumptive in their use.

In some cases M&I users actually have return flows in excess of diversions because of storm drainage capture, promotion of zero-scaping, and fluids introduced to the system in the form of all beverages. In any case, TOM water is worth at least \$10,000 an acre foot, so a TOM of 22,000 acre feet could be worth at least \$200,000,000 in annual revenues in the Denver metro area. So, yes, there are financial opportunities here, and if those in the Valley are willing to sell the historic consumptive use of their water rights at around \$2,500 an acre foot, they are probably selling way too cheap, and should think about offering their water right for closer to \$5,000 an acre foot PLUS a perpetual royalty, perhaps tied, in part, to the land from which the water was removed.

Charlotte Ledonne celebrates 40 years at the SLV AHEC

ALAMOSA- January, 2020 marked Charlotte Ledonne's 40th anniversary as the Nurse Coordinator at the San Luis Valley Area Health Education Center (SLV AHEC). Ledonne's decades of work has made the San Luis Valley a more

healthy and safe place to live. Known for her positive and practical

outlook and organizational skills, she is also a mentor to all who have worked at the SLV AHEC. Her friend and colleague, Lou Ann Cheslock Skinner, sums up her character saying, "It is my privilege to have known Charlotte for over 30 years. In that time, I have been impacted by her optimism, her passion for education and empowerment, and her community involvement."

With too many accolades to list here, a sampling of Ledonne's outstanding areas of professional service include coordinating outreach programs with SLV agencies and institutions including Cancer Screening Assessments and Referrals for health care needs and issues and developing a variety of education classes for health care agencies, providers, and the community. Her education efforts have helped create generations of medical professionals in the SLV.

In relation to supporting those at risk, she teaches a six-week program on women's health issues at the Com-munity Corrections facility and has started a Senior Walk Program. Ledonne teaches nursing students at TSJC and

has served as a preceptor for numerous nursing students from the University of Colorado College of Nursing, Regis University, and Adams State University.

She was pivotal in establishing the San Luis Valley Nightingale event that has honored nurses in the Valley for over 20 years and has been one of a handful of state-wide Nightingale award recipients from the SLV. Ledonne's work has made the greatest impact in the areas of treatment and prevention of HIV/AIDS and Opioid Use Disorder.

Ledonne was an early advocate for those affected by HIV/AIDS, educating health care providers and community leaders on the disease process and how to care for those affected.

SLV AHEC board member Helen Lester remembers her efforts saying, "There was so much fear at that time and she was such a great calming force. She also worked hard to share the humanity of the disease through the quilt project."
Begun in 1987, the NAMES Project

AIDS Memorial Quilt is a national memorial to the people who have lost their lives to AIDS. Weighing 54 tons with more than 48,000 panels it brings both awareness to how massive this pandemic is and comfort to those it has touched.

Ledonne has also served on the National Rural HIV Health Committee, providing input and guidance on rural aspects of care and concerns and has presented at the Regional AIDS Faculty Development Conference in Denver on Mental Health and HIV infection.

Ledonne is on the frontline of the opioid epidemic, working hard to address stigma and effectively provide treatment to people with Opioid Use Disorder. She started the SLV Opioid Naloxone Education Empowerment Distribution (SLV N.E.E.D.), which expands access to Naloxone, an opioid overdose reversal drug. She participates in the Colorado Statewide Naloxone Work Group as well.

Recently, she opened a safe-needle exchange program called SHARRP (San Luis Valley Health Access Risk Reduction Project) in Alamosa, with intentions of expanding the program to other SLV communities soon. The program offers clients who are using injection drugs the ability to prevent the spread of HIV and Hepatitis Cthrough free sterile syringes, along with access to other services. Her response to the opioid epidemic is just the latest in her many years of championing the needs of those at risk in the Valley.

In addition to her extensive professional contributions, Ledonne serves the health of the SLV through diverse voluntary service. She supports myriad organizations like La Puente Home, the

Alamosa County Public Health Department, the Narrow Gauge Book Cooperative, KRZA community radio, the SLV Boys and Girls Club, the SLV Women's march, SLV Pride, the ASU Friends of Music, the Alamosa Live Music Association, the SLV Cancer Relief Society, the Rio Grande Headwaters Land Trust, and the Rio Grande Farm Park (RGFP).

Speaking about her service to the community, the former director of the RGFP, Julie Mordecai said, "Charlotte has been a consistent and caring volunteer for the RGFP since its inception. She is always willing to lend a hand and has been a stalwart in her support of the local foods

Ledonne is a valued member of the SLV AHEC and an asset to the San Luis Valley. Let us all be grateful for her extensive and exemplary work, accomplished with understated grace

When I think about rural healthcare issues such as providing education and access to resources, I almost always think about what I learned from Charlotte's work," says her son, Danny Ledonne. We all have a lot to learn from Charlotte Ledonne.



The Governor issued the executive order verbally. The Governor encouraged the private sector of Colorado to voluntarily offer paid sick leave so that we can collectively do our part to contain the virus. The Governor was



Deadly wildfires ravaged thousands upon thousands of acres of land across California in the summer of 2018. Officials at the California Department of Forestry and Fire Protection said these combined fires comprised the largest wildlands fire in state history. Frightening images of blazes consuming landscapes dominated newscasts as thousands of people were forced to evacuate.

Wildfires torch everything in their paths, devastating communities, businesses and natural resources. Outbreaks seems to come out of nowhere, and meteorologists are not yet able to forecast when wildfires may occur.

It is important to note that wildfires are often started by humans. The National Park Service says as many as 90 percent of wildland fires in the United States are caused by negligence whether it's discarded cigarette butts or campfires left unattended. Some are intentional acts of arson. Nature also may be responsible, with lightning strikes causing torching of parched plants and trees. When combined with the perfect conditions, which can include dry weather, drought and strong winds, a mere spark can develop into a months-long blaze.

The NPS has wildland fire managers who constantly assess the threat of human-caused fires and the threat of wildland fires to humans. Assessments are made as to whether the wildfire should be left to run its course (in rural areas) or it should be contained and extinguished in a human-dominated landscape. National Geographic states that, historically, wildfires are actually supposed to natural landscapes, clearing underbrush in forests and triggering the release of seeds in some plant species, such as the Jack

fire retardants dropped by aircraft.

SAN LUIS VALLEY-This time of year, many questions seem to come up about open burning. SLV Public Health Partnership's Environmental Health staff frequently receive calls of concern on this topic. Here are some answers to common questions.

Q. The fumes from my neighbor's trash burning makes me feel sick. Is this legal?

A. No, burning household trash is prohibited in Colorado.

Q. My parents and grandparents have always burned their trash. What is wrong with doing it the way we have always done it?

A. Today's household trash is full of plastics, synthetics, products produced using chemical processes, and other materials that can cause toxic fumes when they are burned. Inhaling smoke from burning household trash can make you feel

sick in the short term. In the long term, breathing smoke or eating plants and animals that have been exposed to smokeborne toxic substances can cause serious health problems including cancer. Cancer is the second leading cause of death in the San Luis Valley.

Q. Okay, so I can't burn trash. What about weeds or yard waste?

A. Colorado allows open burning of untreated, natural wood (sticks and branches), leaves, dry prairie grass, slash, weeds. All burns must be performed in open piles. Burning in barrels or incinerators is not allowed. You need a permit for this.

Q. How do I get a per-
