ALAMOSA — A new decade brought in both hopes and difficulties 100 years ago.

The effects of WWI were still being felt, sugar was still in shortage and returning soldiers had difficulty finding employment.

Construction of buildings could be resumed and the sale of coal was no longer curtailed.

Interestingly, the newspaper 100 years ago had no sports section and only occasional mention

of sporting activities. Also, there was no fashion section or recipes. Documentation of social life apparently was important; each community, such as Waverley, Hooper or Star, had a social column about who went out of town, who had visitors from out of town or who threw a dinner party.

DWR reminds water community about new rules

ALAMOSA — The time for water users to ensure that they comply with Colorado's newly established groundwater rules is growing short.

The Colorado Division of Water Resources is seeking to remind well owners of the need to comply with the rules within two years of the initial approval.

Judge Pattie Swift signed the regulations in March of 2019. The final deadline for compliance will fall on March 15, 2021. The office of the State Engineer has made it clear that the rules will apply to all withdrawals of groundwater within Water Division No. 3 unless such withdrawals are specifically exempted.

A non- exempt well is considered to be any well that is not for domestic use. The replacement of depletions to the aquifer system will also be required.

The DWR's Division No. 3 Office is seeking to remind well owners of their options. The first option is to obtain a contract to join a Special Improvement District. The second is to develop an individual augmentation plan. The Division office also has expressed concern over the sheer volume of non-exempt wells, including those used by municipalities across the Valley. "We've got a lot of non-irrigation wells out there," said Division Engineer, Craig


She was preceded in death by her son. Jeffrey Ornelas: and grandson Elexis Ornelas; with whom she will be reunited.



sible picnic area, as well as other park amenities. All these improvements will help promote a deeper connection to the river for residents and visitors alike. Emma Reesor, Ex-

ecutive Director of the RGHRP, has been integral in the planning and fundraising for the project, and is excited to see construction in full swing. "It's been a joy to work with the community of Del Norte to make this vision a reality" Reesor said, "Improving connectivity between people and rivers will have a positive effect on the community as a whole".

Marty Asplin with the Del Norte Trails Organization has been a part of the DNRFP from the very be-

ginning and worked hard to bring partners together to benefit Del Norte. "The addition of access to the Rio Grande was part of the Del Norte Trails Master Plan which was adopted by the Town of Del Norte and Rio Grande County in 2007," said Marty Asplin, "accomplishing this is a large piece of the plan."



Cotten. While he expressed confidence that most users are working towards compliance, Cotten stressed that all non-exempt wells would fall under the same requirements. "We have tried to send letters to all well owners," he said. While the 2021 deadline

is still in the distance, Cotten also was quick to point out that those seeking to join a Sub-district should do so as soon as possible, as the deadline for contracts will fall within the next month. Cotten acknowledged the DWR does not want anyone to be shocked by the upcoming changes. However, he made it clear that once the deadline has passed, anyone with a non-exempt well who is still not in compliance will be issued an order to cease the use of that well.

Cotten concluded that the offices' goal is to protect Sr. users and have as smooth of a transition as possible.






Alamosa takes inaugural Gary Ramstetter Classic

ALAMOSA — Welcoming some heavy hitters from the 2A class Alamosa held the Alamosa Invitational on Saturday morning. Touting three first-place finishes the Mean Moose were able to take their home tournament with a team score of 200.

Before the action got underway, Alamosa High School honored wrestling legend Gary Ramstetter by dubbing the annual Alamosa tournament the 'Gary Ramstetter Classic'. Prior to

stepping down this fall, Ramstetter oversaw all of the State Championships the Mean Moose wrestling program would bring back to the San Luis Valley. Alamosa's back-to-back wins at state these past two years have the Moose tied for the most in the state with 12 team titles. With the tournament now bearing the moniker of the undisputed father of Alamosa wrestling the Moose were sure not to let anyone spoil it.

At 106 pounds and 120 pounds respectively, Kyler Liddell and Brandon Reveles took third and fourth-place finishes. From there Alamosa was never far from the top of the podium garnering second-place finishes from Trevor Maestas, Brooks Anderson, Hunter Smith and Zeke Rangel in their respective weight classes.

The maroon and black would take first in three weight classes. Davion Chavez breezed his way to the top of 113 pounds with two falls and one technical fall picking up two of his wins in the first minute. Chavez pinned Avelino Mota of Widefield, No. 10 in 4A, to claim first place.

Colton Liddell claimed the second of Alamosa's three first-place finishes at 132 pounds. Liddell got past Adams City's Jace Long for the second time in two days, having met 4A's seventhranked 132 pounder in the Alamosa Duals the night before. This time, Liddell got by Logan with a 7-5 sudden victory. Clearing the path for a 4-0 win by decision over 2A's sixth-ranked

126 pounder in the first-place match.

Alamosa's final first-place finish came courtesy of Logan Trujillo at 220 pounds. Trujillo's path to pay dirt would involve a 3A top ten meeting. Trujillo (No. 5) faced off with Bennett's Casey Harvey (No. 7). Trujillo controlled the match and took an 8-2 decision moving on to face 2A's second-ranked 220 pounder Jesse Tapia, who Trujillo pinned in 1:44 to

take first place. Alamosa's 200 team points were enough to keep Rocky Ford at bay. 2A's second-ranked team, Rocky Ford, finished in second place with 195.5.

Alamosa will continue to log plenty of mat time, Thursday the Moose will be at Monarch for a dual and will close the weekend off in Lafayette for the Top of the Rockies Tournament at Centaurus High School.

Green registers huge scoring night, but Grizzlies

come up short in Springs

ams State Grizzlies Men's Basketball team dropped their second game of a two-game road trip this weekend, falling to the UCCS Mountain Lions 85-92. The game was a closely contested matchup of two teams fighting to keep pace in the RMAC postseason race, but ultimately it was the home team that got the upper hand on the night.

Guard Juwan Green did his best to will his team to the victory, scoring 37 of the Grizzlies' 85 points in the game. The game was by far the graduate senior's biggest night of the year, and even in a loss, he continues to impress on the offensive end of the floor. On the defensive end, the crafty guard notched 2 steals in the contest and played 38 of the 40 minutes giving absolutely all he had. He has proven that he is the real deal and is perhaps the next great point guard in Coach

Caton's system. Senior Forward Rickey Norris had what is now becoming a routine teamleading rebounding night for him, as he logged 8 boards on the evening to complement his 15 points in just

20 minutes of action. Guard Szymon Walczak and Forward Kaelin Crane were also in double figures, each registering 10 points.

The Grizzly bench had a tough night, which ultimately was the difference in the game, as the UCCS bench provided them with 19 points to the Grizzlies' 10. The Grizzlies shot a respectable 47.7% from the field, but going just 4-16 from threepoint range and 19-28 from the foul line played a huge role in their loss. They now sit at 3-6 in RMAC play and still have not won on the road in the 2019-20 season.

If history tells anything, it is that Coach Russ Caton's teams typically peak later in the season, just in time for a playoff run. If the Grizzlies can find a formula to win big games at home and on the road, they can still make a playoff push, being that the RMAC season is not even halfway over. They will be back on the road next weekend as they prepare for two more conference opponents, the Colorado Mesa Mavericks on Friday and their archrivals, the Western Colorado Mountaineers on Saturday.

Adams State opened the first quarter scoring a quick jumper from Laura Gutierrez. Marshell Hollins then added a good layup to the Grizzlies total, giving the Grizzlies a one-point advantage over the Mountain Lions. UC-Colorado Springs then turned it on, going on a 16-0 run to end the quarter leading the Grizzlies 19-4.

Adams State came out in strong to begin the second quarter. The Grizzlies' Ally McKenzie opened the second quarter, going 2-2 from the line. Maddie Dorris also added to the Grizzlies score with a good layup. McKenzie concluded the quarter adding 5 more points and Gutierrez hitting a three. The Grizzlies trailed the Mountain Lions 36-16 ending the first half.

The third quarter opened with Gutierrez hitting a good jumper. The Grizzlies added 19 points to their second-half total in the third quarter. Paiton Demps and Zakiya Beckles each added four points on the board, along with Hollins hitting a big three.

Adams State finished the third quarter down 55-35.

The Grizzlies came out with fire in the fourth quarter, outscoring the Mountain Lions 19-14. Gutierrez started the Grizzlies off in the fourth quarter hitting a three. Beckles added 8 points in the quarter, along with Kassie Schell, Demps and Hollins each adding to the Grizzlies total. The second half finished up with the Mountain Lions on top, 69-54.
